EATON TOWNSHIP BOARD OF SUPERVISORS MONTHLY MEETING February 1, 2022

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 7:00 p.m. by Chairman White on Tuesday, February 1, 2022.

Present were, Chairperson Kenny White, Supervisor Abe Kukuchka, and Supervisor/Roadmaster Paul Rowker.

Minutes from the previous meeting were distributed in draft form. With no corrections needed, Supervisor Kukuchka made a motion to accept the minutes, seconded by Supervisor Rowker.

FINANCIAL REPORT:

None- due to illness, but it was noted by Supervisor Rowker that PENNDOT needed more information about the use of funds for the berm created by last summer's paving project.

ZONING OFFICER REPORT:

Supervisors noted that the report looked good, and were pleased with Officer Patton's work, as well as that of the new SEO.

VISITORS AND GUESTS:

Resident Dave Williams was present.

NEW BUSINESS:

Ordinance 2022-1, Road Dedication, was signed. Ordinance 2022-2, Floodplain Ordinance, was signed. Resolution 2022-3, TCC delegate was signed, denoting Secretary Jennifer Harvey as delegate. Resolution 2022-4, approving the fee schedule was signed. Resolution 2022-5, a signatory resolution approving Supervisor Kukuchka to sign ARLE grant documents, was signed. The ARLE grant 24-month extension papers were signed. The Resolution approving intergovernmental cooperation between Eaton and Tunkhannock Borough was signed. Documents approving Ginader and Jones' yearly audit were approved and signed. ARP funds usage was discussed, with funds being approve for lost revenue, fire hydrant on 29 corridor and speed signs. Chairman White agreed, and added Broadband internet through Thurston Hollow, as a worthy project. Supervisor Kukuchka noted that expenditures on Parks and Trails were also allowable. The DEP document stating American Asphalts application for an NPDES permit was reviewed. Proctor and Gamble had no notable holding tank releases this past year. Costars aggregate pricing was tabled by Chairman White until quotes from Hilltop Quarry are acquired. Chairman Rowker also asked if the price included trucking. The Community Planning Documents approving the Harding /Ziegler subdivision and the opening of the Ford dealership were discussed. The Supervisors approved of themselves and the roadcrew attending the Northeast Regional Workshop at Keystone College. It was decided that the park rules should be a stand-alone ordinance. April 2021's minutes were amended by Chairman White, seconded by Supervisor Kukuchka.

Meeting was adjourned at 7:49 by Chairman White, seconded by Supervisor Kukuchka.
