

**EATON TOWNSHIP  
BOARD OF SUPERVISORS  
MONTHLY MEETING  
January 3, 2023**

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 6:35 p.m. by Chairman Kenny White on Tuesday, January 3, 2023.

Present were, Chairperson Kenny White, Supervisor Abe Kukuchka, and Supervisor Robert Pitcavage.

Minutes from the previous meeting were distributed in draft form. With no corrections needed, Supervisor White made a motion to accept the minutes, seconded by Supervisor Kukuchka.

**FINANCIAL REPORT:**

The report was approved of by Supervisor. Motion by Supervisor Kukuchka to approve the 2023 Budget by Resolution. There will be no tax increase.

**ZONING OFFICER REPORT:**

Mr. Patton shared the Zoning Officers report; there was one permit for Cooks Trailer Park for a demolition. Three hours of document scanning was completed. The nuisance property has removed old tires. Supervisor Pitcavage suggested looking to the flood plain ordinance in respect to the barrels.

**VISITORS AND GUESTS:**

Lori Bennet spoke to the Superintendent and transportation director at the school. School Bus stop signs will be provided if the township will install. She also addressed the speed some bus drivers. She also suggested Keelersburg Road and corner of 292 by Jenks as possible places for signs. She then started a discussion on the current ambulance crisis.

Charley Hauser asked about the sign requested not being up; Mr. White noted that it is being made. He questioned the use of jake brakes in the Township- to which the Supervisors replied that they could have a study performed- but enforcing signs would be difficult.

**UNFINISHED BUSINESS:**

Supervisor White noted that the mud has been problematic- and that all rock has been allocated with more on order. McMullian will need further attention. Supervisor Pitcavage questioned the use of low of volume road grants through dirt and gravel. Supervisor White replied that he would speak to Dave. He also pointed out that the pipe that was purchased for Horizon Lane needs to be installed.

**NEW BUSINESS:**

The Assessor's changes were reviewed, and remarked upon as unfortunate. Lori Bennet asked the changes could be fought together instead of as individual homeowners. NTHA membership will be renewed. The Aqua Midstream document was reviewed; Supervisor Pitcavage noted that the generator runs nonstop, and that traffic should be blocked to the site, also that the design should be questioned. The Keystone Acquisition document was signed. Financial Interest Forms were distributed. Supervisor asked that the agenda be amended to include the appointment the Zoning Hearing Board Solicitor, Mr. White agreed, second by Bob Pitcavage. Mr. Kukuchka asked that Stephen Menn be appointed, Mr. White seconded the motion, Mr. Pitcavage agreed.

Checks were signed.

Meeting was adjourned at 7:25 by Supervisor White, second by Supervisor Kukuchka
