

**EATON TOWNSHIP
BOARD OF SUPERVISORS
MONTHLY MEETING
July 7, 2020**

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 7 p.m. by Chairman White on Tuesday, July 7, 2020.

Present were, Chairman Kenny White, Supervisor/Road Master Paul Rowker, Supervisor Kukuchka, and Secretary Jennifer Harvey. Also present were Bob Baker and Dakota Wilson.

Minutes from the previous meeting were distributed in draft form. With no corrections needed, Supervisor Rowker made a motion to accept the minutes, seconded by Supervisor Kukuchka. Chairman White.

The financial report was presented, and regarded as correct. Supervisor Kukuchka noted a drop in PUC Act 13 funds from the previous years.

ZONING OFFICER REPORT:

Supervisor Kukuchka noted that Mr. Woods was busy, and motioned to accept the report. Supervisor Rowker seconded. It was noted that Chad Patton was officially chosen as Zoning Officer backup for Eaton and Monroe Township, and that he should receive paid training at \$14-\$15 an hour.

Supervisor Kukuchka also noted that events granted a special event permit should adhere to CDC guidelines. Supervisor Rowker made note of insurance, and Supervisor Kukuchka and Chairman White agreed that it should be in the rider. Supervisor Kukuchka noted that Attorney Litwin would be available to help. Supervisor Rowker noted that ordinances and flood mapping also need to be looked at. Bob Baker inquired about the event that was being held, and Supervisor Kukuchka noted that it was at Whipple's Studio. It was originally to be held as a benefit which was misleading, and also that future permits should stipulate following CDC guidelines.

VISITORS AND GUESTS:

Dakota Wilson was present. He asked for permission to do historic carriage rides through Eaton over the bridge. Chairman White approved, noting cleanup. Supervisor Rowker noted that the integrity of the bridge would have to be monitored, but as the horses are unshod, it should cause no concern. Mr. Wilson will be given a key to unlock the bridge. He will also speak with Kevin Kukuchka and the Eaton United Methodist Church.

Bob Baker asked about recent Zoning Hearing Board meetings for Aldi and Mr. Weirnsz. Supervisor Rowker explained that of the three signs requested, the Board found issue with only one, and Aldi was pleased with the outcome. Supervisor Kukuchka explained that though Mr. Weirnsz was granted a permit in January there were unknown complications from the county due to commercial and residential properties having different setbacks.

NEW BUSINESS:

Supervisor Rowker noted that dust control ran over budget, but it was not overly large, and that next year we will budget more for it.

He also noted that everyone was happy with the application of the Ultrabond.

Chairman White noted the Flood Insurance Study numbers, and Supervisor Rowker said that remapping will put people in the Flood Zone. He also noted that they will moving up to Roger Lane and that he purchased a gas hammer.

It was noted that the treasurer will be on vacation, and working remotely.

A motion was made to adjourn by Chairman White and seconded by Supervisor Rowker to adjourn the meeting. The meeting was adjourned by Chairman White at 7:30 PM.
