

**EATON TOWNSHIP  
BOARD OF SUPERVISORS  
MONTHLY MEETING  
May 2, 2023**

The regular monthly meeting of the Eaton Township Board of Supervisors was called to order at 7:00 p.m. by Chairman Kenny White on Tuesday, May 2, 2023.

Present were Chairman Kenny White, Supervisor Robert Pitcavage, and Supervisor Abe Kukuchka.

Minutes from the previous meeting were distributed in draft form. With no corrections needed, Supervisor Pitcavage made a motion to accept the minutes, seconded by Supervisor Kukuchka Pitcavage.

**FINANCIAL REPORT:**

The financial report was accepted as positive.

**ZONING OFFICER REPORT:**

Mr. Patton shared the Zoning Officers report. Two building permits were issued

**VISITORS AND GUESTS:**

Cathy Biro and Jennifer Kozlansky, Gene Dzubia's daughters attended.

**UNFINISHED BUSINESS:**

Bridge Light update- the bids will soon be going out; the solar signs will be installed in the future. Installation of the solar powered signs is coming along. The DCNR Miller Mountain acquisition is moving forward slowly. It was noted that Seneca Trail Park is in the floodplain. Mr. Patton questioned the start of the Seneca Trail- the supervisors elaborated. Pipe Replacement near the blueberry farm was discussed- the busy season is June 15<sup>th</sup> to August 15<sup>th</sup>. Chairman White noted that the road would be improved, and the signage on private roads is unregulated. Phone Bids for the replacement of the Thurston Hollow pipe were reviewed- Roaring Run-\$14,000, SNS Trucking- \$16,200 and the winner of the bid Sickler Excavating-\$12,175. The pipes cost will be \$4,000. Mr. Pitcavage made a motion to accept Sickler Excavating, with Mr. Kukuchka seconding.

**NEW BUSINESS:**

The Assessor's changes were noted. Mr. White reviewed the Fee Schedule changes. Mr. Patton explained that the changes would reflect the time spent on each issue. Mr. Pitcavage made a motion to accept with a second by Chairman White. The resolution was signed. Chairman White noted that there would be a special meeting May 22<sup>nd</sup> at 6 pm to open bids; all bidders will be given a site showing May 12<sup>th</sup>-spot paving at 9, tree removal at 10, and FDR at 11. The PSATS Conference was attended by Mr. Pitcavage, Treasurer Patton Mr. Patton. Mr. Pitcavage will provide a list of training sessions for Jason. Solar panels and solar farms were discussed. Mr. Patton introduced the possibility of hiring a company to improve usability of online ordinance searches. Ms. Patton added that the company will also critique and improve the ordinance. Mr. Patton was given the figure of \$10,00 for our Ordinance. Monroe will be informed of the opportunity as well.

Checks were signed.

Meeting was adjourned at 7:37 by Kukuchka, second by Supervisor Pitcavage.
