REGISTRATION INFORMATION

1. **Registration:** All team registrations must be completed online. Online registration will close when the capacity of **20 teams** has been reached.
2. **Payment:** Entries are not valid until paid in full. The registration fee is **\$200.00 per team**. Payment must be made at the time of registration.
 - **NO PERSONAL CHECKS ACCEPTED.**
 - **One form of registration per team.**
 - **Schools can pay for multiple teams with one payment method.**
 - Payments can be made online by credit card, by school check, cashier's check, or money order.
3. **Refunds:** If the **Central Texas BBQ Round Up Committee** is notified of a team's cancellation more than 14 days before the date of the event, the team will receive a 100% refund of payment. No refunds will be processed for cancellations received less than 14 days from the event.

CONTEST INFORMATION

The **Next Gen BBQ Comp Battle of the Schools** is sanctioned by the International Barbecue Cookers Association. All International Barbecue Cookers Association rules and regulations will govern this competition.

1. **TEAMS:** Each team must consist of a minimum of two (2) and a maximum of five (5) members.
2. **Junior High Teams:** If all members are under the age of 16, the head cook must be listed as one of the BBQ Coaches for IBSCA regulations.



3. **MEAT PICKUP & COOKING:**

- All meats will be cooked on-site. (**Teams will be responsible for providing their own meat**) the meat can be pre-trimmed, and vacuum sealed. No pre-injection and seasoning is allowed. All meat is subject to inspection by the IBSCA, CTBR, and its volunteers. Meat is allowed to be prepped within the area upon arrival.
 - **NO** meat will be allowed to leave the team's site area.
4. **COOK AREA:** The cook area will be 36 by 36. The cook area will be located in the fenced open-air arena, and only team members will be allowed in the fenced area while the competition is taking place. The only people besides team members allowed in the space will be volunteers from the **Central Texas BBQ Round Up Committee**.
- No other adults will be allowed in the cook area unless there is an emergency.
5. **SANITARY CONDITIONS:** Teams are to prepare and cook in as sanitary a manner as is possible (gloves, hand washing, avoiding cross-contamination). Conditions are subject to inspection by the **Central Texas BBQ Round Up Committee**.

ELIGIBILITY RULES

1. **Eligibility:** To be eligible, contestants must be enrolled in and attending **public and private schools** in Texas at the time of the contest.
2. **Residency:** Contestants must be bona fide residents of the State of Texas.
3. **Academic Standing:** Contestants suspended under Texas Education Code 33.081, "No Pass, No Play," are ineligible to participate.
4. **Ineligibility:** Foreign exchange students and non-United States citizens are ineligible to compete in the **Next Gen BBQ Comp Battle of the Schools**.

BBQ PIT AND SPACE RULES

1. **Pits:** Any commercial or homemade, trailered, or un-trailered pit or smoker normally used for competitive barbeque may be used.
2. **Fuel:** A BBQ pit may include gas or electricity for **starting** the combustion of wood or wood products but **NOT** to complete cooking.
3. **Restrictions:**
 - The use of heat lamps, proofing cabinets, or any other electrical heating/holding device is prohibited.
 - Sous vide, boiling, or frying of competition meat is not allowed.
4. **Camping:** No camping overnight Friday night.

INSTRUCTIONS FOR MEAT TURN-IN

Turn-In Window: A turn-in window of ten (10) minutes before and after the set turn-in time will be recognized.

1. **Prohibited Items:** Garnishes and condiments are prohibited.
2. **Sauce Rule:** Meats may be cooked with sauces/liquids, but **no** sauces/liquids may be added once the meat is put into the tray. No "puddling" of juices allowed.
3. **Tray Requirements:**
 - **Chicken (12:00 AM):** One (1) separate 1/2 fully jointed chicken (breast, wing, thigh, drumstick) **WITH SKIN ON**. No Cornish game hens.
 - **Pork Spareribs (1:30 PM):** Eight (8) individual cut ribs (bone-in). St. Louis cut



acceptable. NO baby backs or country-style ribs.

- **Brisket (3:00 PM):** Eight (8) full slices, recommended 1/4" to 3/8" thick. Blocking allowed; fat cap may be trimmed.

JUDGING FORMAT

1. **Format:** Double-Blind Judging. Entries submitted in containers provided by the **Central Texas BBQ Round Up Committee**.
2. **Tie Breaker:** Brisket will be the tie breaker. The team that finishes higher in the brisket category places higher overall.

In consideration for being permitted to participate in the **Next Gen BBQ Comp Battle of the Schools** (hereinafter the "Event"), hosted by the **Central Texas BBQ Round up** (hereinafter "CTBR"), I, the undersigned Participant (and Parent/Guardian if Participant is under 18), hereby agree to the following terms:

1. ASSUMPTION OF RISK I acknowledge and understand that participation in the Event involves inherent risks, hazards, and dangers that cannot be eliminated regardless of the care taken to avoid injuries. These risks include, but are not limited to:

- Burns, cuts, and other injuries associated with the operation of BBQ pits, open flames, hot coals, gas/electric heating elements, and sharp cooking utensils.
- Foodborne illness or allergic reactions resulting from the handling, preparation, or consumption of food products.
- Risks associated with the presence of other participants, volunteers, and the public.
- **Infectious Diseases (COVID-19):** I acknowledge that participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist.

I hereby knowingly and freely assume all such risks related to injury, illness, infectious diseases (such as COVID-19), harm, and loss associated with the Activity, even if arising from the negligence, fault, or conduct of any kind on the part of the Released Parties.

2. RELEASE AND WAIVER OF LIABILITY I, for myself and on behalf of my heirs, assigns, personal representatives, and next of kin, HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE the **Central Texas BBQ Round up (CTBR)**, its committee members, officers, officials, agents, volunteers, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used to conduct the event (collectively, the "Released Parties"), from any and all liability, claims, demands, losses, or damages caused or alleged to be caused in whole or in part by the negligence of the Released Parties or otherwise, including negligent rescue operations.
