- Run Rules
 - o 12 runs for V and JV, 15 for JH after 5 innings
 - o Game **CANNOT** end at the top of the inning
 - Losing team must bat at least 5 times
 - JV and JH games
 - Maximum of 5 runs per half inning
 - Except for last inning
 - Unlimited scoring
- Dugout conduct
 - Players should stay in their dugout
 - o No warmup devices allowed to be used once the game starts
 - o Don't allow on-deck player to meet with coach
 - o Electronic communication devices are illegal
 - First time is a warning
 - Second time is an ejection
- Ball fair/foul
 - o Location of the ball, NOT the player determines fair/foul
- Playoff information is posted on our website
- Tie breaker
 - Starts in the 10th inning
 - o Player starting on 2nd base is the person scheduled to bat last in that inning
- Circle rule
 - Batter-runner has to have reached 1st base
 - o Pitcher has ball in either her glove or her hand
 - Ball in glove placed under her elbow or on the ground does not count
 - Both feet totally or partially within the circle
 - No play on the runner
