## HERE IS YOUR CHANCE TO HELP TTR GROW

In the fall of 2024, the TOMBSTONE TERRITORY RENDEZVOUS was incorporated as a not-for-profit domestic corporation under the laws of the State of Arizona. TTR has been granted recognition, under the United States tax code, as a 501(c) (3) educational organization.

### **The corporation mission:** The TOMBSTONE TERRITORY RENDEZVOUS

corporation was created to increase and disseminate knowledge of the historic people who lived in and around the Village of Tombstone, Cochise County, Arizona and made early Southwest Borderlands history. This will be accomplished through the encouragement of new historical research, symposiums, seminars, field trips, publications, and educational outreach. As a not-for profit corporation it will also work to encourage the preservation of historic objects and property of the region by working in collaboration with other like-minded organizations.

**Duties of the Board of Governors:** The TTR's corporation charter and by-laws established a Board of Governors to manage the corporation's mission. This volunteer Board of Governors is composed of nine voting members. Members of the Board of Governors serve a three-year staggered term. Election of Board members is being held at the open business meeting during the annual TTR Symposium held in Tombstone in October. Members of the Board of Governors receive no compensation from the corporation for their Board service. Expenses of Board service may be tax deductible.

The TTR Board of Governors meets monthly, via electronic audio-visual communications, and in face-to-face meetings at the annual symposium. Additional Board meetings may be held at the call of the chair or via a request of a majority of the Board members. Board members are expected to participate in a majority of the regular Board meetings.

Board members may additionally serve on event committees. These committee meetings are held in-person or via electronic audio-visual communications or email conversations.

The Board of Governors approves all event budgets and has oversight responsibility for the proper fiscal management of the corporation via the actions of the corporation treasurer. The corporation finances are reviewed monthly by the Board and audited annually. Board members are expected to be active in promoting program events and supporting fundraising activities.

**Board of Governors vacant seats in 2026:** The TTR Board of Governors will have two vacant seats for the term of service starting with the end of the 2025 Symposium in Tombstone. One seat is a full three-year term, while the second seat is for a one-year term.
