5. Terms & Conditions

A. Health Requirements

- Pets must be current on Rabies, Distemper/Parvo, and Bordetella.
- Pets must be free of contagious illness, fleas, and parasites.
- If fleas/parasites are found, treatment will be administered at the owner's expense.
- Owner agrees to disclose all medical and behavioral conditions.

B. Behavior & Safety

- Flying Fur Pets may refuse service for aggression, stress, or safety concerns.
- Pets may be separated or kenneled for safety or rest.
- Dogs play physically; minor injuries may occur.

C. Group Play Participation

If the owner selects group play:

- Dogs may wrestle, chase, nip, and interact physically.
- Staff supervise but cannot prevent all incidents.
- Owner accepts all risks associated with group play.

D. Boarding Policies

- Pets may be kenneled or crated for rest, feeding, or overnight.
- Accurate feeding and medication instructions must be provided.
- Late pickups may incur fees.
- Pets not picked up within 7 days of scheduled pickup may be considered abandoned under Ohio law.

E. Personal Items

- Owners may bring personal items, but Flying Fur Pets is not responsible for loss or damage.

F. Payment Terms

- All fees are due at pickup.
- Owner agrees to pay for damages caused by their pet.
- Additional fees may apply for late pickup, holidays, medication administration, or special handling.

G. Emergency Veterinary Care

- Staff will attempt to contact the owner in an emergency.
- If unreachable, Flying Fur Pets may seek veterinary care at their discretion.
- Owner is responsible for all veterinary costs.

6. Liability Release & Assumption of Risk

A. General Liability Waiver

I understand and agree that Flying Fur Pets, its owners, employees, and agents are **not liable** for:

- Illness, injury, or death of my pet
- Injuries caused by my pet to other animals or people
- Loss, theft, or escape of my pet
- Damage to personal items
- Stress-related conditions (vomiting, diarrhea, anxiety, etc.)
- Injuries resulting from normal dog behavior (scratches, nicks, play bites, sprains, etc.)

I voluntarily assume all risks associated with daycare, boarding, grooming, and group play.

B. Infectious Disease Acknowledgment

I understand that even with proper vaccination, my pet may still contract illnesses such as:

- Kennel cough
- Canine influenza
- Upper respiratory infections
- Parasites or other communicable conditions

Flying Fur Pets is not responsible for these illnesses.

C. Medical Treatment Authorization

I authorize Flying Fur Pets to:

- Transport my pet to a veterinarian
- Approve treatment recommended by a licensed veterinarian
- Administer basic first aid

I agree to pay all associated costs.

D. Behavioral Disclosure

I certify that I have disclosed any history of:

- Biting
- Aggression
- Reactivity
- Anxiety
- Resource guarding

I understand that nondisclosure may result in dismissal and financial responsibility for damages.

E. Hold Harmless Agreement
