MAJOR TERRY RANDALL "TURTLE" ARNOLD

Cook County Sheriff's Office, Georgia End of Watch Monday, October 3, 2022

Major Terry Arnold suffered a fatal heart attack after responding to a fight between two students at Cook County High School in Adel.

While taking one of the juveniles into custody, Major Arnold collapsed. Medical personnel rendered aid, and he was transported to South Georgia Medical Center, where he was unable to be revived.

Major Arnold had served with the Cook County Sheriff's Office for 28 years and previously served with the Remerton Police Department for two years and the Adel Police Department for five years. He is survived by four daughters, a son, ten grandchildren, four siblings, a longtime companion, and her son and daughter. Major Arnold was posthumously promoted to Major.



DEPUTY SHERIFF BLANE LANE

Polk County Sheriff's Office, Florida End of Watch Tuesday, October 4, 2022

Deputy Sheriff Blane Lane was shot and killed while serving a felony arrest warrant in Polk City at about 3:00 am.

He and three other deputies were invited into the subject's trailer to serve the failure to appear warrant for a previous narcotics charge. While Deputy Lane and three other deputies checked the mobile home the wanted subject walked into the room and pointed a gun at them. The deputies immediately fired at the subject but one of their rounds went through a wall and struck Deputy Lane in the shoulder.

He was transported to Lakeland Regional Health Medical Center where he succumbed to his wound. The subject, a convicted felon, was shot twice and is expected to survive. She has been charged with second-degree murder.

Deputy Sheriff Lane had served with the Polk County Sheriff's Office for one year. He is survived by his 3-year-old child.

DEPUTY SHERIFF SIDNEE CARTER

Sedgwick County Sheriff's Office, Kansas End of Watch Friday, October 7, 2022

Deputy Sheriff Sidnee Carter was killed in an automobile crash while responding to a disturbance call at about 9:30 pm.

Another vehicle ran a stop sign and struck her patrol car at the intersection of 135th Street West and 29th Street North near Maize.

Deputy Carter had served with the Sedgwick County Sheriff's Office for two years. She had initially served as a jail deputy for 18 months

and had finished field training as a patrol deputy one week before the crash. She is survived by her parents and siblings.

INVESTIGATOR MYIESHA BREANNA STEWART

Greenville Police Department, Mississippi End of Watch Tuesday, October 11, 2022

Investigator Myiesha Stewart was shot and killed near the intersection of Reed Road and Rebecca Street during a vehicle pursuit at about 7:30 pm.


Greenville officers and deputies with the Washington County Sheriff's Office were pursuing a subject who had fled after shooting his girlfriend.

The subject was taken into custody following the pursuit.

Investigator Stewart is survived by her three-year-old son and parents







LIEUTENANT DUSTIN DEMONTE

Bristol Police Department, Connecticut End of Watch Wednesday, October 12, 2022

Lieutenant Dustin Demonte and Sergeant Alex Hamzy were shot and killed in an ambush in front of a home on Redstone Hill Road, near Birch Street, at about 11:00 pm.

Officers had responded to a business earlier in the evening in response to complaints about a disorderly patron. Officers who responded to the call issued the man an infraction and released him. The man then went home, armed himself with an AR-15 rifle, and made a fake 911 call

reporting a disturbance at his home. As officers arrived at the scene, the man opened fire on them from the front yard.

Lieutenant Demonte and Sergeant Hamzy were both fatally wounded, while a third officer suffered non-life-threatening wounds. The subject was shot and killed by the third officer. Lieutenant Demonte had served with the Bristol Police Department for 10 years. He is survived by his

expectant wife and two children. Lieutenant Demonte was posthumously promoted to Lieutenant.

SERGEANT ALEX HAMZY

Bristol Police Department, Connecticut End of Watch Wednesday, October 12, 2022

Sergeant Alex Hamzy and Lieutenant Dustin Demonte were shot and killed in an ambush in front of a home on Redstone Hill Road, near Birch Street, at about 11:00 pm.

Officers had responded to a business earlier in the evening in response to complaints about a disorderly patron. Officers who responded to the call issued the man an infraction and released him. The man then went

home, armed himself with an AR-15 rifle, and made a fake 911 call reporting a disturbance at his home. As officers arrived at the scene, the man opened fire on them from the front yard.

Sergeant Hamzy and Lieutenant Demonte were both fatally wounded, while a third officer suffered non-life-threatening wounds. The subject was shot and killed by the third officer.

Sergeant Hamzy had served with the Bristol Police Department for eight years. He is survived by his wife, parents, and two sisters. Sergeant Hamzy was posthumously promoted to Sergeant.





POLICE OFFICER TRUONG THAI

Las Vegas Metropolitan Police Department, Nevada End of Watch Thursday, October 13, 2022

Police Officer Truong Thai was shot and killed while responding to a domestic disturbance call in the 800 block of East Flamingo Road at about 1:00 am.

The subject opened fire from inside his vehicle as Officer Thai and his partner attempted to make contact with him at the intersection of East Flamingo Road and South University Center Drive. Officer Thai and a civilian were both struck by the subject's shots. Officer

Thai succumbed to his wounds while being transported to a local hospital.

The man fled the scene but was apprehended by a police canine approximately three miles away after refusing to exit his vehicle.

Officer Thai had served with the Las Vegas Metropolitan Police Department for 23 years and was assigned to the South Central Area Command. He is survived by his daughter.


POLICE OFFICER STEVEN R. NOTHEM, II

Carrollton Police Department, Texas End of Watch Tuesday, October 18, 2022

Police Officer Steve Nothem was killed when his patrol car was struck by a vehicle while he was assisting another officer conducting a DUI investigation in the westbound lanes of President George Bush Turnpike, near Josey Lane, at about 10:25 pm.

The driver of the vehicle that struck him was killed instantly in the crash. Officer Nothem was transported to the Texas Health Presbyterian Hospital Plano where he succumbed to his injuries.

Officer Nothem was a United States Marine Corps veteran. He had served with the Carrollton Police Department for two years and previously served with Grand Chute Police Department in Wisconsin for four years. He is survived by his wife and four children.



OFFICER JORGE ARIAS

United States Department of Homeland Security -Customs and Border Protection - Office of Field Operations, U.S. Government End of Watch Wednesday, October 19, 2022

Officer Jorge Arias was inadvertently shot and killed while training at the Trail Glades Range at 17601 SW 8th Street just after 10 am.

Officer Arias was a United States Coast Guard Reserve veteran and served with the United States Department of Homeland Security

- Customs and Border Protection - Office of Field Operations. He was a Firearms Training Instructor and was assigned to the Miami International Airport. He is survived by his wife and two children.

POLICE OFFICER LOGAN K. MEDLOCK

London Police Department, Kentucky End of Watch Sunday, October 30, 2022

Police Officer Logan Medlock was killed when his patrol car was struck by a drunk driver at the intersection of KY 229 and South Main Street at 12:50 am.

Officer Medlock was driving in southbound on South Main Street when the pickup truck ran a stop light and struck the patrol car,

pushing it into the adjacent cemetery. Officer Medlock succumbed to his injuries at the scene.

The driver was arrested and charged with the murder of a police officer and driving under the influence.

Officer Medlock had served with the London Police Department for three years and had previously served with the Laurel County Correctional Center for one year. He is survived by his wife and son.







LIEUTENANT KRISTINA ZELL

Niagara Falls Police Department, New York End of Watch Monday, November 7, 2022

Lieutenant Kristina Zell died from complications as a result of contracting COVID-19 in the line of duty.

Lieutenant Zell had served with the Niagara Falls Police Department for over 22 years and was assigned to the Criminal Investigation Division. She had previously served with the U.S. Marshals Violent Fugitive Task Force. She is survived by her parents and two brothers.

Lieutenant Zell was posthumously promoted to Lieutenant.



CRIMINAL INVESTIGATOR STEVEN A. CARNES

Tom Green County District Attorney's Office, Texas End of Watch Sunday, November 13, 2022

Criminal Investigator Steven Carnes suffered a fatal heart attack while attempting to arrest a subject at 4611 S. Jackson in San Angelo at 1 am.

The subject was non-compliant, and a struggle ensued. Despite lifesaving measures, Investigator Carnes was unable to be revived.

Investigator Carnes had served with the Tom Green County District Attorney's Office for two years and previously served with the Texas Alcoholic Beverage Commission for 18 years and the Bastrop Police Department for eight years. He is survived by his wife, son, and sister.



POLICE OFFICER BRANDON TSAI

Grand Prairie Police Department, Texas End of Watch Monday, November 14, 2022

Police Officer Brandon Tsai was killed in a vehicle crash while pursuing a vehicle with a fraudulent temporary tag at about 10:45 pm.

The vehicle fled when Officer Tsai attempted to stop it at the intersection of SW 3rd Street and Pioneer Parkway. Officer Tsai and another officer pursued the vehicle for approximately five miles until it slowed suddenly to turn. Officer Tsai's patrol car made contact with the patrol car in front of him as they both attempted to slow down as well.

The impact caused Officer Tsai's patrol car to turn on its side and strike a utility pole.

Officer Tsai was transported to Methodist Dallas Medical Center where he succumbed to his injuries. The vehicle he was pursuing continued to flee but the driver was arrested two days later.

Officer Tsai had served with the Grand Prairie Police Department for 11 months and had previously served with the Los Angeles Police Department, California, for five years.



MARINE INTERDICTION AGENT MICHEL O. MACEDA

United States Department of Homeland Security - Customs and Border Protection - Air and Marine Operations, U.S. Government End of Watch Thursday, November 17, 2022

Marine Interdiction Agent Michel Maceda was shot and killed during a maritime narcotics interdiction operation approximately 12 miles southwest of Cabo Rojo, Puerto Rico. He and two other Marine Interdiction Agents intercepted a vessel they believed to be transporting narcotics. One of the occupants of the vessel opened fire on the agents

as they began to board it. All three agents and both subjects were shot during the ensuing shootout.

The United States Coast Guard flew all three agents to a hospital in Puerto Rico where Agent Maceda later succumbed to his wounds. One of the two smugglers on the boat was also killed. Over 1,300 kilograms of cocaine were recovered from the boat the agents were attempting to board and a second boat that was interdicted nearby.

Agent Maceda had served with the United States Customs and Border Protection - Air and Marine Operations for seven years.

POLICE OFFICER JORDAN JACKSON

Bellevue Police Department, Washington End of Watch Monday, November 21, 2022

Police Officer Jordan Jackson was killed in a motorcycle crash in the 500 block of Bellevue Way SE.

He was traveling northbound when a vehicle pulled out of a parking lot and into his path, causing a collision. He was transported to Harborview Medical Center where he succumbed to his injuries several hours later.

Officer Jackson had served with the Bellevue Police Department for 4-1/2 years and was assigned to the Motor Unit. He had previously served as an EMT and as a volunteer with the King County Sheriff's Office Search and Rescue Unit. He is survived by his wife and children.

DEPUTY SHERIFF CHRISTOPHER TAYLOR

Charlotte County Sheriff's Office, Florida End of Watch Tuesday, November 22, 2022

Deputy Sheriff Christopher Taylor was struck and killed by a drunk driver while conducting a traffic stop on I-75, south of US-17, at about 8:45 pm.

He was standing on the shoulder of the highway with the person he had stopped when the driver of an approaching vehicle lost control of

her car and struck Deputy Taylor's patrol car. The patrol car was pushed into Deputy Taylor and the person he had stopped.

Deputy Taylor was transported to ShorePoint Health where he succumbed to his injuries. The other person who was struck suffered minor injuries.

The woman who struck Deputy Taylor had just completed probation for a prior DUI charge. She was arrested and charged with DUI manslaughter.

Deputy Taylor had served with the Charlotte County Sheriff's Office for 15 months. He is survived by his parents and fiancée.





DETECTIVE SERGEANT FRANK GUALDINO

Yonkers Police Department, New York End of Watch Thursday, December 1, 2022

Detective Sergeant Frank Gualdino was killed in a vehicle crash on Tuckahoe Road at 3:30 pm.

He was driving westbound when an oncoming vehicle lost control and collided with his unmarked vehicle and a transit bus.



Detective Gualdino was transported to a local hospital where he succumbed to his injuries. The bus driver and passengers were treated for minor injuries. The 16-year-old unlicensed driver who caused the crash was transported to a hospital in critical condition.


Detective Gualdino had served with the Yonkers Police Department for 24 years and was due to retire in August 2023. He is survived by his wife, daughter, and son.

Detective Sergeant Gualdino was posthumously promoted.

DEPUTY SHERIFF JOSÉ ANGEL DELEON

Warren County Sheriff's Office, North Carolina End of Watch Sunday, December 4, 2022

Deputy Sheriff José DeLeon was killed in a vehicle crash on U.S. Highway 401, approximately one mile south of Warrenton, while responding to a domestic violence call involving a firearm at about 6:00 pm.



His patrol car left the roadway, struck a tree, and caught fire. Other deputies responding to the same call came across the crash and attempted to pull him from the wreckage. He succumbed to his injuries at the scene.

Deputy DeLeon had served with the Warren County Sheriff's Office for two years. He is survived by his son, parents, sister, two brothers, niece, grandmother, and girlfriend.



BORDER PATROL AGENT RAUL HUMBERTO GONZALEZ, JR.

United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol, U.S. Government

End of Watch Wednesday, December 7, 2022

Border Patrol Agent Raul Gonzalez passed away from injuries sustained in an ATV accident while pursuing subjects illegally crossing the border near Mission at 1:00 am.

Agent Gonzalez was traveling at high speed when he crashed. He was transported to a local hospital where he succumbed to his injuries.

Agent Gonzalez had served with the United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol for over ten years and was assigned to the Rio Grande Valley Sector McAllen Station. He is survived by his son, daughter, father, brother, grandmother, girlfriend, aunts, and uncles.



Maury County Sheriff's Office, Tennessee End of Watch Monday, December 12, 2022

Reserve Deputy Brad Miller was killed in a vehicle crash on Highway 43 near Williamsport Pike while working a traffic detail at a construction zone.

Another vehicle struck Deputy Miller's patrol car from behind, pushing it from the roadway.

Deputy Miller had served with the Maury County Sheriff's Office for

19 years. He is survived by his wife, two children, four grandchildren, and one great-grandchild.

COURT SERVICES OFFICER CURTIS MATTHEW WORLAND

Alaska State Troopers, Alaska End of Watch Tuesday, December 13, 2022

Court Services Officer Curtis Worland died from injuries he received when a musk ox attacked him near Nome.

Officer Worland was using his snowmobile to scare the musk oxen away from his dog mushing team while on a paid work break. A musk ox charged him, and the horn punctured his leg, striking his femoral

artery. Officer Worland drove away from the musk ox but was found unresponsive near his snowmobile at 1:30 pm.

Officer Worland had served with the Alaska State Troopers for 13 years. He is survived by his wife, parents, and siblings.

SENIOR CORRECTIONS OFFICER SCOTT OZBURN RINER

Gwinnett County Department of Corrections, Georgia End of Watch Tuesday, December 13, 2022

Senior Corrections Officer Scott Riner was shot and killed in the parking lot of the Gwinnett County Correctional Center as he arrived to work at 6:30 am.

He encountered a subject in the facility's parking lot who attacked him. During the ensuing struggle, Officer Riner was fatally shot. He was located by other officers at the facility.

The subject fled the scene but was arrested three days later and charged with felony murder and aggravated assault. The investigation revealed that the subject had been in the area for an extended period of time before attacking Officer Riner.

Officer Riner had served with the Gwinnett County Department of Corrections for 12 years. He is survived by his wife, son, daughter, grandchildren, and two siblings.

POLICE OFFICER BRANDEN PAUL ESTORFFE

Bay St. Louis Police Department, Mississippi End of Watch Wednesday, December 14, 2022

Police Officer Branden Estorffe and Sergeant Steven Robin were shot and killed at about 4:30 am while conducting a welfare check on a woman and child sitting in a vehicle parked at the Motel 6 at 1003 U.S. 90.

They had been speaking to the woman for approximately 30 minutes

before making a request for child protective services. Moments later, the woman opened fire, fatally wounding Officer Estorffe and Sergeant Robin. Despite being wounded, Officer Estorffe was able to return fire and killed the subject.

Officer Estorffe had served with the Bay St. Louis Police Department for two years. He is survived by his mother, father, four sisters, brother, and grandparents. His father is also a law enforcement officer.

SERGEANT STEVEN ROBIN

Bay St. Louis Police Department, Mississippi End of Watch Wednesday, December 14, 2022

Sergeant Steven Robin and Police Officer Branden Estorffe were shot and killed at about 4:30 am while conducting a welfare check on a woman and child sitting in a vehicle parked at the Motel 6 at 1003 U.S. 90.

They had been speaking to the woman for approximately 30 minutes before making a request for child protective services. Moments later, the woman opened fire, fatally wounding Officer Estorffe and Sergeant Robin. Despite being wounded, Officer Estorffe was able to return fire and killed the





SERGEANT DONALD SCOBY

Stuttgart Police Department, Arkansas End of Watch Thursday, December 15, 2022

Sergeant Donald Scoby was shot and killed while pursuing a subject who fled from a traffic stop.

Sergeant Scoby attempted to stop the subject's vehicle at about 11:00 pm, but the man fled, and a vehicle pursuit ensued. The man abandoned his vehicle in the area of Reiger Road and S Yoder Road and fled on foot, with Sergeant Scoby chasing him. He shot Sergeant Scoby during the foot pursuit.

The subject barricaded himself in a home. He was killed during an exchange of gunfire with responding SWAT officers. Another officer was wounded during the shootout.

Sergeant Scoby had served with the Stuttgart Police Department for four years.

DEPUTY SHERIFF DANIEL J. KIN

Wyandot County Sheriff's Office, Ohio End of Watch Thursday, December 15, 2022

Deputy Sheriff Daniel Kin was killed in a vehicle crash at the intersection of State Route 56 and State Route 104 in Pickaway County at about 11:00 am.

He was transporting a prisoner when a pickup truck struck the transport van on the driver's door. Deputy Kin was flown to Grant Medical Center in Columbus, where he succumbed to his injuries. The prisoner suffered non-life-threatening injuries.

Deputy Kin had served with the Wyandot County Sheriff's Office for one year and had previously served with the Seneca County Sheriff's Office for three years. He is survived by his wife, two young children, his father, and six sisters.

Chief of Police Joe Carey was struck and killed by a vehicle in the 200 block of Route 58 in Brodnax.



Deputy Sheriff Oscar Bolanos-Anavisca was struck and killed by a vehicle while investigating a robbery at 2:45 am at 2990 Gillespie Street in Fayetteville.





DETECTIVE PAUL DANIEL NEWELL

Benton County Sheriff's Office, Arkansas End of Watch Saturday, December 17, 2022

Detective Paul Newell was killed in a motorcycle crash at 6:30 am at the intersection of Southeast Walton Boulevard and Southeast Metro Parkway while escorting vehicles delivering wreaths to veteran gravesites as part of Wreaths Across America.

His police motorcycle struck a curb, lost control, and then collided with a tractor trailer that was being escorted. He succumbed to his injuries at the scene.

Detective Newell was a United States Army veteran and had served with the Benton County Sheriff's Office for 24 years. He is survived by his wife, two daughters, mother, father, two brothers, and a sister.

DEPUTY SHERIFF COREY D. MCELROY


Garrett County Sheriff's Office, Maryland End of Watch Wednesday, December 21, 2022

Deputy Sheriff Corey McElroy was killed in a vehicle crash at the interchange of I-68 and Route 36 in Frostburg, Maryland, at about 7:25 pm on December 20th, 2022.

His department SUV struck the back of a tractor-trailer before being struck by another vehicle. He was flown to Ruby Memorial Hospital in

Morgantown, West Virginia, where he succumbed to his injuries early the following morning.

Deputy McElroy was a U.S. Marine Corps veteran. He is survived by two young children.







CORPORAL RAY CHARLES HAMILTON

Okaloosa County Sheriff's Office, Florida End of Watch Saturday, December 24, 2022

Corporal Ray Hamilton was shot and killed during a barricade at the 710 block of North Park Boulevard in Wright.

Deputies had responded to the apartment at about 9:00 am to investigate a domestic assault that had occurred the previous night. The suspect refused to exit the home, and the Okaloosa County Sheriff's Office Special Response Team responded to the scene. The man fired out of a window at about 12:40 pm, striking Corporal Hamilton.

Corporal Hamilton was transported to Fort Walton Beach - Destin Hospital, where he succumbed to his wounds several hours later. The subject was charged with premeditated first-degree murder.

Corporal Hamilton had served with the Okaloosa County Sheriff's Office for five years. He is survived by his wife, brother, and two sisters.

DEPUTY SHERIFF ISAIAH CORDERO

Riverside County Sheriff's Department, California End of Watch Thursday, December 29, 2022

Deputy Sheriff Isaiah Cordero was shot and killed while making a traffic stop in the 3900 block of Golden West Avenue in the Jurupa Valley area.

Deputy Cordero was approaching the vehicle he had stopped when the driver pulled out a gun and opened fire on him, fatally wounding him. A citizen who witnessed the shooting called 911 and rendered aide until other deputies arrived.



The subject fled the scene and then led officers on a vehicle pursuit that spanned multiple counties. The subject's vehicle became disabled, and he was then shot and killed after he opened fire on officers. The man had an extensive criminal history and had stabbed a California Highway Patrol canine in 2021. At the time of Deputy Cordero's murder, the man was out on bail even after having been arrested for failing to appear while awaiting a mandatory 25-years to life sentence for the incident in which he stabbed the canine.

After shooting both officers the man carjacked a vehicle and fled into the city of Pittsburgh. He fled into a wooded area following a vehicle pursuit and then opened fire on officers. He was shot and killed by return fire.

Chief McIntire served with the Brackenridge Borough Police Department for 22 years. He had been sworn in as police chief of the Brackenridge Borough Police Department exactly four years earlier.

POLICE OFFICER CARL DOUGLAS KIMBALL

St. Francisville Police Department, Louisiana End of Watch Thursday, January 12, 2023

Police Officer Carl Kimball died from complications as the result of contracting COVID-19 while assigned to the West Feliciana Parish Hospital at 5266 Commerce Street in Saint Francisville.

Officer Kimball had served with the St. Francisville Police Department for ten years and retired from the Louisiana Department of

Supervisory Officer Jackie Montanaro died from injuries she sustained while trying to rescue her daughter from a fire in Hazlet, New Jersey.

When a fire broke out around midnight, Officer Montanaro evacuated from her burning home with her husband and eight-year-old daughter.

She re-entered the home in an attempt to rescue their six-year-old daughter who was still inside. Officer Montanaro was found unconscious, trapped inside with trauma to her arms and hands. She was transported to Cooperman Barnabas Medical Center where she succumbed to her injuries at 1:40 am. Her six-year-old daughter did not survive the fire.

He is survived by his fiancée and infant daughter.

Police Officer Peter Jerving was shot and killed while attempting to arrest a robbery suspect at 1:16 am near the 2700 block of South 14th Street.

Officers were looking for a suspect who had just committed a robbery at a nearby apartment building. The suspect fled on foot as officers approached him. One officer caught the subject and a struggle ensued. The subject fired his handgun and it struck Officer Jerving who was running to the scene to assist. Correctional Officer Jay Miller died from complications as the result of contracting COVID-19 while assigned to the Washington Corrections Center for Women at 9601 Bujacich Road in Gig Harbor.

Police Officer Chris Fitzgerald was shot and killed while struggling with a suspect near 1700 W Montgomery Street in Philadelphia at about 7:30 pm.



Officer Fitzgerald was patrolling the area when he saw three masked individuals in dark clothing standing in an area where several

robberies had recently occurred. As he exited his patrol car to speak to them all three fled on foot. He pursued one of the subjects and began to struggle with him in the 1700 block of W Montgomery Street. The man produced a handgun and shot Officer Fitzgerald multiple times.

The subject then attempted to steal Officer Fitzgerald's duty weapon, belongings, and patrol car before carjacking a citizen several blocks away. Officer Fitzgerald was transported to Temple University Hospital where he succumbed to his wounds.

The man who shot him was arrested at his home in Bucks County early the next morning. He was charged with the murder of a law enforcement officer, robbery, carjacking, and several other offenses.

He was posthumously promoted to the rank of Sergeant. He is survived by his wife and four children. His father served with the Philadelphia Police Department and currently serves as the police chief of the Regional Transportation District Police Department in Denver, Colorado.

Detention Officer Kenneth Fowler succumbed to injuries sustained on January 31st, 2023, when he slipped on ice in the parking lot of the Pontotoc County Justice Center.

The area was experiencing an ice storm when he fell. He was transported to a hospital in Oklahoma City suffering from head injuries and hypothermia. He remained in a medically induced coma until succumbing to his injuries on February 19th, 2023.



Sergeant Mason had served with the Hermann Police Department for over 12 years and was the part-time Chief of Police of the Rosebud Police Department and Reserve Deputy Sheriff of the Gasconade County Sheriff's Office. He is survived by his wife, two sons, mother, and father.

DEPUTY SHERIFF JEREMY MCCAIN

Oklahoma County Sheriff's Office, Oklahoma End of Watch Monday, March 20, 2023

PATROLMAN JOSEPH BARLOW





DEPUTY SHERIFF JOSH OWEN

Pope County Sheriff's Office, Minnesota End of Watch Saturday, April 15, 2023

Deputy Sheriff Josh Owen was shot and killed while he and another deputy attempted to arrest a man for domestic violence in the 400 block of Stromen Street in Cyrus at about 7:30 pm.

Deputies, as well as police officers from the Glenwood Police Department and Starbuck Police Department, had been dispatched to the house for reports of a domestic violence incident. The officers

were attempting to place the man into custody when he opened fire on them. Deputy Owen and the subject were both fatally wounded. The other deputy and the Starbuck officer were injured.

The incident occurred on Deputy Owen's 44th birthday.

Deputy Owen was a Minnesota National Guard Operation Iraqi Freedom veteran and had served with the Pope County Sheriff's Office for almost 12 years. He is survived by his wife, son, and parents. His father is a retired law enforcement officer.

RESERVE CORPORAL JOSEPH JOHNSON

Nyssa Police Department, Oregon End of Watch Saturday, April 15, 2023

Reserve Corporal Joseph Johnson was shot and killed near the intersection of North Third Street and Locust Avenue while making a traffic stop at about 8:20 pm.

He was responding to reports of a violent man damaging property at a home and threatening its occupants. During the response, he

encountered the suspect driving away and conducted a traffic stop. The subject immediately exited his car and opened fire, fatally wounding Reserve Corporal Johnson before he had a chance to return fire. The subject abandoned his vehicle, fled the scene, and was arrested two days later.

Reserve Corporal Johnson had served with the Nyssa Police Department for almost five years. He had also served as a corrections officer with the Oregon Department of Corrections for 15 years and currently worked as a civilian employee for the agency. He is survived by his wife and two children.


SENIOR INVESTIGATOR NICHOLAS GEORGEADIS

Investigator Georgeadis was a United States Army National Guard

veteran and had served with the New York State Police for 21 years, assigned to the Special Investigations Unit and New York State Homeland Security. He is survived by his wife, two sons, daughter, father, sister, nieces, and nephews.





INNOVATIVE TECHNOLOGY IN DOCUMENTING USE OF FORCE

ne of the most important issues facing law enforcement officers today is the possibility of criminal charges or civil litigation from a use of force incident while on or off duty. Over the past three to four years, public perception has drastically changed regarding law enforcement. States, counties, and cities have attempted to either defunded the police or remove qualified immunity thus further making this career more challenging.

As both an active and retired law enforcement officer, I have attended many trainings over the past 40 years on use of force, the laws associated with using force and how we are judged according to Supreme Court rulings. However, I have never been trained on how to document a use of force incident for my own defense.

During my 30-year career with the Georgia Bureau of Investigation, I investigated numerous use of force cases and since retiring, I work with attorneys who represent officers in these cases. Use of force cases vary drastically from a homicide, robbery or child molestation case. In a use of force case, we know the "who", the "what" the "when", and the "where" but the most critical is the "why" which can only come from the officer. There may be video from a body worn camera, a vehicle camera, nearby business surveillance cameras and bystander's cellphone cameras. While these may show some of the incident, none of this records the officer's perception which can only come from the officer involved in the incident. So, how do we get that information?

While assisting in an officer involved shooting that resulted in the death of a suspect in South Georgia, I was conducting a walk-through interview with the young officer asking him to explain his thoughts and perceptions of every aspect of the incident. I already knew of his statement to his attorney two days before I became involved. As he responded to one of my questions, I asked him why he had not informed his attorney of that information. He said, "I didn't think it was that important." After his third response of, "I didn't think it was that important", I realized at that moment, there must be a better way to get the critical, cognitive information and the officer's perception to his/her attorney. The Thin Blue Defend app was born. To date, it is the only one of its kind and is considered groundbreaking technology.

Officers involved in a critical incident resulting in the death or serious injury of the suspect need to be aware of what is about to transpire. One of the first concerns for all at the scene is life saving measures, if needed. After everyone has been attended to, questions will come from first responders asking, "What happened?". If an officer answers this question and if either officer has a BWC, this first statement can be misinterpreted. Attorneys that represent officers know that an officer will answer certain "safety and security questions" such as, "Is anyone else hurt that we don't know about?", "Is there evidence we need to seize?", "Is another suspect on the run?", etc. But, attorneys want to know what their client said; those first statements are critical and may provide a narrative for the investigating agency. Those first utterances or statements are very incomplete and do not contain all the facts and perceptions of the officer. If an officer, through the advice of their attorney, does not provide a statement, the investigating agency possibly only has a body worn camera, a vehicle camera, citizen witnesses (who may be biased) and other information from business and/or residential cameras. This information is incomplete and they do not have the incident from "the officer's perspective".

Next, the officer is most likely separated from everyone else; any weapon, body worn/vehicle camera, department cellphone used is seized by the department supervisors. If the officer used their personal cellphone, it may also be seized under "exigent circumstances" or probable cause. Now, while waiting for the investigating agency and/or their attorney, the officer is in a patrol vehicle outside the scene or taken back to the department. What does an officer tell their attorney? What is important to convey to an attorney that knows very little about the case other than their client called and provided a scene location and the suspect is either deceased or enroute to a hospital? Can the officer remember every detail about what just happened? Does the officer even know what details about the case would be important at a trial two to three years from now?

The attorney arrives and now begins to hear from the officer. Depending on the demeanor of that officer, it may be difficult for him/her to convey details about the incident that just occurred. The Thin Blue Defend app enables an officer to channel his/her thoughts to the incident details rather than the thoughts of "I just killed someone". By using the provided categories on the app, the officer can describe his/her thought process for every action taken.

An officer will be judged according to the Supreme Court ruling of Graham v Connor in that: The Fourth Amendment "reasonableness" inquiry is whether the officers' actions are "objectively reasonable" in light of the facts and circumstances confronting them, without regard to their underlying intent or motivation. https://supreme. justia.com/cases/federal/us/490/386/

Most departments compel an officer to complete a use of force report or face termination. An officer, through the advice of an attorney, may decide to make a formal statement to the investigating agency. These statements will now follow the officer over several years until the case is either dismissed through the criminal and/or civil court or at a trial in either or both courts. The prosecutors will lock the officer into this original statement and any deviation or additional information added may result in them attacking the officer on the stand claiming he/she has had several years to "get their story straight" or may accuse the officer of now providing a self-serving statement. This happened in the trial on the case mentioned above. Note: Fortunately, this officer was found 'not guilty' on manslaughter charges.

The Thin Blue Defend app is an innovative process using technology to provide a series of drop-down selections, audio recordings, text boxes, and cellphone camera access to document what an officer saw, heard, smelled and most importantly, perceived, during a critical incident. Categories include: the officer's condition, suspect actions, suspect response to officer commands, weather conditions, riot situations, equipment utilized during the incident, any malfunction of equipment, vehicle pursuits, obstructions and hinderances, what an officer was advised prior to arriving, after incident investigation and what items were seized from the officer. The main theme of the entire process is "How did (the category, i.e. the suspect's actions) effect your decision in using force? Again, this can only come from the officer and not from a scene sketch, scene photographs or physical evidence seized by the investigating agency.

Prior to documenting an incident, a user must first acknowledge advisements such as:

- The Threats Have Been Stopped/Contained
- Aid To Everyone Has Been Rendered
- Professional Emergency Medical Technicians Are Now On Scene And Have Taken Over Life Preserving Measures
- I Have Been Examined By EMT
- I Have Contacted My Attorney And Received Advisement And Am Documenting This Incident At The Direction Of My Attorney
- I Am Documenting This Incident Outside Of The Official Scene Area As Denoted By Crime Scene Markings and/or Barriers As Designated By The Law Enforcement Agency Having Authority.

CAUTION: Using Your Personal Cellphone At The Scene, In The Presence Of The Investigating Agency, Increases The Risk Of Your Cellphone Being Seized And Searched. You May Choose To Only Use The App In The Presence Of Your Attorney.

An incident document can now be created. The app features a one-touch GPS location, a onetouch current weather conditions and quick emergency contact information. The GPS button was designed based on an investigation I conducted of an incident that occurred in a creek bed half a mile from any roadway. The weather feature was included because of a case which occurred during a pouring rain which effected the officer's decision to pursue and use force.

The mobile app requires no typing of text because after a critical incident, it may be difficult to type any text. Therefore, the entire process utilizes prepared selections and access to audio recording and camera features of the cellphone. For example, as an officer describes the suspect with the audio button, prompts are provided such as hair color and length, clothing, physical build and other identifying descriptions. The officer can take any photos (outside of the designated scene) such as the officer's personal condition, any business cameras near the location and documents provided to him/her during the investigative process. The documentation of this is important information so that now an investigator for their attorney can go back to the area and obtain any business videos, interview any owners of homes near the incident location or obtain any evidence that may have been missed by the investigating agency.

Another important category that I developed was based on a past case. An officer's physical condition is sometimes overlooked by the investigating agency. This particular case involved an officer not being checked by emergency medical technicians that arrived on the scene. After fighting with the suspect, the EMTs asked the officer if he was okay and the officer responded he was fine. The officer began having serious headaches a couple of weeks later. He had sustained some head injuries during the fight that were not visible at the scene. We encourage the officers to be checked by EMTs and to advise them of any non-visible aches and pains however minor. When EMTs check an officer, a report is generated. Now we know blood pressure, temperature, heart rate and any complaints made by the officer.

Another case involved a fight with a suspect and not all the clothing was seized nor were enough photographs taken by the investigating agency. The clothing condition can provide a piece of physical evidence to be brought out in a trial. Just as the clothing was important in the Treyvon Martin and George Zimmerman trial, it too can be just as important in any of these trials. If the clothing and officer condition is noted several days and weeks later, it can be attacked by the prosecutor as "How can we know this was the condition at the time of the incident?"


If an officer's case goes to trial, attorneys will usually have a use of force expert brought in to first, conduct a walk-through with the officer and have the officer explain in detail, the events as they occurred. The experts are looking for the thought process of the officer and why the officer did what he/she did because of all the factors they faced during the entire incident. To borrow the words from Illinois v. Gates, the "totality of the circumstances". These experts are asking the cognitive questions to find out the "why". In one OIS case, the attorney and I were standing off to the side while the expert conducted his walk through with the officer and he came to me after and asked, "How did he do it?" I asked, "What do you mean, how did he do it?" He stated when he conducts these walk throughs, he usually must ask many questions invoking the thought process of the officer and this one, he barely asked any of those questions. He continued by saying the officer was able to inform him of everything he was thinking as the incident unfolded. The expert stated this accomplished two things, one, he was able to obtain all the information he needed to decide if the shooting was justified and two, if he, the expert, testifies in a criminal proceeding for the officer, there is a lesser chance the prosecutor can attack him on leading the officer in the questioning. Thankfully the officer, prior to being interviewed by the expert, had used the Thin Blue Defend app to document the entire incident. I felt the combination of two great attorneys and utilization of the app played a major role in the officer being able to explain his actions from the beginning until the conclusion of the incident. Note: This officer testified before a grand jury and was "no billed".

The goal of Thin Blue Defend is to assist officers in their defense when facing criminal charges. It enables the officer to provide in great detail the thought process so the attorney can better defend their client. Armed with this information from the officer's perspective, the investigating agency may not even bring charges against the officer.

If we are to be judged according to Graham v. Connor, it is

my hope that all agencies investigating these cases across the United States investigate according to Graham v. Connor.

To quote a use of force expert. The

n 1962, President John F. Kennedy signed a proclamation which designated May 15 as Peace Officers Memorial Day and the week in which that date falls as Police Week.
