CORRECTIONAL OFFICER I ROBERT DANFORTH CLARK

Georgia Department of Corrections, Georgia End of Watch Sunday, October 1, 2023


Correctional Officer I Robert Clark died after being assaulted by an inmate with a homemade weapon at the Smith State Prison.He was escorting two prisoners from the dining hall when one of them attacked him from behind with the weapon. The second prisoner attempted to stop the attack but was also assaulted and injured before the attacker was subdued. Officer Clark and the

wounded inmate were both transported to a local hospital where Officer Clark succumbed to his wounds.The inmate who attacked him, who was already serving a life sentence for murder, was charged with Officer Clark's murder.Officer Clark had served with the Georgia Department of Corrections for only six months. He is survived by his mother, two brothers, four sisters, six nephews, and nine nieces.

DEPUTY SHERIFF TUCKER BLAKELY

Knox County Sheriff's Office, Tennessee End of Watch Monday, October 2, 2023

Deputy Sheriff Tucker Blakely succumbed to gunshot wounds he received while responding to a domestic violence call at the 3200 block of Denver Lane in Knoxville.At 11:30 p.m., deputies encountered an armed subject after receiving a domestic violence call. The situation escalated, and a gun battle ensued. Deputy Blakely was struck twice.The subject was shot and killed by returning gunfire.Deputy Blakely was transported to UT Medical Center and remained on life support so his organs could be donated.Deputy



Blakely was a United States Army veteran and had served with the Knox County Sheriff's Office for two years. He is survived by his wife, son, and brother.

HONORING AND COMMEMORATING SERVICE AND SACRIFICE

About The Memorial

he National Law Enforcement Officers Memorial is centered in the 400 block of E Street, NW, Washington, DC and is the nation's monument to law enforcement officers who have died in the line of duty. Dedicated on October 15, 1991, the Memorial honors federal, tribal, state, and local law enforcement officers who have made the ultimate sacrifice for the safety and protection of our nation and its people.

The Memorial features two curving, 304-foot-long blue-gray limestone walls. Carved on these walls are the names of more than 23,000 officers who died in the line of duty throughout U.S. history, dating back to the first known death in 1786. Unlike many other memorials in Washington, DC, the National Law Enforcement Officers Memorial is ever-changing: new names of fallen officers are added to it each spring, in conjunction with National Police Week.

Designed by architect Davis Buckley, the Memorial sits on three acres of federal park land in an area of Washington, DC called Judiciary Square, the historic seat of our nation's judicial branch of government. The Memorial grounds boast plush carpets of grass, nearly 60,000 plants and 128 trees. Each April, more



than 10,000 daffodils bloom at the site, providing a burst of color for visitors. The Memorial's central plaza features an intricate paving pattern and a bronze medallion with the Memorial Fund logo: a blue shield with a red rose draped across it.

Bordering the Memorial's beautifully landscaped park are the two tree-lined "pathways of remembrance" where the names of the fallen officers are engraved. Each of the pathway entrances is adorned with a powerful statuary grouping of an adult lion protecting its cubs. Sculpted by Raymond Kaskey, the bronze statues symbolize the protective role of law enforcement officers and convey the strength, courage and valor that are hallmarks of those who serve and protect.

A number of commemorative ceremonies are held at the Memorial each year, and the site is visited by nearly a quarter million people annually. The Memorial's beauty and tranquility make it a special place for reflection, contemplation or just a quiet moment away from the hustle and bustle of city life.



POLICE OFFICER CHAD SWANSON

Manhattan Beach Police Department, California End of Watch Wednesday, October 4, 2023

Police Officer Chad Swanson was killed in a motorcycle crash on the 405 Highway at Del Amo Avenue.While on his way to work at 5:15 a.m., a vehicle struck his department motorcycle after another vehicle made an unsafe lane change. The impact threw Officer Swanson off his motorcycle. He was transported to Harbor Medical Center where he died from his injuries.In 2017, despite being wounded at the Route 91 Harvest Country Music Festival, he repeatedly ran into the

crowd bringing people to safety.Officer Swanson had served with the Manhattan Beach Police Department for 13 years and previously served with the Hawthorne Police Department. He is survived by his wife, three sons, and parents.

SERGEANT RICHARD CARRERO MENDEZ

Philadelphia Police Department, Pennsylvania End of Watch Thursday, October 12, 2023

Sergeant Richard Mendez was shot and killed at the Philadelphia International Airport's Garage D at about 11:00 p.m.He and his partner arrived in the parking garage, preparing to start their shift, when they observed subjects breaking into a vehicle. As they approached the men, the subjects fired at them. Sergeant Mendez was struck multiple times, and his partner was shot in the arm.Sergeant Mendez was

transported to Penn Presbyterian Medical Center where he succumbed to his wounds at 11:34 p.m.The suspects fled in a stolen vehicle. One of the suspects, who died from gunshot wounds, was dropped off at the Children's Hospital of Philadelphia. The rest of the suspects remained at large until October 16, 2023, when an 18-year-old suspect was arrested.Sergeant Mendez had served with the Philadelphia Police Department for almost 23 years and was assigned to the Airport Unit. He is survived by his wife and daughter.Sergeant Mendez was posthumously promoted to Sergeant and awarded the Purple Heart and Medal of Honor.





LIEUTENANT MILTON RESENDEZ

San Benito Police Department, Texas End of Watch Tuesday, October 17, 2023

Lieutenant Milton Resendez was shot and killed during a police pursuit at the 1100 block of North Sam Houston Boulevard in San Benito.At 10:58 p.m., the San Benito Police Department was notified that a fleeing vehicle being pursued by the Texas Department of Public Safety was entering their jurisdiction. Lieutenant Resendez was traveling north on North Sam Houston Boulevard when the fleeing vehicle approached from the southbound lanes. The subjects fired at

his patrol vehicle. One bullet hit the front of his vehicle, and the second struck the driver's side door. One of the bullets pierced Lieutenant Resendez in the abdomen below his vest. He was transported to Valley Baptist Hospital where he succumbed to his wounds. The two subjects were arrested after a pit maneuver stopped their vehicle. They have been charged with evading arrest, aggravated assault with a deadly weapon, and capital murder. Lieutenant Resendez had served with the San Benito Police Department for 27 years and previously served with the Brownsville Police Department and Palm Valley Police Department.



CORRECTIONAL OFFICER I KELLY BERNARD ROLANDO

Missouri Department of Corrections, Missouri End of Watch Sunday, October 22, 2023

Correctional Officer Kelly Rolando was killed in a vehicle crash at 7:14 p.m. on the 54 Bypass in Mexico, Missouri.Officer Rolando was returning to the Northeast Correctional Center in Bowling Green from a temporary assignment at the University Hospital in Columbia when he collided head-on with a vehicle traveling southbound.He and the driver of the other vehicle were killed instantly.Officer Rolando

had served with the Missouri Department of Corrections for eight years. He is survived by his mother, father, grandmothers, grandfather, three sisters, and two brothers.



SERGEANT JON ARDEN JENSON

Fort Worth Police Department, Texas End of Watch Saturday, October 28, 2023

Sergeant Jon Jenson died because of contracting COVID-19 in the line of duty. Sergeant Jenson was a United States Army veteran and had served with the Fort Worth Police Department for 26 years. He is survived by his wife, daughter, son, and sister.



SENIOR POLICE OFFICER PHOUKHAM TRA

Des Moines Police Department End of Watch Thursday, November 2, 2023

Senior Police Officer Phoukham Tran succumbed to injuries he received when he was struck by a drunk driver at the intersection of East 30th Street and East Grand Avenue in Des Moines on August 19, 2011.Officer Tran was directing traffic at the Iowa State Fair when the driver of a pickup hit him and threw him 47 feet into the air. He was transported to the University of Iowa Hospitals and Clinics where he

was treated for traumatic brain injury, broken ribs, and ruptured spleen. The driver was convicted of serious injury by vehicle, operating while intoxicated-2nd offense, and possession of a controlled substance and was sentenced to seven years. Officer Tran remained wheelchair-bound, suffering from seizures and speech, memory, vision, and coordination issues. On November 2, 2023, he passed away from his injuries. Officer Tran had served with the Des Moines Police Department as a police officer for over 12 years and was a cadet with the agency for 18 years. He is survived by his wife and two children.



DETECTIVE JAMES MICHAEL LETT

Benton Police Department, Arkansas End of Watch Wednesday, November 8, 2023

Detective Mike Lett succumbed to critical injuries he received in a vehicle crash on October 28, 2023.At 11:00 a.m., Detective Lett hydroplaned on Interstate 430 while responding to a service-to-assist with the Benton Police Department's Drug Take Back Program and struck a guardrail. He was transported to Baptist Hospital in Little Rock, where he died from his injuries.Detective Lett was a United States Air Force veteran and had served in law enforcement for over

30 years, serving with the Benton Police Department, Saline County Sheriff's Department, Pulaski County Sheriff's Department, Arkansas Attorney General's Office, Maumelle Police Department, and the Salt Lake City (Utah) Police Department. He is survived by his four daughters, a son, two sisters, adopted parents, and two grandchildren.

SENIOR POLICE OFFICER JORGE PASTORE

Austin Police Department, Texas End of Watch Saturday, November 11, 2023

Senior Police Officer Jorge Pastore was shot and killed during a hostage barricade at 9308 Bernoulli Drive at about 4:10 am.Patrol officers had initially responded to the residence for a domestic violence call involving a stabbing shortly before 3:00 am. Arriving officers located an injured victim outside of the home and learned there were two more injured victims inside. As the officers attempted



to enter the home to rescue the victims the subject inside opened fire, causing the officers to retreat. The agency's SWAT team arrived at the scene and attempted a hostage rescue at about 4:30 am. The subject opened fire on the SWAT team, fatally wounding Officer Pastore and wounding a second officer. The officers returned fire, killing him. The other two victims were also found deceased inside the home. Officer Pastore had served with the Austin Police Department for four years. He is survived by his wife, two stepsons, and parents.

CORRECTIONAL OFFICER III JOVIAN MOTLEY

Texas Department of Criminal Justice - Correctional Institutions Division, Texas End of Watch Monday, November 13, 2023

Correctional Officer III Jovian Motley died while helping restrain a combative inmate at the J. Dale Wainwright Unit at 2665 Prison Road 1 in Lovelady. The cause of death is under investigation. Officer Motley had served with the Texas Department of Criminal Justice -Correctional Institutions Division for over one year. He is survived by his mother and father.

BORDER PATROL AGENT FREDDY ORTIZ

United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol, U.S. Government

End of Watch Tuesday, November 14, 2023

Border Patrol Agent Freddy Ortiz was killed in an ATV crash in Douglas, Arizona, while responding to reports of undocumented immigrants in the area of Chino Road and 5th Street. His ATV left the roadway and struck a utility pole as he drove along International Drive

while searching the area at about 7:00 pm. The collision caused the ATV to overturn and he suffered fatal injuries.Border Patrol Agent Ortiz was a U.S. Navy veteran. He had served with the United States Border Patrol for 13 years and was assigned to the Douglas Station, Tucson Sector. He is survived by his mother and stepfather.







CAPTAIN RICHARD LOUIS RUIZ, SR.

Port Authority of New York and New Jersey Police Department, New York End of Watch Saturday, November 18, 2023

Captain Richard Ruiz died as the result of cancer that he developed following his assignment to the search and recovery efforts at the World Trade Center site following the 9/11 Terrorist Attacks.Captain Ruiz had served with the Port Authority of New York and New Jersey Police Department for 25 years. He was survived by his wife, two daughters, a son, his mother, and three grandchildren.



SERGEANT MICHAEL MORAN

Cortez Police Department, Colorado End of Watch Wednesday, November 29, 2023

Sergeant Michael Moran was shot and killed while making a traffic stop near the intersection of South Broadway and San Juan Drive at about 11:25 am.An occupant of the car shot Sergeant Moran before the suspects fled in the vehicle. Other officers located the two suspects approximately 1-1/2 miles south of the original shooting. One subject was shot and killed after opening fire on officers. A second subject was taken into custody.Sergeant Moran was a U.S. Marine Corps Iraq War veteran and had served with the Cortez Police Department for 11 years. He is survived by his two daughters.



SERGEANT MICHAEL ABBATE

Nevada Department of Public Safety - Nevada Highway Patrol, Nevada

End of Watch Thursday, November 30, 2023

Sergeant Michael Abbate and Trooper Alberto Felix were struck and killed by a drunk driver at 3:23 a.m. off Interstate 15 near D Street in Las Vegas.Sergeant Abbate and Trooper Felix had stopped to check on a driver who appeared to be sleeping in his car. Another vehicle hit them and fled the scene. One officer died at the scene. The other officer was transported to UMC Trauma Hospital where he

succumbed to his injuries. The subject was apprehended six hours later and was charged with two counts of each charge: reckless driving resulting in death, driving under the influence resulting in death, and duty to stop at the scene of an accident involving death. Sergeant Abbate had served with the Nevada Department of Public Safety - Nevada Highway Patrol for almost 11 years. He is survived by his wife and children.

TROOPER ALBERTO FELIX

Nevada Department of Public Safety - Nevada Highway Patrol, Nevada

End of Watch Thursday, November 30, 2023

Trooper Alberto Felix and Sergeant Michael Abbate were struck and killed by a drunk driver at 3:23 a.m. off Interstate 15 near D Street in Las Vegas.Sergeant Abbate and Trooper Felix had stopped to check on a driver who appeared to be sleeping in his car. Another vehicle hit them and fled the scene. One officer died at the scene. The other officer was transported to UMC Trauma Hospital where he

succumbed to his injuries. The subject was apprehended six hours later and was charged with two counts of each charge: reckless driving resulting in death, driving under the influence resulting in death, and duty to stop at the scene of an accident involving death. Trooper Felix was a United States Air Force veteran and had served with the Nevada Department of Public Safety - Nevada Highway Patrol for four years. He is survived by his wife and children.





SERGEANT JAMES MICHAEL RUSS

Chattanooga Police Department, Tennessee End of Watch Saturday, December 2, 2023


Sergeant Mike Russ suffered a fatal heart attack after working three 16-hour days supporting the Blue Cross Bowl at Finley Stadium at 1826 Reggie White Boulevard in Chattanooga.From November 30th, 2023, to December 2nd, 2023, Sergeant Russ was at Finley Stadium at 8:00 a.m., supporting record-breaking crowds at festivities and events before the bowl game. He also maintained his regular duties as a court liaison and his assignment at the Emergency Operations Center. During the


three days, coworkers expressed concern for symptoms he was displaying, such as shortness of breath and coughing. He went home at about 10:00 p.m. to complete department documentation when he collapsed. Despite resuscitation efforts, he was unable to be revived.Sergeant Russ was a United States Navy veteran and served with the Chattanooga Police Department for 16 years. He was survived by his wife, mother, brother, nieces, and nephew.Sergeant Russ a member of Law Enforcement United.

TECHNICAL SERGEANT CHRISTOPHER PHILIP ROCK

New York State Police, New York End of Watch Sunday, December 3, 2023

Technical Sergeant Chris Rock died as the result of cancer that he developed following his assignment to the search and recovery efforts at the World Trade Center site following the 9/11 Terrorist Attacks.Technical Sergeant Rock had served with the New York State Police for 26 years. He was survived by his wife, mother, brother, nieces, and nephews.





POLICE OFFICER PAUL TRACEY

Waltham Police Department, Massachusetts End of Watch Wednesday, December 6, 2023

Police Officer Paul Tracey was struck and killed by a vehicle while he was working a construction detail near 158 Totten Pond Road in Waltham.The subject was driving east on Totten Pond Road at 4:15 p.m. when he attempted to make a U-turn and collided with another vehicle. He drove away from the crash and struck Officer Tracey and three National Grid utility workers about a quarter mile from the initial collision. The subject continued driving, and when he struck

two additional vehicles, he fled on foot, brandished a knife, and then stole a police cruiser. He was apprehended after a foot pursuit.Officer Tracey and one of the utility workers died from their injuries. Two other utility workers were transported to the hospital.The subject was charged with failure to stop for police, negligent operation of a motor vehicle, larceny of a motor vehicle, armed robbery, assault with a dangerous weapon, two counts of manslaughter, and leaving the scene of an accident after causing personal injury and death.Officer Tracey had served with the Waltham Police Department for 28 years. He is survived by his wife, who is also a law enforcement officer, and two children.



SERGEANT RUSSELL EARL LAVARL JONES

Pamlico County Sheriff's Office, North Carolina End of Watch Wednesday, December 6, 2023

Sergeant Russell Jones suffered a fatal heart attack after responding to a disruptive inmate at the Pamlico County Detention Center in Bayboro.While trying to subdue the inmate at 8:33 p.m., Sergeant Jones was punched in the face. Fifteen minutes later, Sergeant Jones collapsed. Despite life-saving measures, he was unable to be resuscitated.Sergeant Jones had served with the Pamlico County

Sheriff's Office for four years. He is survived by his mother and two sisters.



DEPUTY SHERIFF PAUL MARTIN

Mercer County Sheriff's Office, North Dakota End of Watch Wednesday, December 6, 2023


Deputy Sheriff Paul Martin was struck and killed while deploying spike strips in an attempt to stop the pursuit of a stolen vehicle on Highway 200 at 5:35 p.m.Authorities were notified of a stolen vehicle that crashed through the door of an ambulance bay from Sanford Medical Center in Bismarck. When Mercer County deputies located the SUV in Hazen, the driver fled, and a pursuit began. Five miles west of Hazen,

the driver crashed into a Mercer County Sheriff's Office patrol vehicle with its emergency lights activated. The impact propelled the patrol vehicle into Deputy Martin, who was deploying stop sticks. The subject was apprehended at the crash scene. He has been charged with manslaughter, fleeing a police officer, and reckless endangerment. His manslaughter charge was upgraded to homicide. Deputy Martin had served with the Mercer County Sheriff's Office for 18 years. He is survived by his wife, three children, and four grandchildren.



New York State Police, New York End of Watch Saturday, December 9, 2023

Trooper Bob Burney died as the result of cancer that he developed following his assignment to the search and recovery efforts at the World Trade Center site following the 9/11 Terrorist Attacks.Trooper Burney had served with the New York State Police for 27 years. He was survived by his mother, two brothers, a sister, a longtime companion, and four nephews.





CHIEF OF POLICE CHRISTOPHER BYARD CUMMINGS

Samburg Police Department, Tennessee End of Watch Sunday, December 10, 2023

Chief of Police Christopher Cummings suffered a fatal heart attack after assisting with the dismantling of a beaver dam.The beaver dam was obstructing roads and causing flooding. Chief Cummings worked with other officers to tear down the structure, which was solid and difficult to tear apart. He stated that he did not feel well and was going back to the station. An hour later, when officers returned to

the station, they found Chief Cummings unresponsive. Despite resuscitation efforts, he was pronounced deceased.Chief of Police Cummings was a United States Army and Tennessee National Guard Iraq War veteran. He had served with the Samburg Police Department for two years and previously served with the Obion Sheriff's Office for three years and the Union City Police Department for 24 years. He is survived by his son, mother, father, girlfriend, and stepson.



SERGEANT STEPHEN GIBSON

Somervell County Sheriff's Office, Texas End of Watch Wednesday, December 13, 2023

Sergeant Stephen Gibson was killed in a vehicle crash on Texas State Highway 144.At 6:30 a.m., Sergeant Gibson was traveling northbound when a southbound truck lost control on the wet highway. The truck struck Sergeant Gibson's patrol vehicle head-on.Sergeant Gibson was pronounced deceased at the scene. The other driver was not injured.Sergeant Gibson had served with the Somervell County Sheriff's Office for 26 years. He is survived by his wife, two children, and grandchildren.

POLICE OFFICER DANIEL P. DIDATO

East Fishkill Police Department, New York End of Watch Monday, December 18, 2023

Police Officer Dan DiDato was killed in a vehicle crash near Mile Marker 36.8 on southbound Taconic State Parkway at about 6:00 pm.He was en route to the Westchester Medical Center to interview a pedestrian who had been struck by a vehicle near the East Fishkill police station. Officer DiDato's patrol car left the roadway and struck a tree as he drove along the parkway. He was transported to Mid-Hudson Regional Hospital where he succumbed to his injuries.Officer


DiDato had served with the East Fishkill Police Department for 18 years and previously served with the New York City Department of Environmental Protection for four years. He is survived by his parents and two brothers.

DEPUTY SHERIFF JOSHUA HAMILTON

Preble County Sheriff's Office, Ohio End of Watch Monday, December 18, 2023

Deputy Sheriff Joshua Hamilton died in a vehicle crash on Ohio State Route 503 at 4:00 a.m.Deputy Hamilton, traveling southbound, and a vehicle traveling northbound collided head-on. He was transported to the Kettering Preble ER Campus, where he was pronounced dead. The driver of the other car was also killed.Deputy Hamilton was a United States Navy Reserve and Army National Guard veteran and had served

with the Preble County Sheriff's Office for over 1 1/2 years. He is survived by his daughter and parents.









POLICE OFFICER MICHAEL CAIN MAXHEIMER

Shannon Hills Police Department, Arkansas End of Watch Tuesday, December 19, 2023

Police Officer Cain Maxheimer suffered a medical emergency after an incident with two dogs who attempted to attack him.At 7:10 a.m. on December 18, 2023, Officer Maxheimer helped a disabled motorist and pushed a vehicle out of the roadway. By 7:40 a.m., he was sent on a vicious animal complaint on Skyline Drive in Shannon Hills. When one

of the German Shepherds charged him, he was preparing to shoot the dog, but the strays ran into the woods. Officer Maxheimer returned to the department after 8:00 a.m. and complained of nausea and chest pains. He was admitted to the UAMS Medical Center, where he passed away the following day.Officer Maxheimer had served with the Shannon Hills Police Department for three years and previously served with the Benton Police Department, Bauxite Police Department, Saline County Sheriff's Office, Hot Springs County Sheriff's Office, Alexander Police Department, and Johnsons County Sheriff's Office. He is survived by three daughters and his father.



COURT OFFICER ROBERT J. SILVER

St. Clair County 72nd District Court, Michigan End of Watch Thursday, December 28, 2023

Court Officer Bob Silver was shot and killed while serving an eviction notice in the 6100 block of Genaw Road in Clay Township.Officers from the Clay Township Police Department were dispatched to the address to locate Officer Silver after court staff were unable to reach him for several hours. They located his body on the property suffering from gunshot wounds.The tenant at the home barricaded himself inside of the home for a short time before being taken into custody.

The man was charged with murder.Officer Silver had served with the St. Clair County 72nd District Court for 35 years.




POLICE OFFICER TUAN Q. LE Oakland Police Department, California

End of Watch Friday, December 29, 2023

Police Officer Tuan Le was shot and killed while responding to a burglary call at a cannabis store in the 400 block of Embarcadero at about 4:45 am.The store had already been burglarized one time before earlier in the night. As officers arrived at the scene following the second burglary, several suspects fled. Officer Le and his partner were in plainclothes when they were ambushed by a subject who was concealed nearby. Sergeant McIntyre was killed, and the other deputy was wounded. Other responding deputies were able

to rescue Sergeant McIntyre from the front yard. He was transported to a local hospital where he was pronounced dead.The man barricaded himself inside the home for several hours. He was eventually taken into custody by members of a regional SWAT team. The man continued to threaten deputies as he was removed from the scene.Sergeant McIntyre was a U.S. Army veteran and had served with the Spalding County Sheriff's Office for over 11 years. He is survived by his daughter, son, brother, fiancee, fiancee's son, and granddaughter.





SERGEANT PHILIP DALE NIX

Greensboro Police Department, North Carolina End of Watch Saturday, December 30, 2023

Sergeant Philip Nix was off duty when he was shot and killed when he attempted to intervene in a crime that he witnessed while at a gas station at 3202 Sandy Ridge Road in Colfax.One of the subjects involved in the crime shot Sergeant Nix before all the subjects fled in a vehicle to the nearby interstate. Deputy Sheriff Justin Smith was shot and killed while serving a warrant at the 300 block of Sawmill Road in Mountain View, Arkansas, at 4:30 p.m.When Deputy Smith attempted to arrest the subject for terroristic threats, he was shot.The subject was apprehended after a brief standoff and charged with capital murder.Deputy Smith had served with the Stone County Sheriff's Office for 14 years.




DEPUTY SHERIFF GREG MCCOWAN



Burnsville Firefighter/Paramedic Adam Finseth was shot while he was trying to help the wounded officers to an armored vehicle. The man continued to shoot at officers from an upstairs window.Officer Ruge, Officer Elmstraud, and Paramedic Finseth were transported to Hennepin County Medical Center where they succumbed to their wounds. The sergeant was treated and released.The man committed suicide and was found deceased in the home at about 10:15 am. The investigation revealed that the subject fired more than 100 rounds at the officers. The hostages were able to escape safely.Officer Elmstrand had served as a sworn officer with the Burnsville Police Department for five years and had previously served as a community service officer. He is survived by his wife and two young children.

He is survived by his wife, two daughters, a son, and three grandchildren.

SERGEANT THOMAS A. SANFRATELLO

The two had a short discussion, and as Patrolman Hare offered to drive the man into town, the subject suddenly produced a handgun and shot him. He shot him a second

time before pushing him into the passenger seat. He then abducted him and stole the patrol car, abandoning it approximately 16 miles away and fleeing on foot.Patrolman Hare was taken to a local hospital where he succumbed to his wounds two hours later.Unbeknownst to Patrolman Hare, the man was the suspect in the murder of an off-duty paramedic in South Carolina several days earlier. The car he was driving belonged to the murder victim. The subject was arrested two days later after exchanging gunfire with a Bernalillo County sheriff's deputy.Patrolman Hare had served with the New Mexico State Police for six years. He is survived by his girlfriend, two children, mother, father, and brother.




DETECTIVE FIRST GRADE JONATHAN DILLER

Detective First Grade Jonathan Diller was shot and killed during a traffic stop near 19-19 Mott Avenue in the Far Rockaway area of New York City.At 5:50 p.m., Detective Diller and his partner approached a vehicle that was stopped in front of a bus stop. Despite being asked numerous times to exit the vehicle, the subject refused. He pulled out a gun and shot Detective Diller in the stomach, striking him under

his vest. Detective Diller was able to get the gun away from the subject, and his partner wounded the suspect.Detective Diller was transported to Jamaica Hospital where he succumbed to his wounds.The subject, who had an extensive criminal record, was taken to Jamaica Hospital and is in stable condition.Detective Diller had served with the New York City Police Department for three years and was assigned to Patrol Borough Queens South Community Response Team. He is survived by his wife and one-year-old son.He was posthumously promoted to Detective First Grade and given a new shield number, 110, which is his son's birthday.



DEPUTY SHERIFF CHRISTINA MUSIL DeKalb County Sheriff's Office, Illinois

End of Watch Friday, March 29, 2024

Deputy Sheriff Christina Musil was killed when her patrol car was struck by a commercial vehicle on Illinois 23 south of Perry Road at about 10:40 pm.She was parked on the shoulder of the roadway when the approaching vehicle struck the rear of the patrol car. She was transported to a local hospital where she succumbed to her injuries.The driver was originally cited for failing to reduce speed to avoid an accident, improper lane usage, and operating an uninsured

motor vehicle But six days later, he was charged with three counts of aggravated DUI and one count of reckless homicide. Deputy Musil was an Illinois Army National Guard Military Police Afghanistan War veteran and had served with the DeKalb County Sheriff's Office for five years. She is survived by her three children, parents, brother, and sister.



AGENT ELIEZER RAMOS-VELEZ

Puerto Rico Police Department, Puerto Rico End of Watch Friday, March 29, 2024

Agent Eliezer Ramos-Velez was shot and killed while following several off-road vehicles whose riders had been shooting guns in the air and at passing cars along PR 26 at about 4:00 am.He was on his way home from his shift, driving his personal vehicle but still in uniform, when he witnessed the motorcycle and ATV riders shooting at vehicles as they drove along the highway. Agent Ramos-Velez radioed in the event and followed the vehicle along the highway and updated dispatchers as

they turned into the Sabana Abajo Housing Project along Monserrate Avenue.After dispatchers received no additional radio contact from Agent Ramos-Velez, officers located his body in the driver's seat of his vehicle inside the housing complex. His service weapon and police radio had been stolen. The suspects remain at large.Agent Ramos-Velez had served with the Puerto Rico Police Department for 12 years. He is survived by his girlfriend and infant son.



LEAD POLICE OFFICER ADAM BUCKNER

Tucson Police Department, Arizona End of Watch Sunday, March 31, 2024

Lead Police Officer Adam Buckner was struck and killed in a vehicle crash while responding to a call for service. Around 10:00 p.m., Officer Buckner was traveling north on Campbell Avenue in Tucson with emergency lights and sirens activated. As he went through the green light at the intersection at East 6th Street, a vehicle failed to yield and turned into his patrol car. He was transported to Banner University

Medical Center where he succumbed to his injuries.Officer Buckner had served with the Tucson Police Department for over two years and previously served with the New Orleans Police Department (Louisiana) for four years. He is survived by his wife, mother, brothers, and sisters.

History

The National Peace Officers Memorial Service, which is sponsored by the Grand Lodge of the Fraternal Order of Police, is one in a series of events which includes the Candlelight Vigil, which is sponsored by the National Law Enforcement Officers Memorial Fund



(NLEOMF) and seminars sponsored by Concerns of Police Survivors (C.O.P.S.)

National Police Week draws in between 25,000 to 40,000 attendees. The attendees come from departments throughout the United States as well as from agencies throughout the world. This provides a unique opportunity to

meet others who work in law enforcement. In that spirit, the Fraternal Order of Police DC Lodge #1 sponsors receptions each afternoon and evening during Police Week. These events are open to all law enforcement personnel and are an experience unlike any other.
