# THE NEVADA LAW ENFORCEMENT OFFICERS MEMORIAL

The Nevada Law Enforcement Officers Memorial is a monument in Carson City, NV, honoring officers who have died in the line of duty since 1861. As of May 2025, it contained the names of 157 fallen officers. The memorial is managed and maintained by the Legislative Police.

## Location and Visiting

The memorial is located on the grounds of the Nevada Legislature and is open to the public **24 hours a day, 7 days a week**, with free admission.

**Location:** 395 S Carson St, Carson City, NV 89701.

**Hours:** Open 24 hours a day.

**Admission:** Free of charge.

## Annual Events

An annual memorial ceremony, open to the public, is held in Carson City each May during National Police Week to honor the fallen officers. The ceremony often concludes a multi-day, 400-mile "Memorial Run" from Las Vegas to Carson City, during which officers carry a baton inscribed with the names of the fallen.

# HONORING AND COMMEMORATING SERVICE AND SACRIFICE

## About The Memorial

The National Law Enforcement Officers Memorial is centered in the 400 block of E Street, NW, Washington, DC and is the nation's monument to law enforcement officers who have died in the line of duty. Dedicated on October 15, 1991, the Memorial honors federal, tribal, state, and local law enforcement officers who have made the ultimate sacrifice for the safety and protection of our nation and its people.

The Memorial features two curving, 304-foot-long blue-gray limestone walls. Carved on these walls are the names of more than 23,000 officers who died in the line of duty throughout U.S. history, dating back to the first known death in 1786. Unlike many other memorials in Washington, DC, the National Law Enforcement Officers Memorial is ever-changing: new names of fallen officers are added to it each spring, in conjunction with National Police Week.

Designed by architect Davis Buckley, the Memorial sits on three acres of federal park land in an area of Washington, DC called Judiciary Square, the historic seat of our nation's judicial branch of government. The Memorial grounds boast plush carpets of grass, nearly 60,000 plants and 128 trees. Each April, more



than 10,000 daffodils bloom at the site, providing a burst of color for visitors. The Memorial's central plaza features an intricate paving pattern and a bronze medallion with the Memorial Fund logo: a blue shield with a red rose draped across it.

Bordering the Memorial's beautifully landscaped park are the two tree-lined "pathways of remembrance" where the names of the fallen officers are engraved. Each of the pathway entrances is adorned with a powerful statuary grouping of an adult lion protecting its

cubs. Sculpted by Raymond Kaskey, the bronze statues symbolize the protective role of law enforcement officers and convey the strength, courage and valor that are hallmarks of those who serve and protect.

A number of commemorative ceremonies are held at the Memorial each year, and the site is visited by nearly a quarter million people annually. The Memorial's beauty and tranquility make it a special place for reflection, contemplation or just a quiet moment away from the hustle and bustle of city life.



## LIEUTENANT MARK MEADOWS

Irondale Police Department, Alabama

**End of Watch: Monday, January 6, 2025**

Lieutenant Mark Meadows was struck and killed by a motorist while directing traffic at Grants Mill Road and Overton Road in Irondale. Shortly before 7:00 a.m., Lieutenant Meadows was putting out cones when he

was hit. He was transported to Grandview Medical Center where he succumbed to his injuries. Lieutenant Meadows was a United States Army veteran. He had served with the Irondale Police Department for 30 years and previously served with the Mountain Brook Police Department. He is survived by his wife, children, and two grandchildren.

## DEPUTY SHERIFF TIMOTHY CORLEW

Riverside County Sheriff's Department, California

**End of Watch: Wednesday, January 8, 2025**

Deputy Sheriff Tim Corlew was killed in a motorcycle crash at 5:30 a.m. on CA 91 east of La Sierra Avenue in Riverside. While traveling westbound in the HOV lane, Deputy Corlew's patrol motorcycle

collided with a vehicle, ejecting him from his motorcycle. He was transported to Riverside Community Hospital where he was pronounced deceased. Deputy Corlew had served with the Riverside County Sheriff's Department for eight years, assigned to the Jurupa Valley Sheriff's Station. He is survived by his wife and two children.

## DEPUTY SHERIFF JESUS VARGAS

Brazoria County Sheriff's Office, Texas

**End of Watch: Wednesday, January 15, 2025**

Deputy Sheriff Jesus Vargas was shot and killed while serving a warrant at Stella Link Road north of Interstate 610 in Houston at 11:30 a.m. When

Deputy Vargas and his partner approached the subject, the suspect fired at deputies from his vehicle. Deputy Vargas was transported to the Ben Taub Hospital where he succumbed to his wounds. The suspect, who was a repeat violent offender, fled the scene. When a U.S. Marshals

Service canine located the suspect hiding in a dumpster, the suspect fired multiple shots at the K9. A responding officer returned fire, killing the suspect. The canine suffered two bullet wounds to the neck and

nose and is in stable condition. Deputy Vargas had served with the Brazoria County Sheriff's Office for 17 years. He also served with the United States Marshal's Gulf Coast Violent Offenders Task Force. He is survived by his wife and three children.





## SERGEANT MARK BUTLER

Navasota Police Department, Texas

**End of Watch: Wednesday, January 15, 2025**

Sergeant Mark Butler was killed in a head-on collision during a pursuit on Highway 6 near Farm-to-Market 3090 in Navasota. When College Station officers confronted a female suspect attempting to cash fraudulent checks at a bank, the suspect fled southbound on

Highway 6. At the FM 2154 ramp, the suspect exited Highway 6 and reentered the highway, traveling south at speeds of over 100 mph in the northbound lanes. At 3:25 p.m., Sergeant Butler, who was traveling northbound, maneuvered his marked patrol vehicle and collided with

the suspect, preventing her from hitting other motorists on the highway. He was transported to CHI St. Joseph Hospital – Grimes Hospital, where he succumbed to his injuries. The suspect was killed at the scene. Sergeant Butler was a United States Army veteran and had served with the Navasota Police Department for almost four years. He is survived by his wife and two children.



## BORDER PATROL AGENT DAVID CHRISTOPHER MALAND

United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol, U.S.

Government

**End of Watch: Monday, January 20, 2025**

Border Patrol Agent Chris Maland was shot and killed during a traffic stop on Interstate 91 near Newport, Vermont, near the Canadian

Border at 3:15 p.m. Without warning, a female subject exited her vehicle and shot at officers. Officers returned fire, killing another subject in the vehicle who was armed. The shooter was apprehended

and charged with murder, assault with a deadly weapon, and multiple firearm offenses. Agent Maland was a United States Air Force veteran and had served with the United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol for over nine years. He was assigned to the Swanton Sector. He is survived by his mother, father, brother, and girlfriend.



## OFFICER BALDINO MORALES-SÁNCHEZ

Mayagüez Municipal Police Department, Puerto Rico

End of Watch: Saturday, January 25, 2025

Officer Baldino Morales-Sánchez was killed in a motorcycle crash on PR-406 in Añasco, Puerto Rico, shortly before 2:00 am. He was completing his shift at a municipal festival when he was involved in a single-vehicle crash. Officer Morales-Sánchez had served with the Mayagüez Municipal Police Department for 20 years and had previously served with the Añasco Municipal Police Department.



## OFFICER JASON ROSCOW

North Las Vegas Police Department, Nevada

End of Watch: Tuesday, February 4, 2025

Officer Jason Roscow was shot and killed while responding to a report of a subject brandishing a gun at a resident near the 4700 block of High Creek in North Las Vegas around 2:15 p.m. When Officer Roscow attempted to make contact with the subject, the man ignored him and fled. After locating the man, the subject refused commands and fired at Officer Roscow. Officer Roscow returned fire, killing the subject. Officer Roscow was transported to University Medical Center where he succumbed to multiple gunshot wounds. Officer Roscow was a United States Air Force veteran and had served with the North Las Vegas Police Department for 17 years. He is survived by two sons.



## TROOPER KYLE MCACY

Nebraska State Patrol, Nebraska

End of Watch: Monday, February 17, 2025

Trooper Kyle McAcY was struck and killed by a snowplow while at the scene of a traffic crash on eastbound Interstate 80 between Ashland and Greenwood. Around 10:00 a.m., Trooper McAcY was standing outside his patrol car when an approaching snowplow hit him during a snowstorm. Other troopers provided aid, but he succumbed to his injuries at the scene. Trooper McAcY had served with the Nebraska State Patrol for ten years. He is survived by his fiancee.



## POLICE OFFICER KELVIN PATRICK

Detroit Police Department, Michigan

**End of Watch: Thursday, February 6, 2025**

Police Officer Kelvin Patrick succumbed to gunshot wounds he received at the 18300 block of Steel Avenue in Detroit on May 24, 1996. While driving north on Steel Avenue shortly before noon, Officer Patrick and his partner observed juveniles walking south. He stopped his patrol car to investigate a possible case of truancy. When his partner approached the two juveniles, one subject smiled at her while he pulled out a handgun and fired at Officer Patrick. He then shot her in her hand before the two subjects fled east. Both officers were transported to

Grace Hospital. Officer Patrick's partner was released two days after the incident. Officer Patrick suffered wounds to his chest, back, and arm, piercing his spine and leaving him partially paralyzed. He passed away from complications from his wounds on February 6, 2025. The youths were never apprehended. Officer Patrick had served with the Detroit Police Department for 29 years.



## POLICE OFFICER CHRISTOPHER M. L. REESE

Virginia Beach Police Department, Virginia

**End of Watch: Saturday, February 22, 2025**

Police Officer Chris Reese and Police Officer Cameron Girvin were shot while conducting a traffic stop at Sylvan Court at approximately 11:30 p.m. Friday evening. While on patrol, Officer Reese and Officer Girvin observed a car with an expired plate and executed a traffic stop. During the traffic stop, the officers asked the subject to exit the vehicle, and the subject refused; when finally exiting the vehicle, the subject tussled with the officers and immediately produced a pistol,

shooting both Officer Reese and Officer Girvin. While the officers were incapacitated and on the ground, the subject shot each officer a second time and then fled the scene. The subject was found in a shed near the initial scene with a self-inflicted gunshot wound to the head.

First responders attempted life-saving procedures, and both officers were transported to local hospitals. Officer Reese succumbed to his wounds just after midnight at Princess Anne Hospital. Officer Girvin succumbed to his wounds at 4:30 a.m. Saturday morning at Virginia Beach General Hospital. Officer Reese had served with the Virginia Beach Police Department for three years and had previously served for three years with the Virginia Beach Sheriff's Office. He was survived by his wife and parents.



## **POLICE OFFICER JEREMY R. LABONTE**

**Roswell Police Department, Georgia**

**End of Watch: Friday, February 7, 2025**

Police Officer Jeremy Labonte was shot and killed while responding to a suspicious person reported at a shopping center at 1425 Market Blvd in Roswell around 7:15 p.m. When Officer Labonte arrived at the shopping center, he encountered the subject near the ACE Pickleball

Club. While the officer approached the subject for questioning, the man produced a handgun and fired at Officer Labonte multiple times. Officers responding to 911 calls arrived quickly and took the

subject into custody. Officer Labonte was taken to a local hospital where he succumbed to his

wounds. The suspect faces charges of murder, aggravated assault against a law enforcement officer, and a weapons charge. Officer Labonte had served with the Roswell Police Department for over three years. He is survived by his wife, parents, two sisters, nephew, and grandparents.



## **PATROLMAN ANDREW WILLIAM DUARTE**

**West York Borough Police Department, Pennsylvania**

**End of Watch: Saturday, February 22, 2025**

Patrolman Andrew Duarte was shot and killed while responding to reports of an active shooter at the UPMC Memorial Hospital on Innovation Drive and Roosevelt Avenue in York at 10:43 a.m. A subject entered the UPMC Memorial Hospital ICU on Saturday morning and, after learning the woman

he lived with had died, he pulled out a gun and started firing, striking a doctor and another hospital worker. He continued to threaten hospital employees and took a few hostages. When officers arrived at the scene,

the subject shot at officers and ordered them to retreat. Despite efforts to talk to the shooter, he refused to engage. When he emerged from the ICU, he was holding a female nurse hostage, whose hands were bound with zip ties, at gunpoint. Unknown to officers on the scene, the subject was out of ammunition

and his gun was empty. When the subject refused to release his hostage, officers fired. Two bullets struck Patrolman Duarte, mortally wounding him. During the standoff, the subject called his brother and shared his situation, stating that he was ready to die. Four hospital employees were injured; two were shot and two received other injuries. Two law enforcement officers were shot, and a third was wounded by shrapnel.

In 2021, Patrolman Duarte received a hero award from Mothers Against Drunk Driving for his work in enforcing impaired driving in Colorado. Patrolman Duarte had served with the West York Borough Police Department for over two years and previously served with the Denver Police Department for five years. He is survived by his mother and father.



## POLICE OFFICER CAMERON ROBERT GIRVIN

Virginia Beach Police Department, Virginia

End of Watch: Saturday, February 22, 2025

Police Officer Cameron Girvin and Police Officer Chris Reese were shot while conducting a traffic stop at Sylvan Court at approximately 11:30 p.m. Friday evening. While on patrol, Officer Girvin and Officer Reese observed a car with an expired plate and executed a traffic stop. During the traffic stop, the officers asked the subject to exit the vehicle, and the subject refused; when finally exiting the vehicle, the subject tussled with the officers and immediately produced a pistol, shooting both Officer Girvin and Officer Reese. While the officers were incapacitated and on the ground, the subject shot each officer a second time and then fled the scene. The subject was found in a shed near the initial scene with a self-inflicted gunshot wound to the head. First responders attempted life-saving procedures, and both officers were transported to local hospitals. Officer Girvin succumbed to his wounds at 4:30 a.m. Saturday morning at Virginia Beach General Hospital. Officer Reese had succumbed to his wounds just after midnight at Princess Anne Hospital. Officer Girvin had served with the Virginia Beach Police Department for five years. He is survived by his expectant wife and parents.



## DEPUTY SERGEANT MARTIN SHIELDS, JR.

Hinds County Sheriff's Office, Mississippi

End of Watch: Sunday, February 23, 2025

Deputy Sheriff Martin Shields was shot and killed while responding to a domestic call at the 15000 block of Midway Road in Terry. A female requested help in retrieving her belongings from a home. When Deputy Shields and another deputy arrived at the scene, a man inside the house fired at them. The suspect also shot his wife and another female trying to flee the home. The women were transported to a local hospital and are in stable condition. When responding officers entered the home, the suspect was found with self-inflicted gunshot wounds. He had a lengthy criminal history; 7 felony arrests and 18 misdemeanor arrests with zero convictions. Deputy Shields had served with the Hinds County Sheriff's Office for nine months and previously served with the Mississippi Department of Corrections and the Jackson Police Department. He is survived by his wife and daughter. His father had also served with the Hinds County Sheriff's Office.



## **POLICE OFFICER FELICIA DEE REILLY**

Saint Paul Police Department, Minnesota

**End of Watch: Saturday, March 1, 2025**

Police Officer Felicia Reilly succumbed to injuries she received after responding to a 911 hangup call at a residence in the 1600 block of Birmingham Street in Saint Paul on March 24, 2010. When Officer Reilly

arrived at the home, she was invited inside and was notified that the elderly couple's son was threatening them. As Officer Reilly approached the subject, he began to attack her. She used her taser to subdue him, but he kept swinging and punching her in the face. Despite being tased, the man punched her again, and she fell to the floor where the man

proceeded to kick her in the head multiple times. Officer Reilly stood up and attempted to subdue the subject, chasing him outside the home. After responding officers helped Officer Reilly restrain

the subject, she was transported to the hospital for her injuries where she was diagnosed with traumatic brain injury. Throughout the years she suffered from permanent double vision, chronic migraine headaches, light sensitivity, nausea, and a decrease in cognitive functioning, forcing her to retire from the department. She passed away on March 1, 2025, from her injuries. The subject was found guilty of assault and sentenced to 8 1/2 years in prison in 2015. He is unable to be charged with her murder due to the Double Jeopardy Clause in the Fifth Amendment of the United States Constitution. Officer Reilly had served with the Saint Paul Police Department for 17 years. She is survived by her husband, three sons, two daughters, two sisters, and grandchildren.



## **SUPERVISORY SPECIAL AGENT DENNIS M. WAGNER, JR.**

United States Department of Justice - Federal Bureau of Investigation, U.S. Government

**End of Watch: Wednesday, March 5, 2025**

Supervisory Special Agent Dennis Wagner died as a result of cancer that he developed following his assignment to the search and recovery efforts at the Flight 93 crash site in Shanksville, Pennsylvania, following the 9/11 Terrorist Attacks. Supervisory Special Agent Wagner

was a United States Army Reserves Iraq War veteran and served with the United States Department of Justice - Federal Bureau of Investigation for 20 years. He was survived by his wife, daughter, and son.



## SERGEANT LEE E. HENDRICKSON

New Jersey State Police, New Jersey

End of Watch: Friday, March 7, 2025

Sergeant Lee Hendrickson died as a result of cancer that he developed following his assignment to the search and recovery efforts at the World Trade Center site following the 9/11 Terrorist

Attacks. Sergeant Hendrickson was a United States Navy veteran and had served with the New Jersey State Police for 25 years. He is survived by his wife, two daughters, brother, and two grandchildren.



## SERGEANT JOSEPH ANTHONY AZCONA

Newark Police Division, New Jersey

End of Watch: Saturday, March 8, 2025

Sergeant Joseph Azcona was shot and killed while investigating illegal weapons possession at the corner of Carteret Street and Broadway in Newark. At 6:37 p.m. Sergeant Azcona and another officer arrived

at the intersection of Carteret Street and Broadway to question a subject about possible weapons possession. The subject began firing

on the officers immediately and both officers were struck while still in their vehicle. At least 18 shots were reported near the White

Castle at the intersection. When responding officers arrived, they discovered Detective Azcona and the other officer, both wounded. Both officers were transported to University Hospital where Sergeant Azcona succumbed to his wounds at 2:30 a.m. The other

officer was treated for non-life-threatening injuries. Five juveniles were taken into custody. A 14-year-old, who was injured, was charged with weapons possession and murder. Sergeant Azcona had served with the Newark Police Division for five years, the last two as a detective. He is survived by his mother, father, and five siblings. Sergeant Azcona was posthumously promoted to

Sergeant.



## DEPUTY SHERIFF HECTOR CUEVAS, JR.

San Bernardino County Sheriff's Department, California

**End of Watch: Monday, March 17, 2025**

Deputy Sheriff Hector Cuevas was killed when his patrol car struck a pole at the intersection of El Evado and Seneca roads just before 11 a.m.

Deputy Cuevas was in pursuit of a stolen vehicle that had been reported to the department just minutes earlier. During the high-speed chase, Deputy Sheriff Cuevas' vehicle collided with another car and then a nearby power pole. The impact of the crash split the patrol vehicle in half, critically injuring Deputy Sheriff Cuevas. Although first responders rushed to administer aid, he passed away at the scene. The driver of

the other vehicle was taken to a nearby hospital with non-life-threatening injuries. The driver of the stolen vehicle was apprehended a short time later and is in custody, charged with vehicular manslaughter while intoxicated, evading a police officer, and causing death or serious injury. He had a history of evading law enforcement and a lengthy criminal record for vehicular thefts. Deputy Sheriff Cuevas had served with the San Bernardino County Sheriff's Department for six years. He is survived by his wife, two children, his parents, and his brother and sister.

## SERGEANT GRANT J. CANDIES

St. Tammany Parish Sheriff's Office, Louisiana

**End of Watch: Sunday, March 23, 2025**

Sergeant Grant Candies was killed by the driver fleeing a traffic stop on Interstate 10 in Slidell near the Oak Harbor exit. The driver was driving

recklessly without a tag on the car when a deputy attempted to stop the vehicle on Brownswitch Road. When the driver refused to stop and continued to drive at speeds of 85-90 mph while swerving on the roads, a pursuit ensued. The suspects, all juveniles, continued to evade St. Tammany Parish deputies on Interstate 10 into Orleans Parish, where their vehicle crashed into a New Orleans Police Department unit near Crowder Boulevard at approximately 12:30 a.m. All suspects were apprehended, and the driver

was charged with first-degree murder, attempted first-degree murder, and aggravated flight. Two other juveniles have been charged with second-degree murder and manslaughter. The New Orleans Police Department officer in the unit struck by the suspects was injured but was treated for non-life-threatening injuries and released from the hospital. Sergeant Candies was a United States Marine Corps veteran and had served with the St. Tammany Parish Sheriff's Office for nine years. In 2023, he saved two lives and was named St. Tammany Parish Sheriff's Office Deputy of the Year. He is survived by his wife, two children, mother, father, three sisters, and a brother.



## POLICE OFFICER OSMAR RODARTE

Marysville Police Department, California

**End of Watch: Wednesday, March 26, 2025**

Police Officer Osmar Rodarte was shot and killed while serving a search warrant at Kestrel Court in Olivehurst at 7:50 a.m. Law enforcement officers were serving 20 drug trafficking search warrants

through the Yuba, Sutter, Tehama, and Butte Counties to stop a transnational drug trafficking ring from Mexico through the United States. When the Sutter regional SWAT team entered the home on Kestrel Court, the suspect opened fire, and gunfire was exchanged.

Officer Rodarte was struck in the ensuing gunfire. Officer Rodarte was transported to Adventist Health and Rideout Hospital, where he succumbed to his wounds. The suspect, a convicted felon, was shot and killed at the scene. Officer Rodarte was a United States Army veteran and had served with the Marysville Police Department for two years. He is survived by his wife and child.



## DEPUTY SHERIFF WILLIAM MAY

Walton County Sheriff's Office, Florida

**End of Watch: Wednesday, April 2, 2025**

Deputy Sheriff Will May was shot and killed while responding to a disturbance at the Dollar General Market at 10738 US-90 in Defuniak Springs. Around 2:00 p.m., Deputy May arrived at the store and, after talking to the subject, he decided to escort the man out of the store and not arrest him. As soon as they exited the building, the man pulled

out a gun and shot Deputy May a few times. Deputy May returned fire and was able to call for back-up. Deputy May was transported to North Okaloosa Medical Center with multiple gunshot wounds. One

of the bullets went underneath his bulletproof vest, and he passed away over four hours later. The suspect died at the scene. Deputy May was working an overtime shift and was on his way home when he took the disturbance call. He had served with the Walton County Sheriff's Office for over 11 years, the last six of which were as a law enforcement officer. He is survived by his wife, four children, and parents. His mother and father retired from the Walton County Sheriff's Office.

The driver of the semi-truck was not injured. Deputy Pollard had served with the Wood County Sheriff's Office for over eight years and had previously served with the Fannin County Sheriff's Office for three years and the Collin County Sheriff's Office for ten years. She is survived by her daughter, two sisters, her partner, and three grandchildren.



## CAPTAIN HELIO ARMANDO GARCIA, III

South Fulton Police Department, Georgia

**End of Watch: Wednesday, April 16, 2025**

Captain Helio Garcia was killed when his patrol car was struck by another vehicle at approximately 11:30 p.m. on Flat Shoals Road close to Connell Road. Captain Garcia was on patrol when a vehicle veered into his lane and hit his patrol car head-on. Captain Garcia was taken to Grady Memorial Hospital, where he succumbed to his injuries early the next morning. Deputy Sheriff Jesse Perez was killed when debris from a commercial vehicle struck him during a traffic stop on West U.S. Highway 180 in Lamesa. He succumbed to his injuries at Lamesa Medical Arts Hospital. Deputy Perez had served with the Dawson County Sheriff's Office for eight months. He is survived by his wife, three daughters, a son, mother, two brothers, a sister, and a grandson.



## DEPUTY SHERIFF BRANDON RAY SIKES

Columbia County Sheriff's Office, Georgia

**End of Watch: Saturday, April 26, 2025**

Deputy Sheriff Brandon Sikes was shot and killed during an attempted traffic stop just before exit 194 on Interstate 20, near Augusta, at approximately 6:30 p.m. Deputy Sikes and three other deputies were serving a domestic violence protective order on the subject. At first, the man was compliant and non-threatening, but when deputies turned away, he fired at them with a 9mm AR Pistol. Deputy Sikes was mortally wounded. Another deputy was shot in the face. Two deputies returned fire. One of the deputies gathered the injured deputy through a barrage of gunfire and transported him to the hospital, where he is in critical condition. The suspect attempted to flee in his camper but was stopped on the highway. Hours later, drones found the suspect dead inside his camper with pipe bombs, firearms, and ammunition. Deputy Sikes was a United States Army veteran and had served with the Columbia County Sheriff's Office for over six years. He is survived by his wife, who also serves with the agency, a daughter, parents, three brothers, nieces, and a nephew.



## **SPECIAL DEPUTY SHERIFF LARRY HENDERSON, JR.**

Hamilton County Sheriff's Office, Ohio

**End of Watch: Friday, May 2, 2025**

Special Deputy Sheriff Larry Henderson was intentionally struck and killed by a driver while directing traffic at the intersection of Martin Luther King Drive and Burnett Woods Drive in Cincinnati. At

1:00 p.m., Deputy Henderson was providing traffic control and monitoring the traffic signal box near the University of Cincinnati for their commencement ceremonies. While standing on the sidewalk, a driver deliberately drove his vehicle into Deputy Henderson. Deputy

Henderson was transported to the UC Medical Center, where he succumbed to his injuries. The driver, who had recently viewed body camera footage of his son being shot and killed after fleeing a stolen vehicle armed with a handgun, was arrested and charged with aggravated murder. Deputy

Henderson was a United States Marine Corps veteran and had served with the Hamilton County Sheriff's Office for 33 years. He is survived by his wife and five children. Three of Deputy Henderson's cousins are currently serving in law enforcement, and two uncles and a cousin have previously served in law enforcement.



## **SERGEANT ALTON DALE BERRIAN**

Santa Rosa County Sheriff's Office, Florida

**End of Watch: Friday, May 16, 2025**

Sergeant Dale Berrian passed away from complications of a heart attack after helping a disabled motorist move their vehicle out of the busy roadway. On May 8, 2025, Sergeant Berrian assisted with removing a vehicle from the Gulf Breeze Parkway near the Green Briar Parkway in Gulf Breeze just prior to completing his midnight shift. Immediately afterward, he complained of pain and went to the emergency room later that day. Sergeant Berrian went unconscious

while being examined and was life-flighted to HCA West Florida Hospital for emergency surgery. Despite life-saving measures, he never regained consciousness and passed away on May 16, 2025. Sergeant Berrian had served with the Santa Rosa County Sheriff's Office for 21 years and previously served with the Escambia Sheriff's Department. He is survived by his wife, four children, and ten grandchildren.



## LIEUTENANT ALLEN "NOOCHEE" CREDEUR

Lieutenant Noochie Credeur was shot and killed by friendly fire while serving a search warrant at the 500 block of East Harrop Street in Rayne. At 1:27, Lieutenant Credeur was attempting to locate a suspect wanted for attempted murder in a stabbing incident when he was hit by friendly fire. Despite life-saving measures, Lieutenant Credeur succumbed to his wounds at the scene. Lieutenant Credeur had served with the Rayne Police Department for over 20 years. He is survived by his brother and fiancée.



## POLICE OFFICER SAMUEL RIVEROS

Baldwin Park Police Department, California

End of Watch: Saturday, May 31, 2025

Police Officer Sam Riveros was shot and killed while responding to reports of gunfire at the 4200 block of Filhurst Avenue in Baldwin Park. At 7:12 p.m., when two officers arrived at the scene, they found one man unresponsive with a gunshot wound before they were met with gunfire. During the shootout, one of the officers was injured after bullets hit his patrol vehicle. Officer Riveros also responded to the shooting call to assist the officers. He ran into the hail of bullets, preventing the shooter from targeting the officers and the other community members in the neighborhood. Officer Riveros was transported to the Los Angeles County-USC Medical Center, where he was pronounced deceased. Investigators recovered a rifle and 60 spent shell casings at the scene. The man found unresponsive was shot and killed over a parking dispute. The suspect was struck with non-life-threatening wounds. He was charged with two counts of murder with special circumstances, two counts of attempted murder, and a charge for possessing an assault weapon. Officer Riveros had served with the Baldwin Park Police Department for nine years. He is survived by his mother, stepfather, two brothers, and a sister.



## **DEPUTY SHERIFF NATHANIEL ANSAY**

**Florence County Sheriff's Office, South Carolina**

**End of Watch: Tuesday, May 20, 2025**

Deputy Sheriff Nate Ansay was killed in a vehicle crash on State Highway 301 in Effingham around 4:20 p.m. Deputy Ansay was traveling northbound on Highway 301 between Langston Road and Meadow Prong Road when his patrol vehicle collided head-on with an SUV traveling southbound. He was transported to the hospital, where he succumbed to his injuries. The other driver was also hospitalized. Deputy Ansay had served with the Florence County Sheriff's Office for over one year.



## **DEPUTY SHERIFF DANIEL WESTON SHERRER**

**Morrow County Sheriff's Office, Ohio**

**End of Watch: Monday, May 26, 2025**

Deputy Sheriff Weston Sherrer was shot and killed while responding to a report of a shooting and domestic dispute at the 100 block of County Road and Country Road 15, south of Marengo, just outside of Columbus, at approximately 7:40 p.m. When Deputy Sherrer arrived at the residence, he found the subject seated on the porch. As he approached the subject and attempted to de-escalate the situation, the man threatened Deputy Sherrer with a gun if he came any further.

Deputy Sherrer stayed behind and continued to speak with the subject until he moved to the steps and fired at Deputy Sherrer, who was struck while returning gunfire. Deputy Sherrer was taken to a local hospital, where he succumbed to his wounds that night. His The suspect was also wounded and was transported to a local hospital in serious condition. A warrant for aggravated murder has been filed. Deputy Sherrer had served with the Morrow County Sheriff's Office for four years. He is survived by his parents, sister, and fiancée.




## POLICE OFFICER TIMOTHY ONTIVEROS

Bloomfield Police Department, New Mexico

End of Watch: Sunday, June 1, 2025

Police Officer Timothy Ontiveros succumbed to gunshot wounds he received during a traffic stop on Jordan Street at 10:55 p.m. on May 26, 2025. When Officer Ontiveros and another officer pulled over a driver, the man refused to roll down his window or give his identity. After negotiating with the subject for over eight minutes, the officers attempted to arrest the man. The subject pulled out a gun and fired at officers, striking Officer Ontiveros and barely missing the other officer, who returned fire, killing the subject. Officer Ontiveros was transported to San Juan Regional

Medical Center in Farmington with gunshot wounds to his neck and shoulder. He was flown to the University of New Mexico Hospital, where he passed away on June 1, 2025. As his final act of service, his organs were donated. Officer Ontiveros had served with the Bloomfield Police Department for six months and previously served with the Farmington Police Department for almost a year. He was also a volunteer firefighter with the Aztec Fire Department. He is survived by his daughters.



## SERGEANT JONATHAN D. "J.D." WHITE

Angleton Police Department, Texas

End of Watch: Sunday, June 1, 2025

Sergeant J.D. White was struck and killed while escorting a funeral procession. He was flown to Memorial Hermann Hospital in Houston, where he succumbed to his injuries. Sergeant White had served with the Angleton Police Department for 19 years. He was survived by three children and four grandchildren.

## LIEUTENANT EDDIE MAYS

Bernie Police Department, Missouri

End of Watch: Thursday, June 5, 2025

Lieutenant Eddie Mays suffered a fatal heart attack while arresting a man during a domestic call on West Crumb Avenue in Bernie at 4:53 p.m. The subject was arrested and charged with domestic assault. Lieutenant Mays was a United States Air Force veteran and served with the Bernie Police Department for 30 years. He is survived by his wife, two children, and eight grandchildren.





## POLICE OFFICER KRYSTAL RIVERA

Chicago Police Department, Illinois

**End of Watch: Thursday, June 5, 2025**

Police Officer Krystal Rivera was shot and killed during a confrontation with an armed subject. While on routine patrol at 9:50 p.m., officers attempted to stop a man they suspected of having a weapon at the 8200 block of South Drexel Avenue in the Gresham neighborhood. The subject fled and officers pursued the subject into an apartment building, where another armed subject confronted them. During the chaotic encounter, an officer discharged their weapon, fatally striking Officer Rivera. Officer

Rivera was placed into a patrol vehicle, but while en route to the hospital, the car experienced a mechanical malfunction and caught fire. She was transported in another vehicle and succumbed to her wounds at the hospital. The two suspects fled the scene but were apprehended shortly thereafter. One of the men, a convicted felon wanted for six outstanding warrants, was charged with armed violence, illegal possession of a firearm, possession of a controlled substance, and possession of a fraudulent identification card. The second suspect, who was on parole, was charged with firearm possession by a felon and drug possession. Officer Rivera had served with the Chicago Police Department for four years. She is survived by her daughter.



## POLICE OFFICER GABRIEL FACIO

Apache Junction Police Department, Arizona

**End of Watch: Sunday, June 8, 2025**

Police Officer Gabriel Facio died six days after being shot in the face by a driver who had been pulled over for brandishing a gun in a road-

rage incident in the area near Ironwood Drive and Elliott Road. On the morning of Monday, June 2, Officer Facio and additional officers responded to a road-rage incident involving a driver who had allegedly threatened others with a gun. After being pulled over, the driver was initially cooperative. However, when asked to step out of the vehicle, he became aggressive, retrieved a handgun from the glove compartment, and exited the vehicle. Officers ordered him to stop and attempted

to subdue him with non-lethal weapons, but the subject fired at the officers, striking Officer Facio in the face. Officers returned fire, wounding the subject. Officer Facio was rushed to the hospital, where he remained in critical condition for six days before succumbing to his wounds just after

1:00 p.m. on Sunday, June 8. The subject was injured and also taken to the hospital. When he was released, he was charged with one count of first-degree murder, seven counts of aggravated assault, and two counts of disorderly conduct involving a weapon. Officer Facio had served with the Apache Junction Police Department for nearly four years and had previously served as an officer in Phoenix and other agencies in the area. He is survived by his wife, daughter, son, parents, and a grandchild.



## SERGEANT SHIOU DENG

Los Angeles Police Department, California

**End of Watch: Monday, June 23, 2025**

Sergeant Shiou Deng was struck and killed by the driver of a vehicle while assisting at the scene of a vehicle crash on the southbound lanes of Interstate 405 at Moraga Drive in Los Angeles. Around 1:58 a.m., Sergeant Deng was traveling south on the 405 when he witnessed a collision. After turning on his emergency lights, he exited his patrol vehicle to help the victims in the crash when he was hit by another driver. One person died at the scene. Sergeant Deng was transported to the Ronald Reagan UCLA Medical Center, where he succumbed to his injuries. Sergeant Deng had served with the Los Angeles Police Department for 26 years.



## UNDERSHERIFF BRANDON GAEDE

Phillips County Sheriff's Office, Kansas

**End of Watch: Friday, June 27, 2025**

Undersheriff Brandon Gaede was shot and killed while arresting a subject at 899 1st Street in Phillipsburg around 9:28 p.m. After receiving a call about loud booms and explosions around 6:00 p.m., responding officers were unable to find the source but cleared the area, attributing the noise to fireworks. At 8:30 p.m., Undersheriff Gaede responded to the scene after three more calls were made. When he encountered a subject outside his house, the man denied setting off fireworks. Undersheriff Gaede cleared the call but stayed in the area, believing that someone was exploding something stronger than commercial-grade fireworks. Another call came in regarding explosives at 9:18, and Undersheriff Gaede was immediately on the scene and found the same subject in his yard and smoke nearby. The man admitted to setting off explosives, not commercial-grade fireworks, a felony in Kansas. While placing the subject in handcuffs, the man pulled out a concealed handgun and shot Undersheriff Gaede five times. He returned fire, killing the subject. Undersheriff Gaede was transported to a local hospital, where he succumbed to his wounds less than an hour later. An investigation revealed the suspect had more than 33 pounds of illegal explosive materials, over 20 firearms, and a stockpile of ammunition. Undersheriff Gaede had served with the Phillips County Sheriff's Office for eight years. He is survived by his wife and three children.



## **POLICE OFFICER KENDALL ISAIAH CORDER**

**Milwaukee Police Department, Wisconsin**

**End of Watch: Sunday, June 29, 2025**

Police Officer Kendall Corder succumbed to gunshot wounds he received when he was ambushed at North 24th Place and West Garfield Avenue in Milwaukee on June 26, 2025. Around 9:00 p.m., Officer Corder and his partner responded to a domestic violence call with a subject with a gun, which was upgraded to a shots fired call while they were en route to the scene. When they exited their patrol vehicle and approached the alley, they were shot at least 16

times by a subject shooting a Glock-style handgun with an extended magazine, hiding in the bushes. Both officers were transported to Froedtert Hospital. One officer was released on June 28, 2025, after receiving gunshot wounds to the back and foot. Officer Corder remained on life support until passing away from multiple gunshot wounds, including a severed spine, on June 29, 2025. The suspect was apprehended the next day and was charged with first-degree intentional homicide and first-degree recklessly endangering safety. Another was charged with harboring or aiding a felon. A third person was charged with possession of a firearm by a felon. Officer Corder had served with the Milwaukee Police Department for over six years. He is survived by his grandmother, two siblings, and a nephew.



## **DETENTION OFFICER FRANCISCO PAUL FLATTES**

**Cherokee County Sheriff's Office, North Carolina**

**End of Watch: Monday, June 30, 2025**

Detention Officer Francisco Flattes was shot and killed by a federal inmate at the Erlanger Western Carolina Hospital at 3990 E. U.S. Highway 64 Alt in Murphy, North Carolina. Officer Flattes and another officer transported the inmate to a medical appointment when the inmate took Officer Flattes' gun and mortally wounded him. The inmate fled into the parking lot and drove off after carjacking a vehicle. Officer Flattes was transported to the local hospital, where he

was pronounced deceased. Another officer was also injured in the scuffle and is recovering. The inmate was apprehended after a standoff. Officer Flattes had served with the Cherokee County Sheriff's Office for four years. He is survived by his wife, who also served with the Cherokee County Sheriff's Office, four daughters, two sons, and 15 grandchildren.



## DEPUTY SHERIFF DEVIN MASON

Darlington County Sheriff's Office, South Carolina

**End of Watch: Tuesday, July 1, 2025**

Deputy Sheriff Devin Mason was shot and killed while responding to a call on Old Timers Court in Darlington County. At 1:30 a.m., Deputy Mason and another deputy arrived at the residence, where they received a tip regarding the location of a man and a woman with outstanding warrants. The deputies found the woman standing outside and arrested her. When the deputies entered the home, they initiated contact with the mother of the male subject, who stated that she did not know the location of her son. Deputy Mason walked to

the door of the bathroom and was met with gunfire from the subject hiding inside the bathroom.

Both deputies returned fire. Deputy Mason was mortally wounded, and the other deputy was transported to the hospital in stable condition. The suspect was shot and killed. The suspect's mother was charged with obstruction of justice and misprision of a felony, but she died before her trial. Deputy Mason had served with the Darlington County Sheriff's Office for over three months. He had completed his field training a week earlier. He is survived by his son, mother, stepfather, and fiancée.



## OFFICER MIGUEL CANO

California Highway Patrol, California

**End of Watch: Wednesday, July 2, 2025**

Officer Miguel Cano was killed in a vehicle crash at Bristol Parkway north of Green Valley Circle in Culver City, California, at 12:30 a.m. Officer Cano and his partner had just arrested a subject for possession of drugs and an illegal weapon and were transporting him to be processed. While driving on Bristol Parkway, Officer Cano stated that he did not feel well. Shortly after that, he lost control of his patrol vehicle and crashed into a tree. Officer Cano was transported to Ronald Reagan UCLA Medical Center, where he passed away. His partner and the detainee suffered minor injuries. It is believed

that Officer Cano suffered a medical emergency and lost consciousness before the crash. An investigation has been initiated. Officer Cano had served with the California Highway Patrol for two years. He is survived by his wife and parents.



## DEPUTY SHERIFF ANTONIO ALEMAN

Deputy Sheriff Antonio Aleman was killed in an automobile crash on eastbound Interstate 10, close to the Avenida de Mesilla exit, at approximately 5:00 p.m. Deputy Aleman's patrol vehicle collided with the back of a semi-truck while on duty. He was transported to MountainView Regional Medical Center in Las Cruces, where he succumbed to his injuries. Deputy Aleman had served with the Dona Ana County Sheriff's Office for four years. He is survived by his wife and two children.



## SUPERVISORY BORDER PATROL AGENT ERIC CESPEDES

United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol, U.S. Government

End of Watch: Friday, July 11, 2025

Supervisory Border Patrol Agent Eric Cespedes drowned while attempting to save his children, who were caught in a rip current off South Padre Island, Texas. Around 3:30 p.m., Agent Cespedes entered the water and pulled his children out of a rip current. When he returned to the beach, he collapsed. Despite immediate life-saving measures, he passed away at Valley Baptist Medical Center.

Supervisory Border Patrol Agent Cespedes had served with the United States Department of Homeland Security - Customs and Border Protection - United States Border Patrol for 17 years, assigned to the Rio Grande Valley Sector. He was survived by his wife, three children, mother, and four siblings.



## DEPUTY SHERIFF JEREMY CASSADY

Escambia County Sheriff's Office, Florida

End of Watch: Tuesday, July 15, 2025

Deputy Sheriff Jeremy Cassady succumbed to complications from gunshot wounds he received on October 29, 2010.

Deputy Cassady and other deputies responded to a domestic call at 8083 Baywind Circle in Pensacola around 10:00 a.m. When they entered the home, a subject was holding a screaming female hostage and using her as a shield. The subject shot three deputies before he was struck once in the hand and retreated into the bathroom. SWAT members were able to convince the shooter to surrender. Three deputies and the female hostage survived their gunshot wounds. Deputy Cassady was in critical condition for 20 days. After losing both kidneys and receiving a kidney transplant, Deputy Cassady suffered from multiple medical issues. On July 15, 2025, he passed away from medical conditions he developed due to his gunshot wounds.

The suspect, who was the former boyfriend of the female he took hostage, was convicted of four counts of attempted murder, two counts of aggravated assault, armed kidnapping, and trespassing, and was sentenced to four life terms. Deputy Cassady had served with the Escambia County Sheriff's Office for six years. He is survived by his wife, mother, three sisters, and two nieces.



## PAROLE AGENT JOSHUA BYRD

California Department of Corrections and Rehabilitation,  
California

End of Watch: Thursday, July 17, 2025

Parole Agent Joshua Byrd was shot and killed in the Division of Adult Parole Operations at 7717 Edgewater Drive in Oakland at 12:48 p.m. Agent Byrd was transported to Highland Hospital, where he succumbed to his wounds. The shooter, a parolee who was released from prison a week and a half earlier, fled the scene, taking a bus and later stealing a car. He was apprehended and will be charged with first-degree murder.

Agent Byrd was a United States Navy veteran and had served with the California Department of Corrections and Rehabilitation for 11 years. He is survived by his wife and three children.



## **DETECTIVE WILLIAM OSBORN**

Los Angeles County Sheriff's Department, California

**End of Watch: Friday, July 18, 2025**

**End of Watch: Thursday, July 31, 2025**

Sergeant Fredrick Coleman suffered a fatal heart attack while responding to an emergency call for assistance at the Cummins Unit Prison at 2540 Highway 388 in Gould, Arkansas. At 11:34 a.m., Sergeant Coleman was rushing to the aid of another officer during an all-code assistance call when he collapsed and struck his head on the floor. Emergency personnel and staff administered life-saving measures until he was transported to Dumas Medical Center Hospital. When he arrived, he was pronounced deceased. Sergeant Coleman had served with the Arkansas Department of Corrections for 15 years and was awarded the Director's Outstanding Service Award in 2022. Sergeant Kenneth Salas was struck and killed by a motorcyclist while removing debris on Interstate 90 near the Four Lakes exit in Spokane.

At 7:40 a.m., Sergeant Salas stopped with emergency lights activated to help a motorist retrieve a haybale that fell onto the eastbound

highway. He used his patrol vehicle to block the haybale while the motorist pulled his trailer to the right side of the road. Other drivers moved to the right lane to avoid the patrol vehicle, but the motorcycle driver did not see the patrol car until it was too late.

When he attempted to avoid hitting the patrol car, he struck Sergeant Salas. Sergeant Salas was transported to Providence Sacred Heart Medical Center, where he passed away from his injuries. The motorcyclist was also taken to the hospital with serious injuries. Sergeant Salas was a United States Air Force and Washington State Air National Guard veteran. He had served with the Spokane County Sheriff's Department for 34 years and was planning to retire the following month. He is survived by his wife.



## **SERGEANT CALEB EISWORTH**


Baton Rouge Police Department, Louisiana

**End of Watch: Sunday, August 10, 2025**

Sergeant Caleb Eisworth succumbed to injuries he received in a motorcycle crash when he was intentionally struck on June 16, 2025. 
## **SERGEANT RYAN HUDSON**

Sergeant Frederick Scheidt died as a result of cancer that he developed following his assignment to the search and recovery efforts at the World Trade Center site following the 9/11 Terrorist Attacks. Sergeant Scheidt had served with the New York State Police for 30 years. He was survived by his wife and son.

## TROOPER DENNIS RICKS

South Carolina Highway Patrol, South Carolina

End of Watch: Wednesday, August 13, 2025



Trooper Dennis Ricks succumbed to injuries he received when he was struck by a truck during a traffic stop on August 10, 2025. Around 2:00 a.m., Trooper Ricks had stopped a vehicle on Interstate 26 eastbound near mile marker 166 in Orangeburg. When he walked back to his patrol vehicle, the driver of a box truck struck him. After completing his standard physical fitness test around 9:50 a.m., Officer Jackson began to stumble and became incoherent. Rescue personnel immediately performed emergency measures, and he was transported to Advent Health Wauchua. While intubated, he suffered a fatal heart attack and passed away at 5:50 p.m. Officer Jackson had served with the Florida Department of Corrections for nine months.



## POLICE OFFICER SUZANNE O

Maui County Police Department, Hawaii

**End of Watch: Friday, August 15, 2025**

Police Officer Suzanne O was shot and killed near the Paia Sugar Mill, off of Baldwin Avenue, at approximately 8:30 p.m. Officer O was responding to a complaint of trespassing, terrorist threats, and an armed subject shooting a handgun. As she and fellow officers were searching for the subject, he fired at officers while hiding behind a concrete pillar. Officer O was struck in the chest and under her left arm. Officers returned fire, hitting the suspect in the hip. Although first responders attempted life-saving measures,

Officer O succumbed to her wounds at the scene. The suspect, a convicted felon, had received a temporary restraining order for the premises days earlier. He was taken into custody with non-life-threatening injuries and was charged with murder in the first degree. Officer O had served with the Maui County Police Department for five years and was assigned to District 1 patrol Division Bravo Watch shift. She was awarded the Certificate of Merit in 2023.




## POLICE OFFICER ERIC ESTRADA

Sergeant Lee Sorensen and Police Officer Eric Estrada were shot and killed while responding to multiple 911 hang-up calls at a residence near 700 North and 200 East in Tremonton after 9:00 p.m.

One of the officers was talking to a resident in the home about a domestic dispute, a man exited the house with a gun, opened fire, and mortally wounded the officer. Another officer arrived as backup and was also shot and killed. A deputy and a K9 from the Box Elder County Sheriff's Office were hospitalized with non-life-threatening injuries

after being shot while in their patrol vehicle. As additional officers arrived, bystanders convinced the man to surrender. He was arrested and charged with aggravated murder. Sergeant Sorensen had served with the Tremonton-Garland Police Department for 16 years. He is survived by his wife and three children.



## POLICE OFFICER HUNTER SIMONCIC



Police Officer Hunter Simoncic was intentionally struck and killed by the driver of a fleeing vehicle while he was deploying stop sticks on College Parkway and State Avenue in Kansas City. ## DEPUTY SHERIFF ANDY LAHERA

**End of Watch: Thursday, September 11, 2025**

Deputy Sheriff Andy Lahera succumbed to injuries he received on May 23, 2023, when he was struck by a vehicle while directing traffic at the intersection of Saunders Way and South Lecanto Highway in Lecanto, Florida. Sergeant Scott Heimann was shot and killed responding to a domestic violence call near the 2200 block of Downing Street in Hays at approximately 1:56 a.m. Around 11:00 p.m. on Saturday, September 27, authorities were responding to a call for help from a woman attempting to flee from a domestic violence attack. While leaving, her attacker hit her car, and she sought cover in a neighbor's home. When officers arrived at the suspect's home, he had begun to barricade himself in the house. He stated that he planned on killing himself and any officers

who attempted to enter his house. Officers set up a perimeter around the suspect's home while authorities tried to negotiate with the suspect to surrender peacefully. Sergeant Heimann was responsible for the team in the alley behind the home. At 1:56, the suspect fired from inside the house with a thermal scope, hitting Sergeant Heimann. Sergeant Heimann was immediately treated with life-saving measures and transported via air to a regional hospital, where he succumbed to his wounds at 4:03 a.m. Several local, regional, and state teams responded to negotiate with the shooter, who was ultimately found dead in his home with a self-inflicted gunshot wound at 6:29 a.m. Sergeant Heimann had served with the Hays Police Department for nine years and was a member of the Special Situation Response Team. He is survived by his wife, daughter, son, parents, two brothers, two sisters, grandmother, nieces, and nephews.



## **POLICE OFFICER RAY BARRANTES**

Chowchilla Police Department, California

**End of Watch: Friday, October 3, 2025**

Police Officer Ray Barrantes was killed when his patrol car struck the rear end of a semi-trailer in Madera County at the intersection of State Route 152 and Road 13 at 10:30 P.M. Officer Barrantes was driving his patrol car eastbound on the 152 when a semi-trailer hauling tomatoes southbound on Road 13 crossed the 152. Officer Barrantes' patrol car collided with the right rear end of the semi-trailer. He was pronounced dead at the scene. The semi-trailer driver was not injured. Officer Barrantes had served with the City of Chowchilla

Police Department for nearly two years and previously served with the West Sacramento Police Department. He is survived by his wife and three children.

The other

deputy is in critical condition. The suspect was pronounced dead at the hospital. Deputy Riley was a United States Navy veteran and had served with the Iberville Parish Sheriff's Department for six years. He previously served with the Gonzales Police Department. He is survived by his wife, two daughters, a goddaughter, parents, a sister, and two brothers.



## POLICE OFFICER HENRY FRANKLIN

Sikeston Department of Public Safety, Missouri

**End of Watch: Monday, October 6, 2025**

Police Officer Henry Franklin was shot and killed while serving a warrant with his tactical team on County Road 408 in Mississippi County at approximately 7:30 p.m. On Monday evening, Officer Franklin and his tactical team were called to assist with serving a warrant linked to a homicide investigation from earlier that day.

When the team arrived at the home of the suspect and attempted to make contact, the man fired at the officers from inside the house, killing Officer Franklin, and continued to fire. The suspect remained barricaded in the home for five hours and was found dead from a self-inflicted gunshot wound. Officer Franklin was a United States National Guard veteran and had served with the Sikeston Department of Public Safety for over 12 years. He is survived by his wife and four children.

Detective Corporal Christopher Mock suffered a fatal heart attack after responding to multiple investigations. On October 3, 2025, Detective Mock was called to the scene of a homicide. During the investigation, they called the bomb disposal team after finding an article that looked like an explosive device. Immediately after leaving the scene, he was called out to investigate a suicide. The next day, when Detective Mock suffered a heart attack, life-saving measures

were performed, and he was rushed to the hospital, where he stayed until he passed away on October 15, 2025. Detective Mock had served with the St. Lucie County Sheriff's Office for 21 years, assigned to the Criminal Investigation Division. He is survived by his wife and two children.

He was posthumously promoted to Detective Corporal.



## TROOPER NICKY CAYTON


Ohio State Highway Patrol, Ohio

count of malicious wounding, one count of aggravated malicious wounding. Corrections Officer Hall had served with the Virginia Department of Corrections for a year and a half.




## DEPUTY SHERIFF JUSTIN MOWERY

and the other guardsman were transported to local hospitals, where Specialist Beckstrom passed away on November 27, 2025. The other guardsman is in critical condition. The suspect remains in the hospital recovering from gunshot wounds. He was charged with three counts of assault with the intent to kill while armed and criminal possession of a weapon, and will be charged with murder in the first degree. Over 2,000 National Guard troops have been deployed to guard Washington, D.C. since August 2025. They are sworn in and deputized with the United States Department of Justice

- United States Marshals Service as certified law enforcement officers. Specialist Beckstrom had served with the United States Department of Defense - Army National Guard - West Virginia Army National Guard for over two years and was assigned to the 863rd Military Police Company, 111th Engineer Brigade. She had been deployed to Washington, D.C. since August 2025 and volunteered to stay for the Thanksgiving weekend. She is survived by her parents.



## **POLICE OFFICER ANDY CHAN**

Philadelphia Police Department, Pennsylvania

**End of Watch: Tuesday, December 2, 2025**

Police Officer Andy Chan succumbed to injuries he received in a motorcycle crash on January 3, 2019. Around 6:00 p.m., Officer Chan was driving on Rhawn Street in Philadelphia when the driver of another vehicle struck his motorcycle near Rowland Boulevard. Neither driver was cited for the crash.
