### **Academic War and Peace**

- In Times of Relative Academic Peace ....
  - EDUCATE:
    - You don't need to haveducate colleagues, admins, and Board members on AAUP Principles of <u>Academic Freedom</u>, <u>Shared</u> <u>Governance</u>, and <u>Tenure</u>
    - You don't need have a legal degree to read the law!
      - Know your rights, institutional policies, SACSCOC, and law
      - KNOWLEDGE IS POWER
  - ORGANIZE and RECRUIT:
    - Start local chapter...TFA, AAUP, AFT, etc.
    - get involved at state level
  - Plan for the Future:
    - · Create your own legal fund...you never know when you might need it

## **Academic War and Peace**

- In Times of Relative Academic War (now)....
  - If you get called into HR or unexpected meeting with an administrator....
  - Never Go it Alone!!!
  - Record the meeting (Texas is a one-party state)
  - Let them make their mistakes
  - TPIA
  - Play Offense More than Defense
  - HR/the administration is not your friend
  - SACSCOC, TPIA, and TOMA are your friends
  - Speak Softly and Carry a Big Stick
    - Know your policies, procedures, and your rights

# What we do.... Office of Faculty Representation (OFR)

- Began October, 2023
  - (necessity is the mother of invention)
- OFR members across the state
- Can represent you in meetings with administrators
- Communicate with university/college admins and legal counsel on your behalf
- Represent you during appeal hearings
- Help you prepare grievances
- Serve as liaisons with your legal counsel

### **State Sovereign Immunity**

- 11th Amendment of the Constitution
  - = State Sovereign Immunity
- Exceptions to the 11th:
  - Title VII (including Title IX)
    - "the great equalizer" = your foot in the door
    - TOMA
    - Whistleblower Statute
    - TPIA
- You can go after individual admins:
  - "1983" Constitutional claims
  - · ADA
  - FMLA
  - Etc.

### When to do what....

- If it's just a dispute...(example they took the clocks out of the classrooms)
  - Contact OFR
  - · Internal grievance may be appropriate
  - OFR can represent you in your meetings with admins
- If you are put on a PIP, given a letter of dismissal/non-renewal/termination
  - Contact OFR IMMEDIATELY
  - Do not file an internal grievance until you have talked with OFR
  - You may need to get legal help immediately
- If you are terminated mid-contract without due process
  - Contact OFR IMMEDIATELY
  - Do not give them a chance to correct their due process mistake!
  - You need legal help immediately
- 9/10 cases settle and never end up in court
