Dear Potential Class Member,

You previously received notice of a settlement in a class action lawsuit that arose out of the fire on April 3, 2015, at GE's Appliance Park in Louisville, Kentucky (the "AP6 Fire"). We write again to remind you of the Settlement and to encourage you to make a claim for benefits. Our records identify you as a potential Class Member.

- **Class Members may receive \$150 or more depending on the distance of your residence from the AP6 Fire. (Note: your final award amount may be more or less depending on the total number of valid claims we receive.)**
- **Class Members are eligible for cash payments even if you previously received money from GE in connection with the AP6 Fire.**
- Class Members may also claim out-of-pocket expenses resulting from the AP6 Fire and shelter-in-place advisories.

- **Claim Forms must be postmarked by January 16, 2018.**

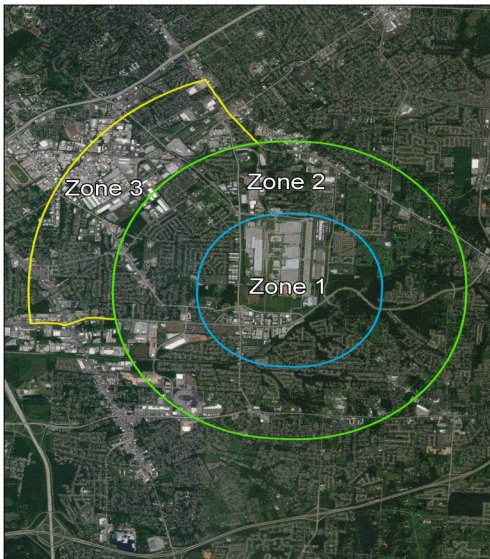
