All the structures (except residential block) are constructed using solid bamboo, Bamboo Shingles, Bitumen Sheet as water proofing material, WPC sheets, Polystyrene, Engineered bamboo tiles as flooring materials etc, except the base structures of non-combustible materials. As per the section 3(1) of the MFP & LSM Act, it is owner or occupier's liability to provide for fire prevention and life safety measures. Considering the legal provision, EOI/Applications are invited. The EOI/Applications shall be submitted within 10 days of publication only by the approved/empaneled Fire Auditors by the Maharashtra state Government.

Expression of Interest is invited for the following scope of work. Scope of work is in addition to the measures recommended by the National Fire Safety and Engineering College, Nagpur.

SCOPE OF WORK WILL COVER THE FOLLOWING AREAS

- 1. Assess the risk of Bitumen Sheet, Wood Polymer Composite and Bamboo Shingles that are used as Roofing Materials and corrective measures thereupon.
- 2. Assess the risk at the (first floor of) Academic block, residential block and corrective measures thereupon.
- 3. Assess the risk at first and second floor at the hostel block, canteen and corrective measures thereupon.
- Compliance of National Building Code of India 2016, Maharashtra Fire prevention and Life Safety Measures Act (MFP & LSM Act) 2006, BIS standards and others relevant provisions etc.

5. Any other provisions/suggestions/corrective measures that suit the site to prevent the fire accidents.

PAYMENT TERMS:

- 1. Fee for each scope of work is to be mentioned separately and clearly in the EOI.
- 2. Total fee shall be mentioned (including GST and other taxes) in the EOI.
- 3. Travelling cost shall be borne by the auditor.

DURATION OF WORK:

1. Audit report shall be submitted within 15-20 days from the issuance of work order.
