
A RESOLUTION TO NOTIFY THE ASSESSOR/COLLECTOR FOR THE CITY OF BARDWELL OF THE TAX RATE TO EMPLOY IN LEVYING PROPERTY TAXES FOR ALL TAXABLE PROPERTY WITHIN IT'S JURISDICTION FOR THE TAX YEAR 2023.

BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF BARDWELL, ELLIS COUNTY, TEXAS THAT FOR THE YEAR 2023, THERE IS HEREBY LEVIED ON ALL TAXABLE PROPERTY LOCATED WITHIN THE LIMITS OF THE CITY OF BARDWELL, AN NO NEW REVENUE ADOPTED TAX RATE OF 0.167088 ON EACH AND EVERY \$100 OF TAXABLE PROPERTY VALUE. SUCH TAX SHALL BE APPORTIONED AS FOLLOWS:

A TAX RATE OF \$0.167088 IS HEREBY ASSESSED AND LEVIED FOR THE CITY OF BARDWELL AND NO AMOUNT IS ASSESSED AND LEVIED FOR DEBT PURPOSES.

THE TAX ACCESSOR/COLLECTOR FOR THE CITY OF BARDWELL IS HEREBY DIRECTED TO EMPLOY THE NO NEW REVENUE ADOPTED RATE OF \$0.167088 FOR \$100 IN PREPARING THE 2023 TAX ROLL AND IN COLLECTION OF TAXES FOR THE 2023 TAX YEAR.
