
Meet the Board Candidates - 2/11/2026

Overflow Parking

The Board has authorized the towing of inoperable vehicles from the overflow parking area by the Clubhouse. Terri Kenyon, Board Members & Patrol are working on a new parking policy for homeowners to park their vehicles in any of the overflow parking areas.

Once the parking policy have been approved by the Board, the policy will be enforced. Vehicles parked in any of the overflow parking areas must be in working order and must be moved every 7 days. All vehicles must have a license plate or a temporary moving plate. The overflow parking areas are not for vehicle storage, broken down vehicles and abandoned vehicles.

Any changes to the exterior of your home (decks, patios, driveway, landscaping, trees, paint, roofing, irrigation, fences (including temporary Horse Fences), etc., must have prior approval from the ARB before you start the project. Failure to secure prior approval could result in a violation or fine (up to \$100) and may require you to stop work or remove any improvements you have made. ARB Forms are available in the Clubhouse Lobby or on the Website. Email requests are not accepted.
