- **Price:** 1 SPUN = 0.0001 Solana (10,000 SPUNCAT per Sol)
- Cap: 20 Sol per wallet.
- Order Policy: First Come First serve until presale cap is reached.
- **Delivery:** Airdropped to contributing wallet after liquidity is added and locked.
- Refunds: No refunds. Contributions are final.
- Rewards: Investors will be rewarded with 1,000 additional SPUNCAT tokens per each 1 Solana invested during presale. (1,000 SPUN tokens airdropped per Sol per Wallet).

• Each believer that contributes to SPUNCAT and turns this meme coin project into a Movement will receive tokens airdropped the associated wallet. Reward tokens will be tradable immediately at time of launch.

6. Liquidity and Launch Plan

- Add SPUN/SOL liquidity after presale closes.
- Lock 100% of LP tokens for 12 months and publish the lock proof link.
- Begin buyer airdrops after lock is verifiable on-chain.

- Threshold: 2 of 3 signers (This wallet consists of Main Phantom CwjUFgSX4bBAmntvfqmNoyokwpwjLvrJFwCrc3yJ5c7e, Phantom Biometric 6BLAKhepMbXt33hdRHdZZ3A6421zAdAh1RPLJXWrGRjC, Solflare Main HCRjNRPP7gw2ud9wnnih7GVtTrZS1xJo6WR1HvrmxfmG)
- All fund movements securely require 2 threshold approvals. 1 of which is the Biometric phantom wallet address.

9. Anti Impersonation Warning

Only links published in official channels (above) are valid. Any contracts, presales, airdrops, or listings not linked by the official channels are not endorsed and may be scams. We will never DM you. During the creation of the SPUNCAT token Heather created 2 billion tokens held in the Squads Multisig wallet that can not be updated with metadata. The unusable tokens will be burned and have a completely

different token address. This is being transparent, for we intend to build trust.

10. Timeline

- Presale Start: 2025-09-28 11:11pm EST Sarasota, Florida USA
- Presale End: Exact date and time to be determined by supply sold during presale. Presale will end when 20% of total supply or 400,000,000 SPUN is sold.
- Liquidity Add + LP Lock: immediately after presale
- Airdrop Distribution: After LP lock proof is posted.

11. Vesting strategy and schedule

- Following the official launch, there will be a 6 month cliff where no presale tokens will be released for selling.
- 25% of presale tokens will be released at the six month mark for investors to trade.
- At this time a determined percentage of tokens will then be slowly released in bi-weekly increments until each wallet receives the amount of tokens which were purchased during the presale timeframe.
- All tokens will be fully vested by 14 months from launch

12. Additional Project Information

As of today's date we're in the process of updating our metadata on Solscan. Just to make sure everything is transparent and ready for our community. We are really excited because Spuncat is just the beginning—we've got big dreams for future tokens that can help raise awareness for mental health and psilocybin mushrooms. We want to get people out from behind our phone screens and back to interpersonal real human connection by including fun activities down the line.

We have kept things a bit under wraps on social media to keep the project safe from copycats. And yeah, we intend to make this meme coin to be part of the 1% of tokens that stick and stay which is why we have taken so long to introduce our idea to the public. We have been extremely careful about testing. There has been some trial and error along the way and it has been a real learning process. We want to get it right and then build a strong, welcoming community and cause a movement.


