






### **Background**

- Original organization focused on Downtown Owensboro was created in 1978 by a collection of local business owners & residents (shut down in 2005)
  - Spearheaded original bridge lighting in 1995
  - Friday After 5, started in 1997, created new entity in 2004 to maintain concerts downtown
  - Transitioned to Downtown Development Corp. in 2007 and officially closed operations in 2011
  - GO-EDC assumed development focus, but downtown employee's role changed in 2013
  - Attempt to create private organization focused on downtown struggled due to lack of funding
- Current private & public stakeholders' objectives for downtown vary (no ideal individual home)
- Significant amount of underutilized real estate remains in the core downtown area (need small developments in addition to large)
- Difficulty in coordinating events while managing small business (need a "quarterback" to facilitate)
- Owensboro is the largest KY city without a dedicated downtown representative
- Over 25 cities participate in KY Main Street Program (requiring a dedicated downtown representative)

### **Other Downtown Organizations**

- Downtown Bowling Green (2021, City)
  - Recently announced master plan for \$50mm riverfront park & \$8.5mm expansion to SKyPAC
- Downtown Evansville (2017, Economic District)
  - Created both business organization and development corporation to benefit downtown
- Murray Main Street (2002, KY Main Street)
  - Started Downtown Farmer's Market
  - Rehabbed multiple properties (w/ new project in 2024)
- Paducah Main Street (KY Main Street)
  - UNESCO Creative City (2013); Historical Main Street (2024)
  - Lowertown Artist District relocation program (early 2000's)
