USE DIRECTIONS

This product should not be stored in a silo.

Granulated Diammonium Phosphate fertiliser for use at planting in grain and forage crops, in sugarcane and for top-dressing intensive pasture.

This fertiliser is for dry application to the soil. It contains insolubles and is not intended for application in solution, i.e. in fertigation programs or foliar sprays.

This product should not be fed to livestock or used in stock feed mixtures.

If top-dressing pastures, do not graze for 3 weeks after application.

WARNING - DO NOT STORE FERTILISER IN SILOS

Bulk fertiliser should only be stored for extended periods in purpose-built sheds or bunkers. Where this is not possible apply as soon as practical after dispatch - ideally within 48 hours.
