If top-dressing pastures, do not graze for 3 weeks, or until rain or irrigation is received or regrowth occurs.

This fertiliser is for dry application to the soil. Do not use in foliar sprays or fertigation.

WARNING - DO NOT STORE FERTILISER IN SILOS

Bulk fertiliser should only be stored for extended periods in purpose-built sheds or bunkers. Where this is not possible, Dellavedova Fertilisers recommends application as soon as practical after despatch - ideally within 48 hours.
