- Please no yelling or shouting.
- > Running will not be tolerated.
- Pet the cats gently.
- Do not chase the cats.
- Please take lots of pictures and videos! (No flash please)
- Be mindful of your time. Others are waiting for their turn!

All Cat Lounge visits are 45 minutes and a staff member will instruct visitors when it's time to enter and exit the lounge.

If I am a Parent or Guardian, I will supervise and accompany my minor or child at all times. Their actions are my responsibility.

We reserve the right to refuse entry and service to anyone.

If you do anything that is detrimental to the well-being of the cats, you will be asked to leave.

Those of you who bring children: they are your responsibility. You MUST supervise your children at all times. Please guide them in healthy interaction with cats.

I acknowledge that cats, even under the best of circumstances, may be unpredictable, may bite or scratch, or may transmit zoonotic diseases.

If a cat shows signs of aggression or discomfort, please do not agitate them further. Ziggy's Cat Lounge is not liable if cats scratch or lash out at you.

I certify that each visitor in my booking agrees to assume all responsibility and risk of interacting with animals.

I confirm that all visitors are at least 5 years of age.
