ALL Exhibitors/Vendors MUST download/print out and complete the entire application, submit a copy

of ID (Driver's License or Passport), required documents for Food Vendors (Food Handling License/Permit) and submit either BEFORE

May 31, 2024 via email, or(in person the first day of attendance if noticed first) NO EXCEPTIONS

d) All vendors who sign this application MUST COMMIT TO A 6-WEEK STRAIGHT AGREEMENT to be a Vendor at the Farmers Market. This is to benefit the community residents in having consistency, productivity and professionalism from the Farmer's Market. (Some exceptions.)

e) All vendors must have table drapery that touches the ground, so as to hide any boxes, merchandise, etc. This is to give the Farmer's Market a respectable presentation.

f) All Vendors must have weights for their tents

g) All Vendors must have proper signage for their business

H) The GFM will be held rain or shine. If weather conditions are a 'cause for concern', the GFM Team will assess, make a decision and notify Vendors 24 hours prior to the day of the FM operations.

I) Vendors who have excessive absences or Lateness (3 OR MORE DAYS) without proper notification will be excused from the GFM for the 2024 season.

H) Vendors can park in lot located at 90 Manhattan Ave and must remain until close of market. Cars will be permitted in Market area for set up purposes only before 9:45am

If the GBFM Management Team does not have the Exhibitor/Vendor completed application, proof of

ID and required documents before or on the first day of the market, that Exhibitor/Vendor will NOT

BE ALLOWED to participate in the GBFM.
