

# Maxwell Creek Market Garden 2026 CSA Membership Agreement

This Community Supported Agriculture (CSA) Agreement outlines the shared commitment between **Maxwell Creek Market Garden LLC** (“The Farm”) and the **CSA Member** (“the Member”) for the 2026 growing season.

---

## 1. Season & Membership

- The 2026 CSA season runs approximately from **April 1, 2026 to July 31, 2026** weather permitting.
- By joining the CSA, the Member purchases a *share of the Farm's harvest* for the season.

## 2. What Members Receive

- Members will receive a **weekly share** of seasonal farm produce.
- Share contents vary week to week and reflect seasonal availability, weather, and growing conditions.
- Shares may include vegetables, herbs, and occasional farm extras.

## 3. Shared Risk & Reward

- CSA membership is a partnership. Members share in both the **abundance and the risk of farming**.
- Weather, pests, disease, and other factors may affect quantity or variety of produce.
- No refunds will be issued due to crop loss or reduced harvest.

## 4. Payment

- Total cost of the 2026 CSA share:
  - **Harvest Box (for Pick Up): \$630**
  - **Harvest Box (for Delivery): \$710**
  - **Harvest Box WITH Flower Club (for Pick Up): \$950**
  - **Harvest Box WITH Flower Club (For Delivery): \$1030**
  - **Mini Harvest Box (For Pick Up) \$500**
  - **Mini Harvest Box (for Delivery) \$580**
  - **Mini Harvest Box WITH Flower Club (for Pick Up): \$850**
  - **Mini Harvest Box WITH Flower Club (for Delivery): \$930**
  - **Flower Club (for Pick Up): \$350**
  - **Flower Club (for Delivery): \$430**
- Payment options:

- Full payment due by **March 15<sup>th</sup>**
- Installment plan: Please contact [maxwellcreekmarketgarden@gmail.com](mailto:maxwellcreekmarketgarden@gmail.com) for an installment of 25% monthly (April, May, June, July)
- Membership is not contingent upon weekly yield.

## 5. Pick-Up & Distribution

- Pick-up location: **Murphy Community Center- 205 N. Murphy Rd., Murphy, TX 75094**
- Pick-up day & time: **Fridays from 12PM – 7PM**
- It is the Member's responsibility to pick up their share during the scheduled window.
- Missed pickups are forfeited unless prior arrangements are made.

## 6. Communication

- The Farm will communicate updates via **email**.
- Members are encouraged to read weekly communications for crop updates, storage tips, and farm news.

## 7. Vacation & Skipped Weeks

- Members may **transfer shares into a credit to be used in the future, donate, or skip** with advance notice, subject to Farm policy.
- Details: **Members may email at least 5 days in advanced if they are unable to pick up a weekly box. That box may be turned into a “credit” for later use.**

## 8. Food Safety

- The Farm follows good agricultural practices to provide safe, high-quality produce.
- Members are responsible for washing and properly storing produce after pickup.

## 9. Agreement Acknowledgment
