**ARTICLES OF INCORPORATION  
OF  
CALLAWAY LAKES HOMEOWNERS ASSOCIATION, INC.**

**ARTICLE I**

The name of this corporation shall be: Callaway Lakes Homeowners Association, Inc.

**ARTICLE 2**

This corporation is formed pursuant to the Georgia Nonprofit Corporation Code and shall have perpetual duration.

**ARTICLE 3**

This corporation shall have no stock or stockholders; it is not organized and shall not operate for profit or pecuniary gain; and no part of the net earnings of this corporation shall inure to the benefit of any member, director, officer or any private individual except that reasonable compensation may be paid for services rendered to or for this corporation affecting one or more of its purposes. No part of the activities of this corporation shall be for carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of any candidate for public office.

**ARTICLE 4**

The purpose for which this corporation is organized is to promote the recreation, health, safety, welfare, common benefit and enjoyment of the Owners of Units of Callaway Lakes Subdivision (the "Subdivision"), being located in Land Lots 259, 260, 285 and 286 of the 2<sup>nd</sup> Land District of Lee County, Georgia, as more fully set forth in those Protective Covenants Callaway Lakes Subdivision Section One A & ; Section Two; Section Three; Section Four; Section Five, Section Six and any amendments thereto (the "Protective Covenants") as said Protective Covenants are recorded in Deed Book 140, Page 115 and as amended by those Amendments recorded in Deed Book 451, Page 182, Deed Book 151, Page 166, Deed Book 170, Page 39, Deed Book 193, Page 215, Deed Book 352, Page 302, and Deed Book 509, Page 98, in the Office of the Clerk of the Superior Court of Lee County, Georgia and such other amendments as may be recorded.

Insofar as permitted by law, this corporation shall have the power to do anything that, in the opinion of the Board of Directors of this corporation, will promote, directly or indirectly, the recreation, health, safety, welfare, common benefit and enjoyment of the Owners and occupants of Units in the Subdivision, including, but not limited to, the power (i) to purchase, accept by gift, lease, hold, sell, mortgage, convey or otherwise acquire or dispose of any real and personal property necessary or proper for the carrying out of the purposes of this corporation; (ii) to own, acquire,

construct, equip, operate and maintain amenities, services and facilities incident to the purposes of this corporation; (iii) to fix, levy and collect assessments as provided in said Declaration of Covenants; and (iv) in general, to exercise all the rights, powers, privileges and immunities as are provided and allowed for similar corporations under the laws of Georgia, including, but not limited to, the Georgia Nonprofit Corporation Code, subject, however, to any limitations set forth in said Declaration of Covenants.

#### ARTICLE 5

The membership of this corporation shall be comprised of the Owners of Residential Units in the Subdivision as set forth in said Protective Covenants. Voting by the members of this corporation shall be as set forth in and subject to the provisions of said Protective Covenants.

#### ARTICLE 6

Directors shall be elected and serve as provided in the By-Laws of this corporation. The number of Directors constituting the initial Board of Directors shall be three and the name and address of each such Director is:

## ARTICLE 8


These Articles of Incorporation may be amended from time to time in the same manner as is provided in said Declaration of Covenants with respect to amendments to said Declaration of Covenants.


