AgVet Participant Expectations

The Indiana AgVets Certification and Internship Program is an agricultural career training opportunity specifically for U.S. military veterans in Indiana or surrounding states. The program provides an orientation opportunity for participants in rewarding careers in production agriculture or agribusiness by providing supervised training (free of charge) tailored to the veteran's personal interests and career aspirations, and paid internships in a farm or agricultural service business.

Indiana AgVets is a project of Hoosier Uplands Economic Development Corporation, in cooperation with the AgrAbility Project at Purdue University. The program is supported by the United States Department of Agriculture's National Institute of Food and Agriculture (NIFA) Grant Number 2019-77028-29971.

Program participants are expected to be fully committed to completion of all project-related activities and trainings, including the following:

Core Trainings:

- Introduction to Indiana AgVets, Overview of Indiana Agriculture, and Veteran Services (1 day)
- Tour(s) of Indiana Farms, Agribusinesses, and Supporting Organizations & Agencies (2 days)
- Employment and Career Guidance for Veterans in Agriculture (2 days)
- Agricultural Safety & Health Certificate Program (2 days)
- Indiana Commercial Pesticide Applicator Core Training (1 day)
- OSHA Powered Industrial Truck (Forklift) Certification (1 day)

(Core trainings will occur at various locations throughout Indiana)

Additional Training & Certification Programs:

In addition to the core trainings listed above, all AgVets participants will be expected to complete an additional 40-80 hours of trainings or educational programs directly related to their personal career interests. Project staff and internship mentors will assist the participants in selecting appropriate supplemental training.

NOTE: Registration costs and tuition for core trainings will be covered by the AgVets program. Costs for additional certifications will be partially or fully covered by AgVets. Transportation to and from events and programs is the responsibility of the participant.

Agricultural Internship:

The culmination of the AgVets program will be an 8-week paid internship at an Indiana farm or agricultural business. The internship will be full-time (40 hours per week), unless other arrangements are made with the intern host. Interns are expected to work at the direction of site supervisors and will be provided onsite job coaching by the AgVets project staff. Interns will be paid an hourly stipend by Hoosier Uplands Economic Development Corporation. Every effort will be made to place interns in a location within reasonable commuting distance of his/her home or school.

Optional Opportunities:

AgVets participants will be welcomed to participate in activities and events hosted by the Farmer Veteran Coalition (national) and the Indiana Chapter of the Farmer Veteran Coalition. In addition, AgVets will be invited to the annual AgrAbility National Training Workshop. Partial stipends may be available for some of these activities.
