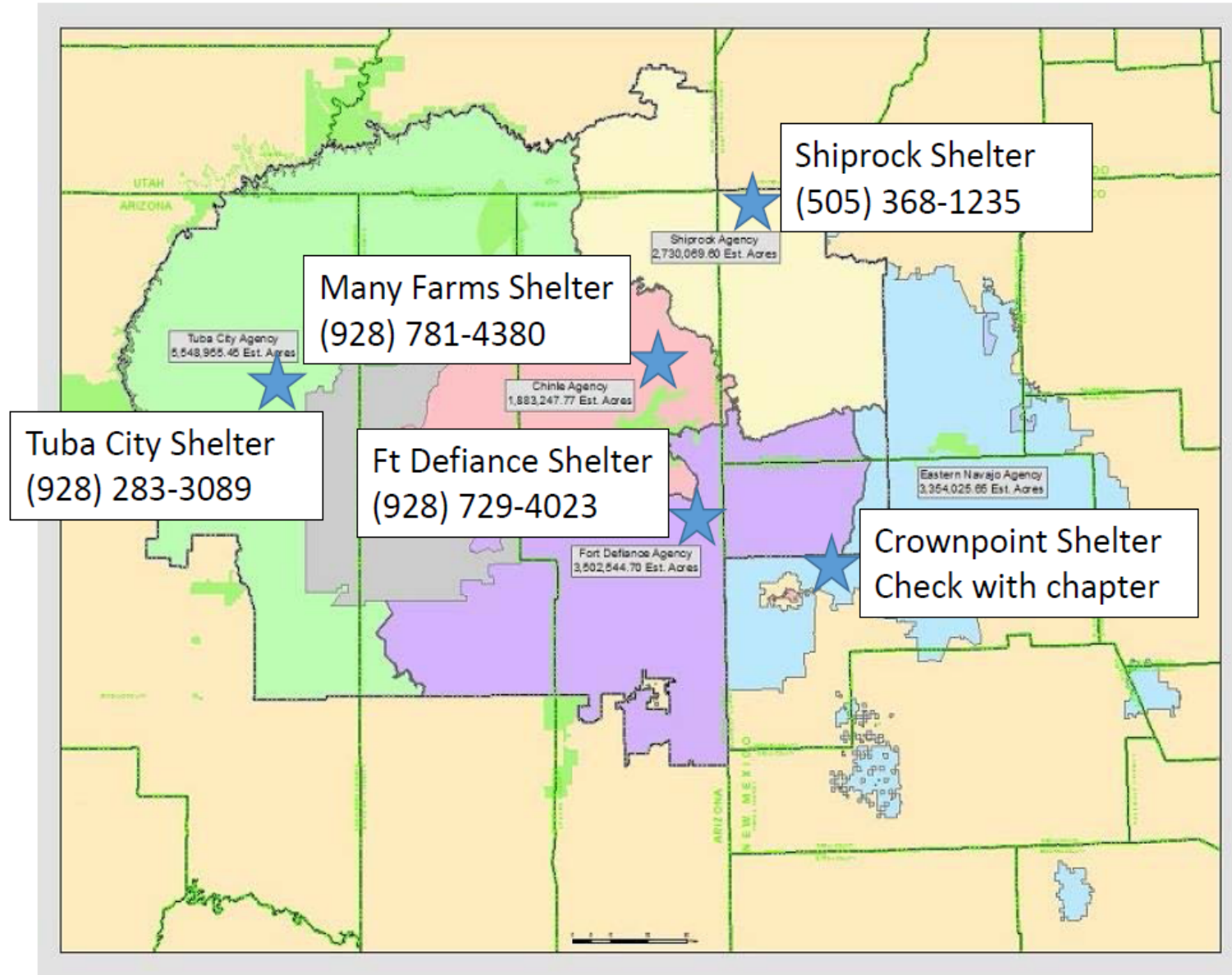

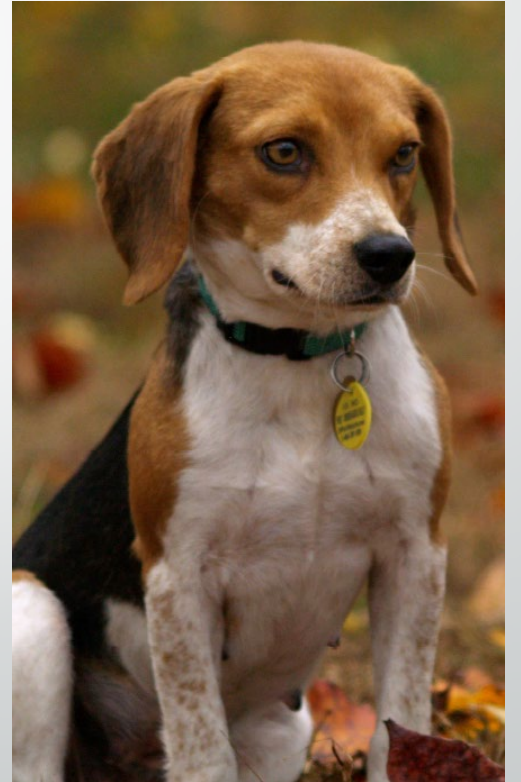

Navajo Nation Animal License

- Pets are REQUIRED to be licensed, microchipped, and rabies vaccinated at 3 months or older
- Animal Licenses are available at all agency shelters
- Animal license is placed on the collar
 - Needs to be visible
- Animal Licenses are good for one year
 - Expire December 31 each year
- It is the responsibility of animal owners to license and vaccinate pet each year



Navajo Nation Animal License

- **Title 13 § 1702 licensing**

- A) (1) Excessive Number of Dogs in the Household
- A) (2) Excessive Number of Cats in the Household
- A) (3) Failure to comply with lease agreement for number of allowable pets per household
- C) Failure to microchip your pet
- G) Failure to Obtain or display animal license
- H) Transfer of Animal Tags

- **Title 13 § 1704 Rabies Control**

- A) Failure to Vaccinate or Rabies
- B) Failure to produce certificate of vaccinate
- F) Failure to show proof of vaccination
