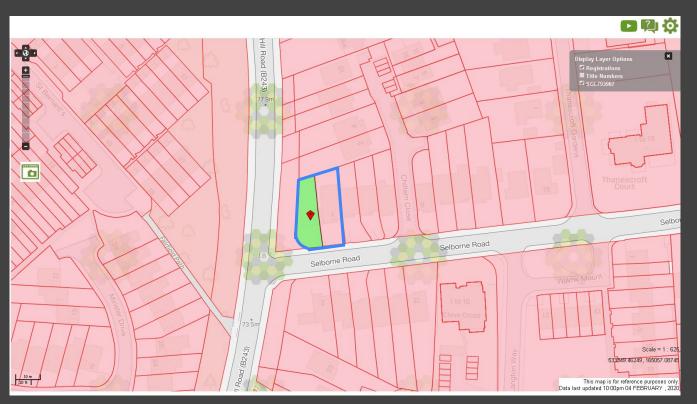
The Fundamentals of Option Agreements

"The Right but not the Obligation to	Option Period - initial app. & appeal
Buy Land / Property"	Security - restriction / agreed notice
£1.00	Landowner obliged to help / not hinder
Subject to Planning or Other Condition	Control over planning app.
Purchase Price - Fixed or Formula	Light touch conveyancing - owner's help
Overage Clause	Also use on HMO / prior approval
Assignable Contracts	projects
Can be traded / back to back	Get the right lawyer

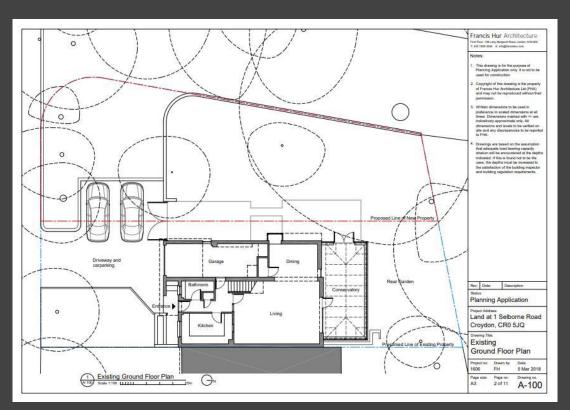

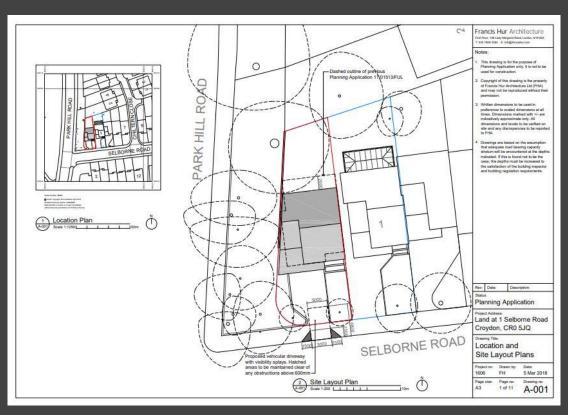

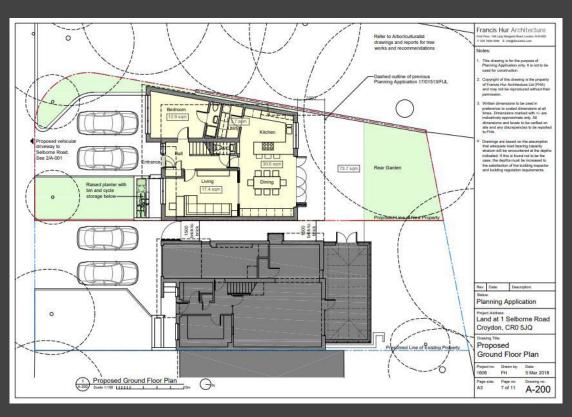
