Ambulance Services – Raber Township has received notice that Pickford Ambulance Service will be merging with Kinross Charter Township. This merge is due to increase costs and decreasing staff. Kinross hopes to be able to operate a crew out of the Pickford Ambulance garage in order to maintain appropriate response times to Raber Township. Linda and Leslie met with Tom Ball, Pickford Supervisor and Renee Gray, Kinross EMS Director to gather further details about the merger. Kinross has provided a service agreement to cover all of Raber Township in the amount of \$45,000 annually. The township board discussed options for coverage with

DeTour Township and at this time DeTour is unable to cover Raber entirely due to their declining volunteer base as well as the frequent need to cover Drummond Island. The board discussed funding options to cover the increase cost of the Kinross service agreement. The board will follow up with Pickford Township and Kinross EMS to plan a townhall meeting to better inform our residents of the current situation.
