# **Sign-Up Information**

<u>Sign-Ups\*:</u> Try-outs are not needed for Show Team teams. This allows any level of athlete to participate in the sport of cheerleading. While this level is introductory, it will give athletes and parents an idea of what competition cheerleading is all about. This is a "sign-up" process and teams are created by age groups. The age groups will range from 3 – 5 years old.

**Practices**: They will be on Tuesdays at 4:30-5:30 and they will attend their tumbling class on Thursdays at 4:30 to 5:15. Show Team will start with their team practices on June 5<sup>th</sup> at 4:30 to 5:30 and then their first tumbling Practice will be June 7<sup>th</sup>. Once they get their cartwheel and can follow along in a class and stay on task they will move to a Level 1 Tumbling Class of their choice but this will raise your tuition by 10.00 a month if you are in a Level 1 tumbling class.

<u>PRACTICE & TUITION:</u> Show Team will have two practices per week. Monthly tuition is \$100 (including tumbling.) Tumbling will be Thursday 430 to 515 and Team Practice Tuesdays 430 to 530. Practice wear will be provided.

<u>UNIFORMS:</u> Uniform tops will be full length and the skirt will be an "A LINE" design. It will not be the same uniform as our full competitive squads, but will be the same colors.

<u>COMPETITIONS:</u> Show Team will attend 4 competitions. These competitions will not require an overnight hotel stay. Show Teams will perform locally in the Houston/Galveston area. Show teams receive participation awards and are not ranked/scored.

# **Financial Obligations**

CHEER ITEMS NEEDED: \$175.00

The items needed, and included in this cost are uniform skirt, uniform top, uniform bow, boy cut briefs, and practice wear (including bow.) If you are a returning show team athlete, you will not need a new uniform unless yours doesn't fit. You can deduct \$100.00 from this.

**MUSIC AND CHOREOGRAPHY FEES:** \$100.00

This is customized music and choreography for each team.

**COMPETITION FEES: \$400.00** 

Competition fees cover the registration cost for each athlete to attend each competition. This does not cover admission for spectators but covers the athletes if they want to stay and watch friends of other teams.

PRACTICE ITEMS: Included in the "cheer items needed cost"

Each athlete will receive a practice shirt and practice shorts
