### **Sign-Up Information**

<u>Sign-Ups\*:</u> Try-outs are needed for Novice teams. This allows any beginner athletes to participate in the sport of cheerleading. While this level is introductory, it will give athletes and parents an idea of what competition cheerleading is all about. The age groups will range from 5 – 11 years old. The goal of Novice teams is for beginners to learn a 1:30 cheerleading routine by themselves and receive a high ranking. It is more affordable than elite and prep competitive cheer and great place to start for beginners interested in cheer.

**Practices**: Practices will either be on Tuesdays or Wednesdays at 4:45-5:45 and they will have a team tumbling practice on Saturday 10:00AM. Novice Team will start with their team practices on June 4th. In the tumbling practice they will learn how to tumble on count in a group atmosphere. Once they have mastered the back walkover the athlete will be able to move to a Level 1/2 tumbling class of their choice and forgo the team tumbling practice.

<u>PRACTICE & TUITION:</u> Novice Team will have two practices per week. Monthly tuition is \$135 (including tumbling.)

<u>UNIFORMS:</u> Uniform tops will be full length and the skirt will be an "A LINE" design. It will not be the same uniform as our full competitive squads but will be the same colors.

<u>COMPETITIONS:</u> Novice Teams will attend 6-8 competitions. (Increased Number) These competitions will not require an overnight hotel stay. Novice Teams will perform locally in the Houston/Galveston area. Novice teams compete for ranking; Superior, Excellent or Outstanding they do not compete for placements.
