- Councillor Graves reported that the weather has been too warm to pour concrete. If weather permits he will look into pouring the concrete Wednesday, August 18, 2021
- Mayor Banks reported that she has Buffalo Board that will be installed around the exterior of the storage shed by Ridge Runner Construction before pouring the concrete.
- Admin Assistant shared correspondence from Water Security Agency EPO, Rick Sheichuk, advising that we can
 do the interior patching ourselves under the direction of Tex Schirrschmidt as he is a certified operator. Rick
 Sheichuk also outlined the requirements for Precautionary Drinking Water Advisories, etc. surrounding the
 repair work.
- Councillor Spearman will look into sourcing the supplies for the interior patching.
- Council intends to move forward with the interior patching before winter, 2021.

Tenders for the Sale of 15 Patrick Street

- Admin Assistant advised that no tenders for the sale of 15 Patrick Street were received. By tendering the property the Town has fulfilled the requirements set out in the Provincial Mediation Board's order.
- The possibility of our Public Works Staff demolishing the building was discussed. The Town could then try to sell the property again, once it has been demolished and cleared of debris. The administrator is to look into the costs for large construction dumpsters and backhoe costs.
