REGISTRATION

Registration is open to the public.

Registration Deadlines

Students are responsible for adhering to the deadlines for registration, payment, withdrawal, and any changes to registration as published in the Reach Academy course catalog, on the Reach Healthcare website, and in any registration instructions provided.

Reschedules

Students may reschedule their start date up to two (2) business days before the class begins. A reschedule request may be granted one (1) time only.

Transfers

Students may transfer their registration to another individual if the transfer occurs at least seven (7) business days before the class start date.

Transfers must be applied to the original scheduled class date.

Requests for refunds or transfers made by the recipient of a transferred registration are not permitted.

Refunds

No refunds are issued after ten (10) business days from the date of registration. If you cancel after ten business days, your payment is non-refundable.

Reach Academy courses are designed to support the development of high performance non-clinical health professional workforce. Consistent attendance and meaningful participation are essential to achieving course competencies and meeting certification requirements.

Attendance Expectations

Students are expected to attend all scheduled class sessions in full, whether in person or online. Missing class may limit a student's ability to successfully complete required learning activities. Students who do not attend the required number of instructional hours will not receive a certificate of completion for the course. For courses connected to professional certification pathways, failure to meet the required hours may also result in ineligibility for the corresponding professional certification.

Punctuality

Students are expected to arrive on time and remain for the full duration of each session. Repeated tardiness or early departures may impact course completion or certification eligibility.

Participation Requirements

Active engagement is required in discussions, learning activities, breakout groups, and skills demonstrations. Participation demonstrates readiness for professional practice and contributes to a positive learning environment.

Missed Sessions

Make-up sessions are not available. Students who miss any portion of required instructional time will be required to retake the course in full. Retaking a course will require re-enrollment and repayment of course fees.

Technology Requirements for Online Courses

Students must ensure that they have a reliable internet connection, a working camera and microphone, and a quiet environment free from disruptions. Students are expected to remain visible and engaged during virtual instruction unless otherwise specified by the instructor.

ASSESSMENT AND COMPLETION REQUIREMENTS

Reach Academy courses are designed to ensure that students gain the knowledge, skills, and competencies necessary to serve effectively within the healthcare and clinical setting in the capacity of non-clinical healthcare health workers, including but not limited to birth workers and community workers. To receive a certificate of completion and to remain eligible for certification pathways, students must successfully meet all assessment and completion requirements outlined for each course.

Coursework and Assignments

Students are expected to complete all required coursework, assigned readings, exercises, and written or practical assignments by the deadlines established by the instructor. Assignments are designed to reinforce learning and support competency development.

Skills Demonstrations

Courses that involve practical or hands-on competency development may require students to demonstrate specific skills during live instruction. Successful demonstration of required skills is essential for course completion and certification eligibility.

Participation Expectations

Active participation in discussions, group work, learning activities, and skills practice is required. Participation demonstrates professional readiness and contributes to the overall learning experience.

Assessments

Some courses may include quizzes, knowledge checks, or final assessments to evaluate understanding of course material. Students must complete all assessments with a satisfactory score to receive a certificate of completion.

Foundations of Doula Practice

Course ID	Course Title	Description
RAF101	Intro to Childbirth Education (DONA Approved)	Gain a foundational understanding of the childbirth process, birth options, and communication strategies for effective client education. DONA International recognized training. <i>This course is taught by a DONA approved trainer and meets the Intro to Childbirth for Doulas requirement needed for DONA Birth Doula Certification. This course meets the Intro to Childbirth requirement needed to attend Reach Academy's Birth Doula Training course.</i>
RAF102	Birth Doula Training (DONA Approved)	A comprehensive training that prepares doulas to provide physical, emotional, educational and resource support before, during, and after childbirth. This course is taught by a DONA approved trainer and meets the DONA Approved Birth Doula Workshop requirement needed for DONA Birth Doula Certification. A DONA Approved Intro to Childbirth course must successfully completed prior to attending this course.
RAF103	Intro to Breastfeeding (DONA Approved)	Learn the basics of lactation support, positioning, and common troubleshooting techniques for early postpartum success. DONA International recognized training. This course is taught by a DONA approved trainer and meets the Lactation Support Education requirements needed for both DONA Birth Doula Certification and DONA Postpartum Doula Certification.
RAF104	How to Become DONA Certified	A 3-week guided accountability course to help participants complete and submit their DONA certification materials with support from mentors.
RAF105	How to Become Credentialed	A 2-week step-by-step course covering the process for doulas to obtain credentialing with major insurances

		entities including Medi-Cal, documentation requirements, and ongoing compliance.
RAF106	Adult and Pediatric CPR / BL Certification	Hands-on instruction in CPR techniques for adults, children, and infants, fulfilling professional certification standards.
RAF107	HIPAA Training for Doulas (Online)	A self-paced, online course with assessment. Health Insurance Portability and Accountability Act (HIPAA) is a federal regulation intended to protect personal privacy and secure personal health information by setting national standards for handling such data. This course meets annual HIPAA Compliance requirements.
RAF108	Using Technology for Client Management	Learn best practices for managing scheduling, documentation, and secure communication through digital platforms.
RAF109	Birth Experience Externship	This course fulfills the hands-on birth attendance requirements necessary for professional doula certification pathways, as well as DONA International Birth Doula Certification and insurance credentialing requirements. RAF109 may be taken three (3) times to meet birth attendance requirements for certification. Each enrollment of RAF109 must be completed separately and can be taken at the same time, with full participation and documentation for each birth experience. Birth experience must include prenatal, labor and birth, and postnatal support. Enrollment includes tracking, supervision, documentation, and supplies. This course is supervised by a DONA certified Doula and meets the Birth Experience requirement needed for DONA Birth Doula Certification. DONA Approved Intro to Childbirth course, DONA Approved Birth Doula Workshop, and DONA approved Lactation Support Education, and valid HIPAA Training courses must successfully be completed prior to attending this course.

RAA203	Working with Peanut Balls	Learn positioning and techniques for using peanut balls effectively to support labor progression and comfort.
RAA204	Doula Support of the Epidural Client	Techniques for positioning, advocacy, and emotional support for clients who receive epidurals.
RAA205	Supporting the Cesarean Birth	Understand how to support clients through planned or unplanned cesarean births, including preparation and recovery guidance.
RAA206	VBAC Support Strategies	Learn how to assist and empower clients planning a vaginal birth after cesarean, including safety and advocacy best practices.
