- 2. BOULDER CITY HORSEMEN'S ASSOCIATION shall have and is hereby granted a lien for any and all boarding and other charges resulting from the boarding of said horse.
- 3. If the horse becomes ill or is injured, Owner shall be notified at the above telephone number for instructions, and if the Owner cannot be informed or does not answer the notice or the health injuries requires immediate action, BOULDER CITY HORSEMEN'S ASSOCIATION, shall have the right to use its best judgment regarding measures to be taken for the welfare and health of the horse.
- 4. Any medical fees incurred shall be paid by Owner of horse and BOULDER CITY HORSEMEN'S ASSOCIATION shall have no liability therefor.
- 5. BOULDER CITY HORSEMEN'S ASSOCIATION, its agents or employees shall not be liable for any damage that may accrue from any cause or as a result of fire, theft, running away, state of health to person, horse or property.
- 6. To abide by all the rules and regulations of the association. No horse shall allowed to be moved from the association unless the bill is paid in full.
- 7. To provide current veterinarian certificate, coggins and brand inspection on all livestock prior to unloading.
- 8. To assume all responsibility and risk arising out of engaging or participating in equestrian activities at BOULDER CITY HORSEMEN'S ASSOCIATION, and to hold Executive Board, Membership and employee harmless from all damages or liability for any injury to person, horse, or property arising from any reason whatsoever.
- 9. To indemnify and hold BOULDER CITY HORSEMEN'S ASSOCIATION harmless against any claim for damages which may arise from any actions of Owner's horse(s), including transmission of disease to any other human being or animal. The Owner fully understands that BOULDER CITY HORSEMEN'S ASSOCIATION does not carry any insurance on any horse(s) not owned by it for boarding or for any other purposes, whether public liability, accidental injury, theft or equine mortality insurance, and that all risks connected with boarding or for any other reason for which the horse(s) in the possession of, and on the premises of BOULDER CITY HORSEMEN'S ASSOCIATION are to be borne by the Owner. BOULDER CITY HORSEMEN'S ASSOCIATION strongly recommends equine mortality insurance be obtained applicable to the subject horse(s) by Owner.
- 10. BOULDER CITY HORSEMEN'S ASSOCIATION shall not be responsible for the theft, loss, damage or disappearance of any tack or equipment or other property stored at BOULDER CITY HORSEMEN'S ASSOCIATION as same is stored at the Owner's risk.
- 11. BOULDER CITY HORSEMEN'S ASSOCIATION may exercise its lien rights and 10 days after written notice to Owner at the address above set out, may dispose of said horse for the unpaid charges arisen or public sale and Owner waive all other legal notice. In the event the sale does not receive a price sufficient to pay costs and charges, Owner shall be liable for the difference.
- 12. In the event someone other than Owner calls for the horse, such person shall have written authorization signed by Owner to obtain the horse.
