**Refunds & Class Changes**– Pre-entries will be refunded only upon written request received prior to closing of pre-entries. No refunds will be given for any entries received after pre-entry closing date; this includes emailed "day of show" entries. No class changes will be made once entries have closed.

**Returned Checks**: Any check returned to our bank will invalidate all entries associated with that check. In addition, the person writing the check will be reported to ASCA – No Exceptions. Delta ASF will add a \$35.00 Collection fee to the amount of each returned check. Anyone with a check returned must pay all future Delta ASF event fees in cash. NO Entry will be accepted by a dog, owner or handler disqualified from any ASCA Program or a person not in good standing with ASCA.

**Conformation** (all classes split by sex)

Non-Regular: Puppies – 2-4 mo, 4-6 mo, BOBP & Veteran 7-10, 10+, BOBV

Altered: 6-9, 9-12, 12-15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Intact: 6-9, 9-12, 12- 15, 15-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red

Ribbons: 1<sup>st</sup> through 4<sup>th</sup> place Rosettes: Best Jr., Reserve Jr., BOBP, BOSP, BOBV, BOSV Altered and Intact WD, RWD, WB, RWB, BOS, BOW, BOB

**Rally**: Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A **No bitches in season are allowed to participate. Rally is limited to the first 35 entries per trial, no entries will be accepted after 35 dogs.**

Ribbons 1<sup>st</sup> -4<sup>th</sup> place. Rosettes: High in Trial, High Scoring Junior in Trial, High Combined Score in Excellent B & Masters B, High Scoring Aussie, High Scoring Other Breed.

**Obedience:** Utility B/A, Open Dog Excellent B/A, Companion Dog Excellent B/A, Novice C/B/A, Optional Titling Beginner Novice B/A, Sub Novice – Novice Group Exercises will be held after Novice individual exercises. **Obedience is limited to the first 25 entries per trial. No entries will be accepted after 25 dogs. No bitches in season are allowed to participate.** Ribbons 1<sup>st</sup> -4<sup>th</sup> place. Rosettes: High in Trial, High Combined, High in Trial Junior, High Scoring Aussie, High Scoring Other Breed.

**Section 8:** All dogs six (6) months and older must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned obedience trials. Photocopies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned obedience trials.

**DIRECTIONS:**

Take Hwy 99 to Turlock. Exit Fulkerth, turn left (eastbound). The third stop light will be Golden State. Make a right on Golden State and then an immediate right on to North Front. Go approximately 2 blocks and make a right, cross the RR tracks, right on Broadway and enter through back gate.

**Grounds and General Information:**

- Show will be outdoors on grass.
- Grounds open at 7am and close at 10pm. For late or early arrival information contact the show coordinator listed above.
- No designated grooming area however we ask that you keep grooming at least 20 feet from ringside.
- Electricity is available at the rate of \$50 per day throughout the fairgrounds with preference given to overnight RV accommodation. Please notify the show coordinator prior to the show if you would like to reserve electricity.
- No dog may enter the show ring or be given an armband without a completed entry form and all show fees paid in full.
- Pre-entries with missing/inaccurate information or missing/inaccurate payment will not be added to the judges' books until all information and/or payment is received. Be sure to read your entry and the flyer carefully to avoid delay.
- All minors must be accompanied by a parent/guardian at all times while on the show grounds.
- Animals must have adequate shade and water and may not be left unattended while on the show grounds.

## **WEEKEND HIGH POINT AWARDS**

We are excited to offer high point awards for the following categories: Junior, Puppy, Veteran, Altered, Intact Class Animal, Intact Champion, Rally and Obedience. High point awards are to be presented at the conclusion of the Sunday shows/trials.

To qualify for a high point award:

Conformation dogs/juniors must be entered in all 5 shows and compete in at least 4 shows. A point (1) will be earned for each defeated dog/junior.

Rally dogs must be entered in both trials and must Q in every run entered. Your highest score in the AM and PM trials will be added to determine a winner. If entered in more than one class, only a single high score will be counted. In the event of a tie, lowest combined time for those two runs will break the tie.

Obedience dogs must be entered in both trials and must Q in every run entered. Your highest score in the AM and PM trials will be added to determine a winner. If entered in more than one class, only a single high score will be counted. In the event of a tie, lowest combined time for those two runs will break the tie.

\*\*High in Trial and High Combined points do not apply to high point\*\*



## **NEW FIRE CODE PARKING**


### **REQUIREMENTS**

No parking within 20 feet of buildings. All Day of Parking will be in the midway (see map). If you are parked in an RV Spot or plugged into power you will be required to pay the RV fee, this includes day of exhibitors.

We want to make sure we are able to come back here so please adhere to these new requirements.



## **RESERVED RV PARKING HIGHLY RECOMMENDED**



**Overnight Parking for RVs at show site:** Overnight RV parking will be available for **\$50 per day, TENT CAMPING AVAILABLE \$50 per day**. Showers are only available at the March/April show Pre-arrangement recommended. Some parking will have full hook-ups. Others will have electricity only. Dump station on site. No exit or entry 10 pm to 6 am. Overnight spaces **will be** assigned and should be reserved in advance. Un-reserved overnight parking may be available at check-in but not guaranteed.
