Refund of Pre-entries & Class Changes– Pre-entries will be refunded only upon written request received prior to close of pre-entries. No other entry refunds will be granted. No class changes will be made once entries have closed.

Returned Checks: Any check returned to our bank will invalidate all entries associated with that check. In addition, the person writing the check will be reported to ASCA – No Exceptions. Delta ASF will add a \$35.00 Collection fee to the amount of each returned check. Anyone with a check returned must pay all future Delta ASF event fees in cash.

NO Entry will be accepted from a dog, owner or handler disqualified from any ASCA Program or a person not in good standing with ASCA.

Obedience: Utility B/A, Open Dog Excellent B/A, Companion Dog Excellent B/A, Novice C/B/A, Optional Titling Beginner Novice B/A, Sub Novice – Novice Group Exercises will be held after Novice individual exercises. **Obedience is limited to the first 25 entries per show. No entries will be accepted after 25 dogs. No bitches in season are allowed to participate.**

Ribbons 1st -4th place. Rosettes: High in Trial, High Combined, High in Trial Junior, High Scoring Aussie, High Scoring Other Breed

Rally: Masters C/B/A, Excellent C/B/A, Advanced C/B/A, Novice C/B/A **No bitches in season are allowed to participate. Rally is limited to the first 35 entries per show, no entries will be accepted after 35 dogs.**

Ribbons 1st -4th place. Rosettes: High Scoring Junior in Trial, Hi Combined Score in Excellent B & Masters B.

Section 8: All dogs six (6) months and older must have an individual ASCA registration or LEP number or an ASCA tracking number to compete in ASCA sanctioned obedience trials. ...Photo copies or originals of registration or tracking number papers must be presented to the Registration Table upon request when entering ASCA sanctioned obedience trials.

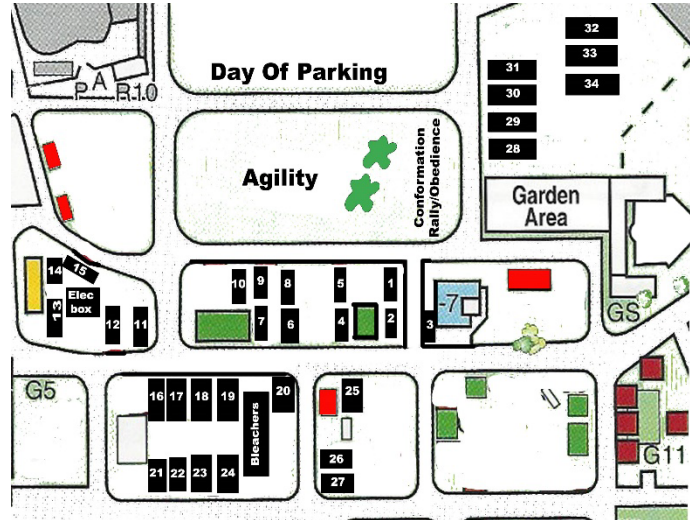

PLEASE BE AWARE OF THE NEW FIRE CODE PARKING REQUIREMENTS. DAY OF SHOW PARKING IS ON THE MAP BELOW. If you are parked in an RV spot you will need to pay for that spot. There is absolutely no parking near the barns. If you are parked by the barns the cost to you will be \$200.00 per day.

NEW FIRE CODE PARKING REQUIREMENTS

No parking within 20 feet of buildings. All Day of Parking will be in the midway (see map). If you are parked in an RV Spot or plugged into power you will be required to pay the RV fee, this includes day of exhibitors.

Overnight Parking for RVs at show site: Overnight RV parking will be available for **\$50 per night**, **TENT CAMPING AVAILABLE \$50 per night**. Pre-arrangement recommended. Some parking will have full hook-ups. Others will have electricity only. Dump station on site. No exit or entry 10 pm to 6 am. Overnight spaces may be assigned and should be reserved in advance. Un-reserved parking may be available at check in but not guaranteed
