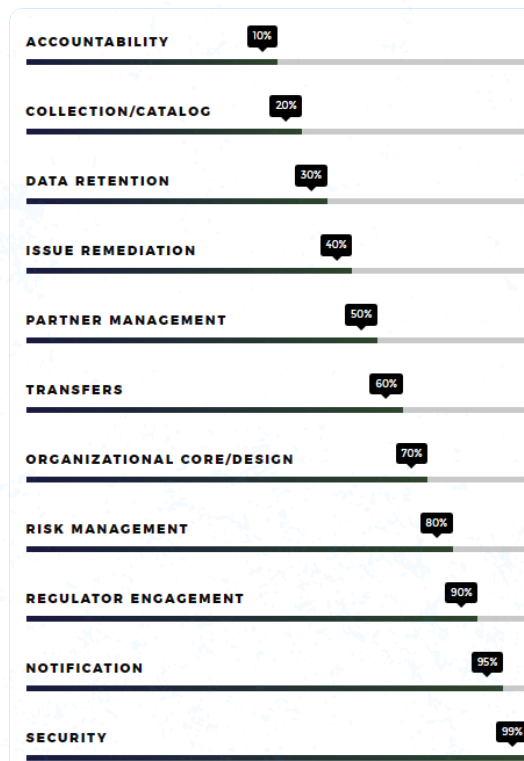

The CCPA provides California residents with certain rights regarding their personal information collected by businesses, including the right to know, delete, and opt-out of the sale of their data.
