APPLYING FOR TOWNSHIP ASSISTANCE - WHAT YOU NEED TO DO:

1. You may apply online or on paper.

Online application: <https://columbiatownship.net/township-assistance>

Paper application: Available for pick up in the mailbox at the Columbia Township fire station, 22 E Radio Rd, Columbia City, Indiana

2. Fill out this application - COMPLETELY. Be sure to include any children for which child support is being paid out and include the amount of time they spend in the household.

3. Gather all of the following:

- A. Photo ID for ALL adults in the household.
- B. Itemized bank statements for each adult member of the household.
- C. ALL of your utility bills.
- D. Your lease, rental agreement or mortgage payment voucher.
- E. Any court or medical records that pertain to your current circumstances.
- F. Proof of ALL HOUSEHOLD INCOME FOR THE LAST 30 DAYS. This will include:
 - I. Check stubs, direct deposits, unemployment benefit records.
 - II. SSI & SSD records.
 - III. Child support records.
 - IV. Proof of food stamps - you should have a letter from them stating amount and effective date.

(WE NEED TO SEE ALL OF YOUR FINANCES FOR THE LAST 30 DAYS.)

APPENDIX A - Income

For each additional family member, add \$5,140 annually and \$428 monthly. Figures based on 100% of 2023 Federal Income Guidelines published in the Federal Register: January 17, 2023.		

Income guidelines for determining township assistance eligibility shall be based upon no less than 100% of the Federal Poverty Level as outlined above.

Columbia Township will use 100% of the Federal Poverty level as its guide in determining eligibility.

COUNTABLE INCOME - This term means a monetary amount either paid to an applicant or a member of an applicant's household not more than thirty (30) days before the date of application for Township Assistance, or accrued and legally available for withdrawal by an applicant or a member of an applicant's household at the time of application or not more than thirty (30) days after the date of application for Township Assistance.
