You will be required to provide documents of vaccination protocol, additionally we can not stress enough the importance of weaning your bull calves at least 45 days prior to delivery to the feedlot. Calves properly vaccinated and timely weaned have a much greater probability of staying healthy during the test period.

All consignors will NEED to bring trailers to the sale! You are responsible for the transportation of your own no sale bulls and, if at all possible, assist with deliveries of sold bulls.

Any No Sales bulls not removed from the sales facility will be assessed a non removal fee paid to the WBA of 75.00 per bull in addition to a daily feed charge to be paid by you directly to bonina.

Consignors with bulls requiring treatment with medications while on the test will be informed and sent an outlying invoice to be paid directly to the WBA at the end of each applicable month.
