Hands On OT is committed to protecting the privacy and security of your personal information. This policy explains how we collect, use, and safeguard your information in accordance with HIPAA and applicable California privacy laws.

► Information We Collect

Personal Information

- Name, address, phone number, email
- Date of birth
- Insurance information
- Emergency contact details

Health Information (PHI)

- Medical history and referral information
- Evaluation findings and treatment notes
- Progress documentation
- Communications with your healthcare providers

Technical or Website Information

- IP address
- Browser or device information
- Basic usage analytics

► How We Use Your Information

- Occupational therapy/physical therapy evaluation and treatment
- Scheduling and appointment reminders
- Insurance verification, billing, and payment processing
- Coordination with your healthcare providers
- Quality improvement and internal operations
- Compliance with legal and regulatory requirements

Hands On OT does **not** sell personal information.

► SMS Text Messaging

► How We Share Your Information

We may share your information only as permitted by law:

- Insurance companies for billing and claims
- Referring or treating healthcare providers
- HIPAA-compliant business associates
- When required by law (e.g., public health reporting, court orders)

We do not share information for marketing without written authorization.

► Your Rights Under HIPAA

You may:

- Access your medical records
- Request corrections
- Request restrictions on certain uses or disclosures
- Request confidential communications
- Receive an accounting of disclosures
- Obtain a copy of this Privacy Policy

Requests must be submitted in writing.

► **Your Rights Under California Law**

California law may provide additional rights:

- To know what personal information we collect
- To request deletion of certain personal information
- To request that your information not be sold

Hands On OT does **not** sell personal information. HIPAA-protected medical information is generally exempt from CCPA, but we honor all applicable California privacy protections.

► **Data Security**

Hands On OT uses administrative, technical, and physical safeguards to protect your information. While we work to maintain secure systems, no method of transmission or storage is completely guaranteed.
