This Privacy Policy explains how *LLANSANTFFRAID POOL AND LLANSANTFFRAID DEUDDWR VILLAGE HALL* (“we”, “our”, “us”) collects, uses, and protects your personal data when you use our website llasantffraidvillagehall.com.

1. Who We Are

2. What Information We Collect

We may collect the following types of personal data when you use our website:

- Information you provide directly – e.g. when filling out contact forms, signing up for newsletters, or making donations. This may include your name, email address, postal address, and phone number.
- Technical information – e.g. your IP address, browser type, device information, and pages visited (collected automatically via cookies and analytics tools).
- Transaction information – if you make a payment or donation, we collect details necessary to process the transaction (handled securely via our payment provider).

3. How We Use Your Information

We use your information to:

- Provide and manage our services
- Process donations or payments
- Respond to enquiries or requests
- Send you updates or marketing (if you have consented)
- Improve our website and services
- Comply with legal obligations

4. Legal Basis for Processing

Under the UK GDPR, we process your personal data based on one or more of the following:

- Consent – when you have agreed to receive marketing emails
- Contract – when processing is necessary to provide services you have requested
- Legal obligation – to comply with legal requirements
- Legitimate interests – to improve our services and maintain security

5. Sharing Your Information

We will not sell or rent your personal data. We may share your data with:

- Service providers who help us operate our website and services (e.g. hosting, email, payment processing)
- Regulatory bodies or law enforcement, if required by law

All third parties are required to keep your data secure and use it only for the purposes we specify.

6. International Transfers

If your data is transferred outside the UK or EEA, we will ensure appropriate safeguards are in place, such as the UK International Data Transfer Agreement (IDTA) or EU Standard Contractual Clauses.

7. Data Retention

We keep your personal data only for as long as necessary for the purposes described in this policy, or as required by law.

8. Your Rights

Under data protection law, you have the right to:

- Access your personal data
- Correct inaccuracies in your data
- Request deletion of your data (“right to be forgotten”)
- Restrict or object to processing
- Withdraw consent at any time
- Data portability (receive a copy of your data in a machine-readable format)
