Reference is hereby made to the <u>Bylaws of Cascada Homeowners Association</u>, filed as Document No. 2006014425; and that <u>Amendment to Bylaws of Cascada Homeowners Association</u>, filed as Document No. 2020223482, both filed in the Official Public Records of Travis County, Texas (collectively, the "**Bylaws**").

Reference is further made to that certain <u>Declaration of Cascada Condominium</u>, filed as Document No. 2006014424, the <u>Amendment of Declaration of Cascada Homeowners Association</u>, filed as Document No. 2016092439, and the <u>Amendment of Declaration of Cascada Homeowners Association</u> filed as Document No. 2018010147, all in the Official Public Records of Travis County, Texas, (together with amendments and supplemental documents thereto, the "**Declaration**").

WHEREAS the owners of units subject to the Declaration are automatically made members of Cascada Homeowners Association (the "Association");

WHEREAS the Association is a Texas non-profit corporation and is governed in accordance with the Bylaws;

WHEREAS the members (the "Members") of the Association are authorized to amend the Bylaws pursuant to Article 13.1 of the Bylaws; and

WHEREAS the Members voted on June 27, 2019 to adopt the Bylaw amendments set forth below;

THEREFORE the Bylaws have been, and by these presents are, amended as follows:

1. By AMENDING Article II Section 2.1 to read in its entirety as follows:

"2.1 NUMBER AND TERM OF OFFICE. After the Declarant Control Period, the board will consist of three persons. Upon election, each director will serve a term of two years. A director takes office upon the adjournment of the meeting or balloting at which he is elected or appointed, and absent death, ineligibility, resignation, or removal, will hold office until his successor is elected or appointed. The number of directors may be changed by amendment of these Bylaws, but may not be less than three."
