#### SECOND AMENDMENT TO DECLARATION OF

#### **CASCADA HOMEOWNERS ASSOCIATION**

(Related to delegation of trash maintenance to the Association)

<u>Document reference.</u> Reference is hereby made to the <u>Declaration of Cascada Condominium</u>, filed as Document No. 2006014424 of the Official Public Records of Travis County, Texas, and as further amended by the <u>Amendment of Declaration of Cascada Homeowners Association</u>, filed as Document No. 2016092439 of the Official Public Records of Travis County, Texas (together with any other amendments and supplemental documents thereto, the "**Declaration**").

WHEREAS, the Declaration provides that persons owning units subject to the Declaration are mandatory members of the Cascada Homeowners Association (the "Association") and the Association may act on behalf of said members and for the community's benefit; and,

WHEREAS, the Association desires to unify the trash collection process for the community and to make such collection a part of the Association and Common Responsibility as outlined in Appendix E of the Declaration; and,

WHEREAS, the Declaration must be amended to effectuate this proposed change; and,

WHEREAS, Section 8.3.1 of the Declaration provides that it may be amended by either a majority of all units or by a two-thirds (2/3) vote of the units represented at a meeting of the Association called for the purpose of changing the Area of Common Responsibility; and,

WHEREAS, Section 82.067(a) of the Texas Property Code provides that a declaration may be amended only by a vote of sixty-seven percent (67%) of the total votes allocated to the unit owners entitled to vote on the amendment of the declaration, unless the declaration contains a larger percentage, in which event the percentage in the declaration controls; and,

WHEREAS, the Declaration provides for a lower percentage as set forth in Section 82.067(a) of the Texas Property Code; therefore, Section 82.067(a) controls with respect to the percentage of votes necessary to effect an amendment to the Declaration; and,

WHEREAS, at least a two-thirds (2/3) vote of all of the units in the community voted to approve this Amendment.

NOW THEREFORE, the Board of Directors of CASCADA HOMEOWNERS ASSOCIATION, as representatives of the members of the Association, do hereby attest that, in compliance with Section 8.3.1 of the Declaration, the below Second Amendment to the Declaration is made as follows:
