



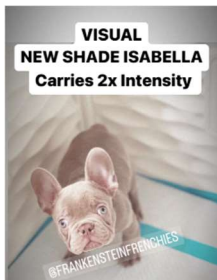

SAMPLE CONTRACT

Frankenstein Frenchies & FrankensteinFrenchies.com registered here as ("**Stud Owner**") and **CLIENTS NAME** hereafter ("**Female Owner**") hereby agree to the following terms and conditions regarding a breeding of the two dogs listed:

Stud is a New Shade Isabella French Bulldog Named: **FRANKENSTEIN FRENCHIES MAUI** as shown in photograph and on website link included:

The Female Owner has Agreed to pay the Stud Owner a total fee of \$1,000.00 USD which is non-refundable. The owner has Deposited \$0.00 USD to hold their place to use stud, deposit placed will be deducted from total stud fee. Remaining balance to be paid prior to breeding. Includes (2) Artificial Inseminations by the stud owner or their employees if the Females owner chooses to do so.

- Female owner will pay for collection and shipping expense if semen was chosen to be shipped by Next Day Air shipping.
- Female owner must notify stud owner of first signs of heat.
- Three days may not lapse of first signs of heat or swelling of vulva.
- Stud Owner requires (48hr) Notice prior to performing in person "live breeding"

***These requirements must be met in order to allow sufficient time for stud owner to make arrangements and preparations for the listed breeding as documented on this contract.**

SAMPLE CONTRACT

If a successful litter does not occur, the female will be bred during her next season, provided that the Stud Owner is notified within (7) days from inseminations due dates. If no litter is produced, Stud owner will provide a second attempt for the female owner to successfully produce a litter. In the event that the second breeding is unsuccessful the stud owner reserves the right to approve a third attempt based on a breeder-to-breeder basis. The Stud Owner and the Female Owner verify that their respective dogs are capable of breeding and do not suffer from any contagious conditions (including but not limited to parasites, rabies, DHL or Parvovirus) which may affect a viable litter to be produced. Female owner Agrees to Deposit amount shown in website listed at top of the document or has the option to Pay in Full total of \$1000.00 USD via PayPal friends and family, Walmart to Walmart, google wallet, zelle , or any of the payment options listed on our website checkout. **Any and all Payments and/or Deposits are (nonrefundable).**

- Female owner agrees to pay for the Telescopic Insemination or Surgical insemination if they choose or decide not to utilize the included (2) Artificial inseminations offered by Stud Owner. Stud owner will not do a repeat stud service if female has (2 or more) puppies. Two puppies will be considered a litter, if female only has (1) puppy the stud owner will do a repeat breeding to the same female on her next heat cycle.
- Female owner agrees to take pictures and live video of female in day 50-60 additionally pictures and live video of the litter the day litter is born and (2) weeks after for registration.
- Female owner will confirm pregnancy by vet via x-ray or ultrasound. If female owner does not have an x-ray or ultrasound done by day (55) of the breeding or comply with pictures and video to confirm pregnancy, they will lose the right to their rebreeding.

Stud owner will not register the litter until puppies are (3) weeks old and out of the "red zone" this is to ensure all puppies birthed remain healthy and alive, for some reason under the unfortunate circumstances any and or all pups were to end up not able to remain alive during this period of time resulting as being "deceased". In the event this were to occur the stud owner would not be liable nor would the stud owner be obligated to perform a second stud service if the litter was as mentioned in the above statement to be (2) or more pups birthed, also as stated if the female were to birth only (1) pup regardless of what situation were to arise the females owner would have the option to perform a repeat stud service within (12) calendar months utilizing the same stud listed on this contract.

If the female's owner chooses to ship the semen, once the semen is shipped it is no longer the stud owner's responsibility if semen is late due to FedEx shipping or damaged. If semen is damaged female owner will need to require written proof from their veterinarian. Female owner will pay for any cost associated with the reshipping of damaged semen. Stud owner will send new semen the following day or give female owner one stud credit to be used within one year for the same female. If MAUI is out of town or incapable of being collected for fresh chilled semen, female owner will receive frozen semen to make breeding possible if frozen semes is unavailable Females owner can opt to use another stud we do have available. This contract is non-transferable, In agreement to the terms of this contract, stud and female owner/owners affix their signatures below:
