Kelly presenting for Frank on zoom - WQ met in late March

watershed commission is reporting revitalization project is receiving 175k\$ to study a comprehensive plan for Silver Lake

Looking to hire consultant and will include representation from SLA to be on that group

Fits in with dredging project - two pronged effort underway a property lease agreement to dewater any sediment and a comprehensive dredging and plan including long term maintenance

plan to be complete mid year 2023

submit application early 2024 and hope to begin/complete project Fall 2024

\$500 to native plants to share within the community with message about importance of Native plant. A handout will be included with this year's directory. Tract directors can distribute with directories.

Japanese Knotweed spraying done. When Frank returns he is going to examine areas to determine effectiveness and spray company will return if necessary.

Club at Silver Lake has reached out to Wyo Co Soil and Water - they had large Japanese Knotweed infestation last year and did not want to partner with us. This has spread and now they want to address it and are attempting to work with soil and water.

Working with state to place a map at the boat launch and Perry park to show where the plantings have occurred all around the lake and to illustrate the Silver Lake watershed not just lake-side plantings.

Becca Campbell from watershed has identified three sights to be looked at in May and we will plan for plantings in fall of 23, 24, 25 in these locations
