- Homeowner of Distinction Award 5 min Leslie Kunze (Applications on table)
 - o turn sheets in to Leslie if you are nominating someone
- Water Quality 15 Minutes Frank Bright
 - o see attached WQ report
 - o no dredging update or lake-wide management plan. Funds are allocated by the state to create lakeside assessment plan to develop future plans for the lake. Will take several years to create this comprehensive plan. It dovetails with dredging. The dredging activities right now are primarily on procuring land for approximately three years as the land's sole purpose to deposit sediment onto the land from the Lake. May be spread if Class A (non hazardous) if Class B it would dewater on site and then remove.



- no longer a plan to expand the wetland area at North end materials to be hauled away
- o Club this year is now interested but ball is in their court but not helping as proposed last year
- o have created a new map of watershed to show where plantings have been done over the years
- o approval from boat launch (NYS) was instant. Village of Perry has taken over one year to approve planting project
- o Planting sites for next year on Silver Lake Road (2) and Suckerbrook
- o every tract to create a basket for the raffle and get them to Frank and Bonnie
- o CSLAP report is in early (usually takes until July)
 - important take away is over the 37 years we have been associated with CSLAP the overall lake health has improved
 - · chlorophyll level has gone down
 - · clarity has gone up
 - ammonia has gone up (somewhat problematic)
 - deep phosphorus has gone down over time (primary food source for everything green in the lake)
 - within the watershed every large farm has a large concrete manure bunker
 - have planted a few thousand plants the last several years which probably have some impact
- Perry HS is back on the lake after COVID
 - have added fish sampling to their studies
 - netted live fish and doing overall assessment of health of fish and looking specifically for microplastics
- o Silver Lake Sewer system continues to be a discussion
 - trying to work with Town of Castile and to go on tour of sewer plant
- o improper leaf and waste disposal
 - standing policy for Lake Erie to make it illegal to dispose of yard waste into lakes and waterways
 - leaf and debris pickup to be included in the next WM contract
 - requires support from municipalities which to date have not been helpful



- o fish kill was reported to be normal due to winter stress this year there was four freezes of the lake. There is usually only one. That is the reason it is so green right now. The lake turned over four times due to freeze/thaw and it should dissipate as time goes on this season.
- o plants are downstairs to be picked up take everything pick up everything that is present
- stocking a few years ago that was performed will not be repeated as they are naturally sustaining now
 - Silver Lake is #1 for Walleye now
- Web Site and Facebook Michelle Hess
 - o things are going well continue to send content and pictures
 - o met with Bob Murphy and got some old photos from SLI and history
- Old Business 5 minutes each
 - Waste Management
 - still looking for two sites for dumpsters
 - still struggling with them
 - Docking and Mooring Laws Approval
 - last month commercial 100' limit was passed. This is going to Don Roberts at the county to distribute to Perry and Castile for approval
- New Business 10 Minutes

- <u>Taxation Oversight Committee May 11th Meeting results</u>
 - o went to ToC with a presentation stating that the taxes are high for services that are provided
 - issues with leaf pick up, trash pick up, etc.
 - o 10% tax increase on top of 30% assessment increase
 - o asked for a 15% reduction in assessments now it is a wait and see
- Boater Safety Course June 3rd at the Marina, Offered by the Coast Guard, Start time 8:00 AM, arrival at 7:30 AM, Max 35 participants Money to Mary Gavigan by May 25th; SLA is subsidizing the cost to SLA

Tina Radus Town of Castile assessor since 2013 meet and greet:

- -wants to address some of the concerns and feedback to brainstorm ideas about issues that residents are having
 - -she has grievance forms available if you feel it is unfair or unequal
 - -grievance day is June 1st
 - -cannot do the reduction of 15% legally because it is past roll
 - -would be doing a 15% increase if we reduced the tax rate to offset
 - -do not control sales or market but we have to follow it
- -assessments following sales to remain fair and equitable these were determined to be fair across the board
- -school tax rate dropped but increases due to budget issues with fire departments and county hospital
 - -residential trends from NYS have been 8-10% per year (typical is 2-4%)
 - -restricted somewhat by NYS to follow their guidelines
 - -next reassessment will be in 2025 for ToC
- -every year information is available and roll is made public on county website which includes sales for reassessment with the price/sq ft
