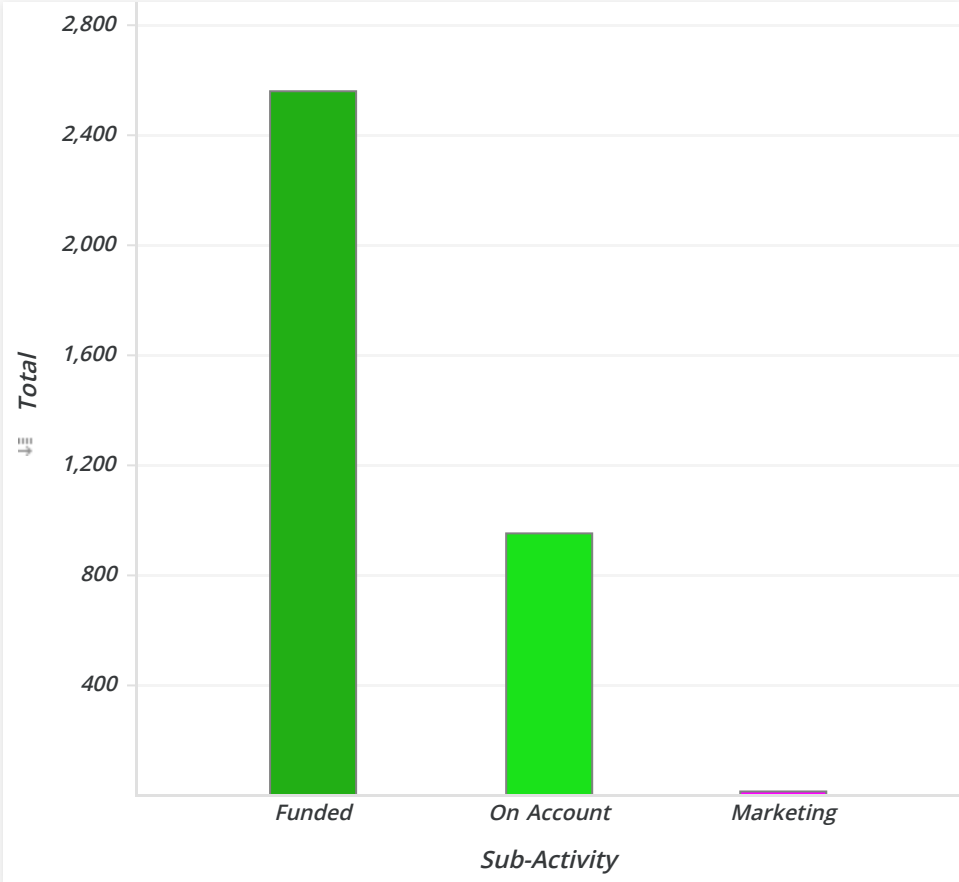
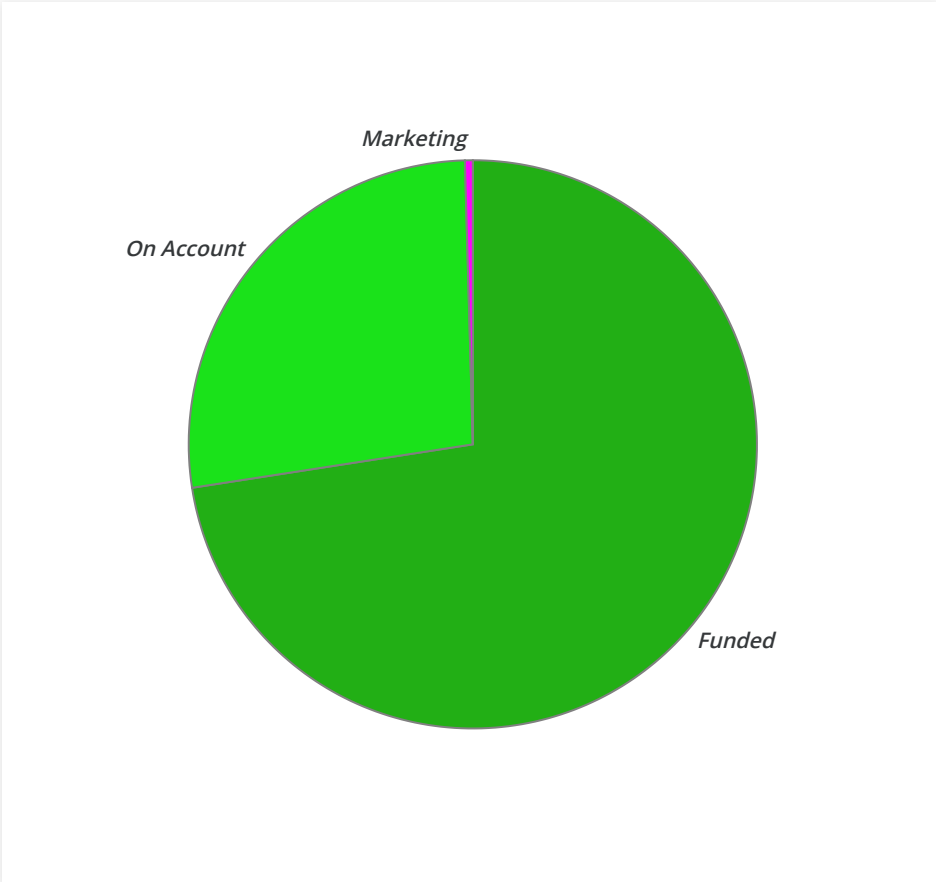
2023 (NET) - World Map - Country Distribution



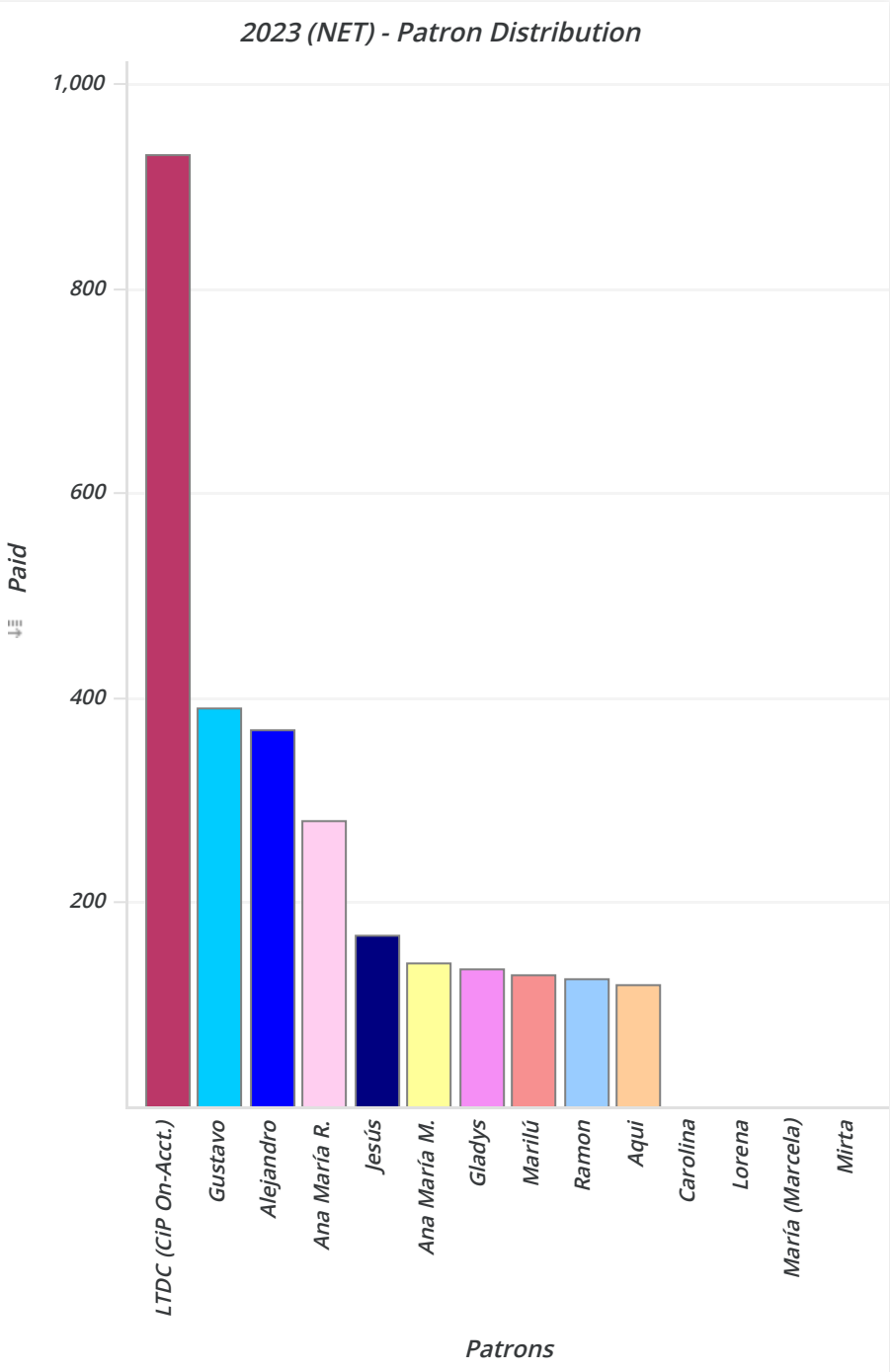
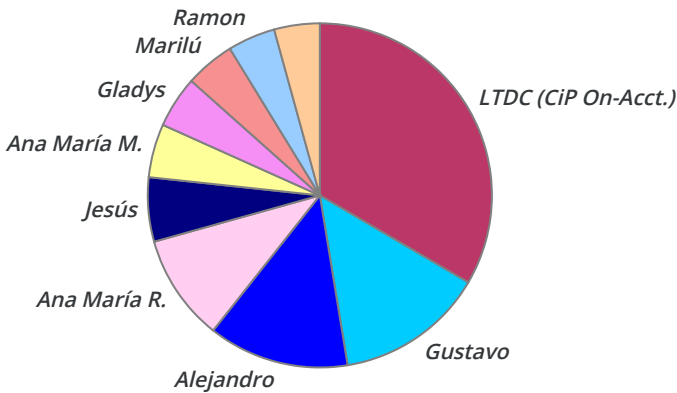
