LOK ADALAT, MARCH 2022

Indian Constitutional Aid Association started Project Rihaayi in Kishanganj, Bihar. The flagship project focuses on giving pro bono legal aid to minority communities imprisoned in the jails of Kishanganj and surrounding districts. ICAA is helping UTRC imprisoned for petty crimes get bail under the procedure established by law. The project will focus on minors, SCs, transgender, women, and other marginalized communities to release them from the jails with due consideration of the experts and practitioners in the field of law.

A Lok Adalat was held in the Kishanganj Court premises on the 12th of March, 2022 between 10am-5pm to aid in speedy disposal of cases and help the petitioners and the accused in the judicial process. Our team helped the accused in dispute resolution and aided in reaching a peaceful resolution

SUMMARY OF THE CASE

The nine accused allege that they have been falsely implicated in the case. They have been accused of cheating the petitioner by impersonation and inducing him to deliver some goods. Considering the false nature of this charge and the fact that the sections they are charged under are all bailable, the accused, therefore, pray for bail from the Court.

The accused are residents of Pothia district and to aid them in their application, our team of lawyers in Kishanganj assisted them in solving the dispute and reaching a peaceful settlement with the petitioners in the Lok Adalat.
