The flagship project focuses on giving pro bono legal aid to minority communities imprisoned in the jails of Kishanganj and surrounding districts. ICAA is helping UTRC imprisoned for petty crimes get bail under the procedure established by law. The project will focus on minors, SCs, transgender, women, and other marginalized communities to release them from the jails with due consideration of the experts and practitioners in the field of law.

SUMMARY OF THE CASE

The accused are all residents of Andabari village and this is their first appearance after the submission of the charge sheet. They have been accused of trespassing and causing hurt along with wrongfully restraining the petitioner. They allege that all of them have been wrongly accused and implicated in a false case as the petitioner has filed the case due to personal grudges against the accused. Considering that the complaint is false and the sections they are charged under are allailable, the accused, therefore, pray for bail from the Court.

In order to aid the accused in their case, our team of lawyers in Kishanganj assisted them in resolving the dispute and in filing the case material before the Court. Bail was granted to all accused on 01.07.2022
