PROJECT RIHAAYI

Indian Constitutional Aid Association started Project Rihaayi in Kishanganj, Bihar. The flagship project focuses on giving pro bono legal aid to minority communities imprisoned in the jails of Kishanganj and surrounding districts. ICAA is helping UTRC imprisoned for petty crimes get bail under the procedure established by law. The project will focus on minors, SCs, transgender, women, and other marginalized communities to release them from the jails with due consideration of the experts and practitioners in the field of law.

SUMMARY OF THE CASE

The accused is a pardashin lady, residing in Patila Bhasa, district Thakurganj. She alleges that she is innocent and has been falsely accused in a case due to personal grudges. Furthermore, she alleges that the case filed is false and malicious and no case is even made out u/S 307 as the victim shows no signs of grievous hurt.

Taking into consideration that the complaint is false and Sections 341, 323, 324, 307, and 34 of the IPC are all bailable, the accused therefore pray for bail from the Court.

In order to aid the accused in their case, our team of lawyers in Kishanganj assisted them in resolving the dispute and in filing the case material before the Court. Bail was granted to all accused on 14.06.2022. She is the first woman accused to be released under Project Rihaayi and reaffirms our commitment to aid underprivileged sections in Kishanganj get legal aid and justice.
