## Public Use Rates

**½ Day (5 Hours):** \$25 per rider

**Full Day (6am–10pm):** \$50 per rider

**Yearly Single:** \$250

**Yearly Family:** \$350 (Immediate Family Only)

(MAX 5 people. CLRA reserves the right to adjust public-use pricing or offer discounted or promotional rates at its discretion. **ARENA ONLY! This does not include pens, chutes, lights and water. If needed, please contact us.**)

## Public Use Rules and Policies

1. **Payment:** All public-use fees must be paid prior to arena use. Checks and cash are acceptable. If using card, ask for the Zeffy link to pay.
2. **Arena Access:** Public riding access may be administered by an authorized third party on behalf of CLRA. Such administration does not transfer ownership, control, or liability of the facilities.
3. **Arena Conditions and Closures:**  
CLRA reserves the right to close the arena at any time for maintenance, repairs, safety concerns, weather conditions, or other operational needs. In the event of rain or wet conditions that render the arena unsafe or unusable, riding in the arena is strictly prohibited until CLRA determines conditions are acceptable. Any rider who violates this rule will no longer be allowed to ride or use the arena.
4. **Lighting:** Lighting is available at \$25 per hour if approved and scheduled in advance.
5. **Conduct and Safety:** Riders are responsible for their own safety and the safety of others. Reckless, unsafe, or abusive behavior will result in immediate removal and loss of riding privileges.
6. **Dogs:** Dogs must be on a leash at all times.
7. **Fire:** Campfires or fireworks are NOT permitted.
8. **Litter Control:** Riders must clean up after use. Trash must be placed in trash cans. A \$50 cleaning fee will be charged if the arena is not left in clean condition.
9. **Security Cameras:** Security cameras are in use on the arena premises. Use of the arena constitutes acknowledgment and acceptance of video monitoring.

**Minor Riders:** Any rider under the age of eighteen (18) must have a parent or legal guardian present at the arena at all times. No minor may be left at the arena unsupervised. Failure to comply with this policy may result in immediate removal from the facility and loss of riding privileges
